

The informant later denied buying drugs at Johnston's home and said police told him to lie about the incident, Police Chief Richard Pennington said. Pennington said the informant is in protective custody and is a key part of the FBI-led investigation into the shootout.

In the New York case, Bell and his friends were leaving his bachelor party on Nov. 25 when a group of undercover police fired 50 shots at their car. Police have said that Bell's vehicle hit one officer and an unmarked police car, and that officers apparently thought a companions of Bell's was about to get a gun.



U.S. Jails Millions

Millions more on probation, parole

(AP) -- A record seven million people — or one in every 32 American adults - were behind bars, on probation or on parole by the end of last year, according to the Justice Department. Of those, 2.2 million were in prison or jail, an increase of 2.7 percent over the previous year.

Men still far outnumber women in prisons and jails, but the female population is growing faster. Over the past year, the female population in state or federal prison increased 2.6 percent while the number of male inmates rose 1.9 percent. By year's end, 7 percent of all inmates were women. The gender figures do not include inmates in local jails. "Today's figures fail to cap-

ture incarceration's impact on the thousands of children left behind by mothers in prison," Marc Mauer, the executive director of the Sentencing Project, a Washington-based group supporting criminal justice reform, said in a statement. "Misguided policies that create harsher sentences for nonviolent drug offenses are disproportionately responsible for the increasing rates of women in prisons and jails.

From 1995 to 2003, inmates in federal prison for drug offenses have accounted for 49 percent of total prison population growth.

Racial disparities among prisoners persist. In the 25-29 age group, 8.1 percent of black men are incarcerated, compared with 2.6 percent of Hispanic men and 1.1 percent of white men. And the numbers are similar for female mi-
