the building.

During the celebration luncheon inside, many spoke to how all of those involved in the renovation persevered in the face of a difficult and unusual project.

"It wasn't an easy thing to do," said Isaac Dixon, president of the Urban League of Portland board of directors, "but the building is absolutely beautiful, and the artistic touches on the outside are absolutely stellar."

Not seeing the project as finished, the group wanted to see further improvements on the parking lot and sidewalk. There was also a call for a new tenant involved in advocacy work now that Albina Head Start was moving out of the building.

"It's a great central location, so if we could get some additional services to the community from that space, that would be great," said Fitzpatrick.


