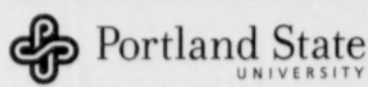

Proposals are requested from qualified professional teams for the provision of design services for the programming, site feasibility, design and construction of the Resource Access Center. The Housing Authority of Portland (HAP) will accept Proposals until **2:00 PM, Friday, November 16, 2007** at HAP's Purchasing Department located at 135 SW Ash Street, 5th Floor, Portland, Oregon 97204. Proposals should be clearly marked with the respondent's name and address and the RFP title and number.

The Housing Authority of Portland, at the request of the City of Portland and with the participation of Transition Projects, Inc., the Portland Development Commission and the Bureau of Housing and Community Development, proposes to develop a significant new building in Old Town/China Town as part of the City of Portland's 10-Year Plan to End Homelessness. Three sites near the Steel Bridge bridgehead are currently being considered. In Phase 1 of the work solicited through this proposal, the design team will work collaboratively with the above organizations to develop an architectural program and select the most appropriate site for the Resource Access Center. In Phase 2, the design team will provide full design services and construction administration services for the Resource Access Center.

A pre-proposal conference for prime consultants or their representatives will be held on Thursday, **October 25, 2007 at 10:30 AM at the Portland Development Commission Office at 222 NW 5th Avenue, Portland, Oregon 97209** in the Commission Conference Room. Immediately following this conference, consultants will have the opportunity to visit each of the three sites currently under consideration.

HAP has established a goal of 20% participation by disadvantaged, minority-owned, woman-owned and emerging small businesses on this project and encourages proposals from interested D/M/W/ESB firms. Disadvantaged, minority-owned, woman-owned and emerging small businesses with an interest in this project are also encouraged to attend the pre-proposal conference.
