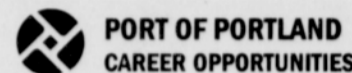

Notice is hereby given that the City of Vancouver, Washington, will receive sealed bids up to the hour of 11:00 a.m., Pacific Local Time, Tuesday, November 13th, 2007, and publicly opened and read aloud at that time on the same day in the Procurement Services Conference Room, 610 Esther Street, 2nd Floor, Vancouver, Washington, for the following:

Haagen Community Park includes the development of a 500 s.f. masonry restroom, playground complete with play equipment, curbing, safety surfacing. Site work which includes the following: clearing, grubbing, minor grading, storm water facilities, concrete and asphalt surfaces, curbing; utilities including water, sewer, grinder pump system and electrical; irrigation, landscaping and turf seeding.
