This contract provides for the reconstruction of the roadway, including new curb, sidewalk, and drainage facilities on E 32nd Avenue between E McLoughlin Blvd and E 13th Street, and on E 11th Street between E 13th Street and McLoughlin Blvd, including all associated work for all portions of this project in accordance with the attached Contract Plans, these Contract Provisions, and the Standard Specifications.

This project is financed through the Community Development Block Grant Program (CDBG) with funds obtained from the U.S. Department of Housing and Urban Development (HUD). The contract will be subject to regulations of the Departments of Labor and Housing and Urban Development. Attention is called to Federal provisions for Equal Employment Opportunity, HUD Section 3 requirements, and the minimum wages as set forth in the contract documents. The higher wage rate between the Federal and State rates, at minimum, shall prevail per WAC 296-127-025.


