Food Tokens Boost Buying Power

For low income at King Farmers Market

The Northeast Coalition of Neighborhoods, with the support of the Portland Farmers Market, has launched an incentive program to improve the access of low-income residents to the new King Farmers Market.

The Sunday market opened last May at King School Park through a partnership with NECN, an umbrella organization for 12 neighborhood associations and more than 30,000 households located in inner north and northeast Portland.

The market is open 10 a.m. to 2 p.m. Sundays through Sept. 27, near the intersection of Northeast Seventh Avenue and Wygant Street. More than 4,000 people - twice as many as expected - visited on its opening day and market attendance continues to surpass expectations.

The new Foodshare Fund Northeast incentive program will enable low-income residents of north and northeast Portland, who receive benefits through Oregon's Food Stamp Program, to make their dollars stretch with special tokens paid for by donations from local residents and businesses.



In the future, organizers will look for additional ways to support the program and possibly raise or eliminate the \$5 limit on the match.

The foodshare tokens have the same limitations as the electronic food stamps. Both may only be used for fruits, vegetables, meats, fish poultry, dairy products and seeds and plants intended for growing food. They cannot be used for non-food items, ready-to-eat foods, and hot foods.
