At that time, the bids will be opened and publicly read aloud in the MERC Conference Room. Formal bids may not be submitted by facsimile (fax) transmittal.

This RFB is to secure written bids for commissioning authority (CxA) services, consisting of retro-commissioning the facility to systematically optimize the building and ancillary systems so that they are calibrated and operating as required to deliver functional and efficient performance. This commissioning effort is also intended to satisfy the re-commissioning required by the USGBC LEED rating system for existing buildings. Additionally Contractor is to provide facility staff with associated system documentation and training. Contracted work contemplated is to be phased over a 5 year period

Work will be in accordance with the construction documents and technical specifications contained in the Request for Bids. The location of the work will be at the Oregon Convention Center, in various mechanical rooms throughout.
