a schizophrenic man who died while in police custody, the Portland Police Bureau has had all patrol officers go through 40 hours of crisis of law enforcement," he said. intervention training, which prepares officers to better respond to situations where someone is experiencing a mental health episode.

Police have steadily become the first responders to people experiencing mental health episodes as social and mental health services have struggled to keep up with increased demand for them.

Campbell's brother Timothy Douglass, 23, died that day after fighting a long struggle with a heart condition. Although the details of surrounding Campbell's situation aren't entirely clear, he was, by all accounts, extremely distraught by his brother's passing, and was reportedly suicidal and acting erratically.

It's a crap shoot if you're going to have an officer who understands mental illness," said Chris Bouneff, executive director of Oregon chapter of the National Alliance on Men-cated. tal Illness.

Bouneff said that it's hard to speak to this particular incident because there is so much unknown about Campbell's exact circumstances. But he said law enforcement officers are not the ideal first responders to people in crisis because they operate on a "command and control" approach that often escalates these situations.

made a difference. It's just a matter of better integrating agencies better equipped to deal with people in crisis, according to Bouneff.

Jason Renaud, the founder of the Mental Health Association of Portland and former candidate for City Council, said that the police bureau began training officers primarily so they'd have cover from legal liability in cases like the Chasse incident.

He said that the county's services have been strained from the Still, Bouneff believes that the soggy economy, but he asserted mental health crisis training has that his department has been able to Saltzman.

maintain its programs reasonably well.

"Are we bad off? Absolutely not," he guipped.

The county funds a Mobile Crisis Outreach Team that helps defuse people experiencing a mental health episode and services 2,600 annually. The police have a direct line to it, and can use it for situations where someone is having a break-

The computer assisted dispatch the police released after the incident reveals that officers knew that Campbell's brother had died that day, was extremely distraught, and suicidal. With it being clear that the man was so psychically rattled why didn't they draw on the resources of other services?

Sgt. Greg Stewart, Police Bureau spokesperson, said that Campbell had a history of violent and criminal behavior. While there was a report about a gun in his possession, police found no weapon on or near his body. They later found a handgun stashed in a closet near the front door of the apartment he had been in earlier.

"I don't buy that," said Bouneff of the bureau's rationale for not calling in help.

After the incident television stations were able to interview people who witnessed the entire event. If police were so worried about the security of another agency, they Dave Austin, the spokesperson would have cleared out the entire block leaving no one to witness it, argued Bouneff.

The incident is currently under investigation, and grand jury proceedings have been opened. Calls for making the proceedings public have gotten louder, and are being joined by Police Commissioner Dan
