## Corrections Counselor Multnomah County

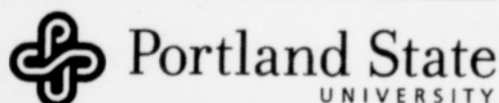

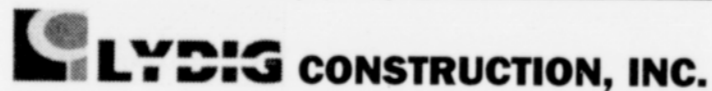

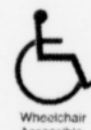
