Fernwood Teacher Builds Skills

Tom Streckert, an American history and government teacher at Beverly Cleary at Fernwood School in northeast Portland, was one of only 30 educators from across the nation selected to attend this week C-SPAN Classroom's 2010 Educators' Conference held in Washington, D.C.

The conference brings together middle and high school educators who specialize in social studies and using C-SPAN in their classrooms. Tom Streckert competed against

"Our goal for the conference is that after an agenda-packed two days, teachers will return to their communities armed with solid teaching tips, tools and strategies for engaging their students in a better understanding of how government works, as well as how to become informed citizens," says Joanne Wheeler, C-SPAN Vice President of Education.

National Oral History Project

Later this summer, Storycorp, a national project that seeks to celebrate the lives of ordinary people by recording their stories, will be visiting Multnomah County Library, and is currently seeking people to share their histories, especially stories about the intersection of library and

community. The stories will be archived in the American Folklife Center at the Library of Congress, and a couple will be broadcast on NPR.

However, because of limited time and resources, Storycorp can only record 18 stories during a three day period beginning August 12. Individuals or pairs interested in participating in the project can submit their story for consid-

eration by calling 503-988-5402.

Storycorp is looking for stories about meaningful experiences between families and friends. A key part of the experience is being interviewed by someone close to you, and being able to ask questions you might not have ever asked.
