Nuclear Severity Grows

Japan ranked its nuclear crisis at the highest possible severity on an international scale — the same level as the 1986 Chernobyl disaster even as it insisted Tuesday that radiation leaks are declining at its tsunami-crippled nuclear plant. The higher rating is an open acknowledgement that the nuclear accident at the Fukushima Dai-ichi plant is the second-worst in history.
