The City will retain on file all statements of qualifications for consultant selection on specific projects. The final selection will be by the recommendation of the Public Works Director to the City Council on each of the respective projects.

The areas of work included on the roster are asphalt paving, building construction, concrete curbs and flatwork, earthwork and excavation, electrical, erosion control, extruded curb, fencing, fire sprinklers, hazardous material abatement, HVAC, landscape and irrigation, mechanical, plumbing, reservoir cleaning, septic tank pumping, sewer cleaning and video inspection, underground utilities, well drilling, wetland mitigation, and other (areas of work not listed on the qualifications form). All contractors are required to provide a copy of their contractor's license, certification of liability insurance, and statement of bonding capacity.
