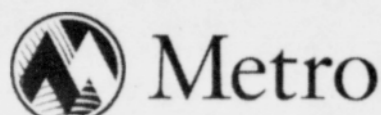

Robert Steen Jr.

Robert Steen Jr. was born June 18, 1945, in Portland, at Wilcox Memorial Hospital, now Legacy Good Samaritan Hospital. His parents are the late Ruthye Tru Tuggle and Robert Steen Sr.

Bob attended Immaculate Heart Grade School, North Catholic High School and Portland State University where he graduated in 1968. In 1967, he married Sharon (Leggroan) and to their union, a daughter, Lorraine Tru Steen was born.

While in college, Bob worked as a Porter for the Union Pacific Railroad. After graduation, he worked for IT&T, a contractor for the Hanford Nuclear site in Richland, Wash. After moving back to Portland, Bob worked for Western Kraft Paper Company and then was employed by

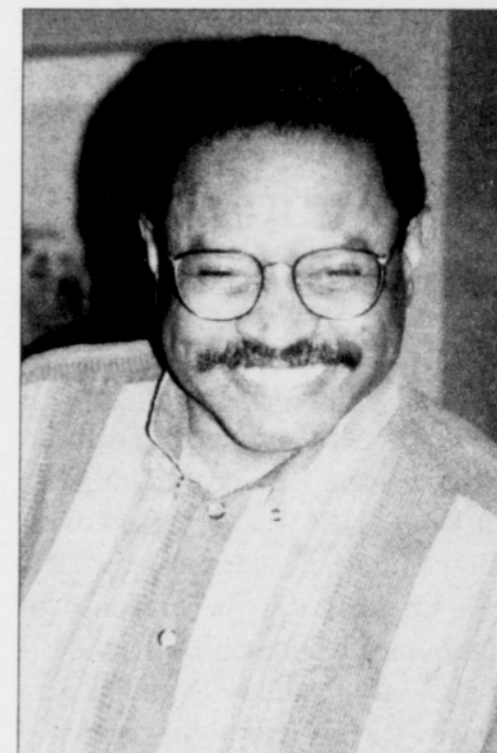
Multnomah County in personnel and at the Donald E. Long Juvenile Center.

In 1978, Bob took a position with the Bureau of Labor and Industries as executive assistant to State Labor Commissioner Mary Wendy Roberts, making him Oregon's first registered black lobbyist.

He later worked for Blue Cross/Blue Shield, the City of Portland in the Planning Bureau, the Office of Affirmative Action and as a Human Resources Analyst for the city's Bureau of Personnel.

Bob was very active in his church, Augustana Lutheran, teaching Sunday School, a member of the Church Council and as past president of the African American Lutheran Association.

He is survived by his daughter, Lorraine Tru Steen, his former wife, Sharon Steen, his best friend and



brother, Ron Steen, his granddaughter, Bobbie Elaine Steen, and partner of 25 years, Glenn Ludtke. He is also survived by an adopted son, numerous family and friends.

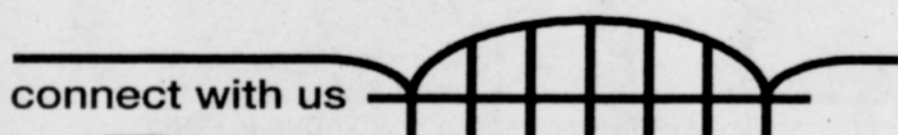
