Politics is a difficult road for many people to navigate. A young Portland man has started Politcrowd.com as a way to bridge that gap.

Paul Locker, 22, says he got the idea for such a platform after realizing that many of his friends and peers were not engaged in politics and had no desire to do so for an array of reasons, one of them being a perceived inability to interact with elected officials.



"The goal here is we want people to basically empower themselves to get in contact with their politicians in a way that's power through numbers rather than power through money or connections," says Locker.

The recent University of San Diego graduate says his passion for politics and non-partisan beliefs were instilled during his formative years.

He and his small staff are putting in long hours without pay making phone calls to the state capital and shaking the hands of taxpaying citizens they hope will become active users of the website.

Attorney General Eric Holder, speaking recently at the National Urban League Conference, found the ruling "disappointing and

deeply flawed" but stressed that the decision is not a defeat, but "a historic opportunity" to strengthen civil rights law.

Demonstrators will seize this opportunity to organize in support of stronger protections under the law. Other events, including the recent verdict in the trial of George Zimmerman, highlight a failure on the part of our legal system to address systematic injustices and unequal protections under the law.

In Portland, where unemployment for African Americans is often double the rate of the majority popurights, including the U.S. Supreme lation, and where a 2012 federal inquiry found that Police Bureau engaged in a pattern or practice of excessive force, the issues that compelled the 1963 March of Washington for Jobs and Freedom, including lack economic opportunity and police brutality, are still the pressing issues of today.
