PEARSON FIELD AIRPORT FOG SEAL PROJECT

Notice is hereby given that the City of Vancouver, Washington, will receive sealed bids up to the hour of 11:00 A.M., Pacific Local Time, **Thursday, August 22, 2013**, and publicly opened and read aloud at that time on the same day in the Vancouver City Hall, 415 W 6th St, Vancouver, Washington, for the following:

The Pearson Field Airport Fog Seal project consist of, but is not limited to, crack repair and sealing of Runway 8-26, taxiways, aprons, ramps and t-hanger taxi lanes; crack repair and sealing of the t-hanger aprons; fog seal of Runway 8-26, taxiways, aprons, ramps and t-hanger taxi lanes; replacement of existing markings; replacement of fifteen guidance sign panels; and replacement of existing wind cone per the plans and specifications.

An optional pre-bid conference will be held on Wednesday, August 14, 2013 at 10:00 am in the Aero Maintenance Lobby located at 1115 East 5th Street, Vancouver WA. Contractors are strongly encouraged to attend.
