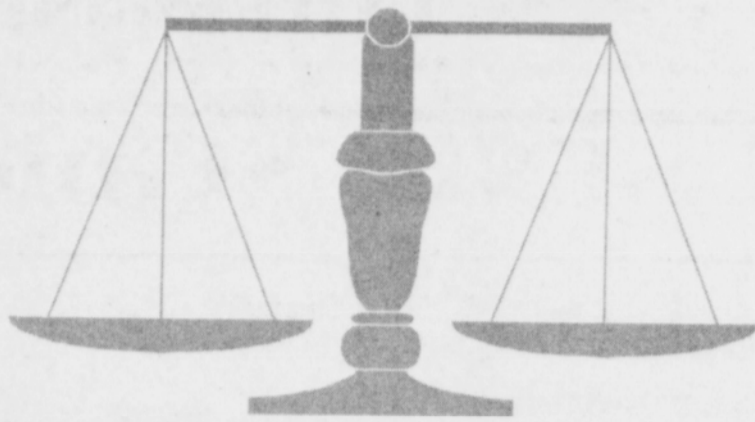

**The Portland City Auditor's Independent Police Review (IPR) division** is responsible for the civilian oversight of the Portland Police Bureau.

The City Auditor is recruiting volunteers to serve on the **Police Review Board (PRB)**, which is an advisory body to the Chief of Police.

The PRB makes recommendations to the Chief regarding findings and discipline and may make recommendations regarding adequacy and completeness of an investigation. The PRB may also make police or training recommendations to the Chief.

PRB members are appointed by Portland City Council to serve three-year terms.

Candidates must be Portland, Oregon, residents or business owners, and be impartial and objective without bias regarding law enforcement.
