Other key points from the 2013 report: Black residents of Portland have the lowest homeownership rate of all groups, including other minority groups; the black community has experienced the greatest number of opment. housing foreclosures; black residents pay the highest percent of Renewal Area encompasses 3,390 household income on housing; the experience of African-Americans in Portland has been marked by several cycles of displacement; and the median net worth for black households in 2011 was \$6,446, which was lower than it was in 1984 at \$7,150.

In a statement to the Portland Observer, Portland Housing Bureau director Traci Manning who works directly with the PDC acknowledged gentrification as a "result of government actions [that have] occurred for decades in inner northeast Portland and the Interstate Corridor."

"Most of that can't be changed." she says.

Despite this sentiment, Manning remains hopeful that proposals like the mayor's will allow for the kind of economic activity that will allow current families to stay in the area, and allow others to return.
