## For Summer Street: Mill Creek Bridge No. 470218 (Salem)

The Purchasing Administrator of the City of Salem will receive sealed bids at the Contracts & Procurement Division, 555 Liberty Street SE, Room 330, City Hall, Salem, Oregon 97301, between the hours of 8 a.m.-12 p.m. and 1 p.m.- 5 p.m., but not after 2:30 p.m., (Local Time) Tuesday, June 17, 2014, at which time said bids will be publicly opened and read in the Public Works Conference Room 325, City Hall, for the project specified herein.

CLASS OF WORK: REIN - Bridges and Structures.

**WORK TO BE DONE:** The proposed work generally consists of channel excavation of the existing creek streambed material and installation of Class 700 riprap. Select streambed material will then be installed over the riprap. More specifically the project includes approximately 670 cubic yards of channel excavation, installation of 420 cubic yards of Class 700 riprap, concrete repairs, and site restoration and cleanup.


