



This contract provides for the improvement of the portion of NW 18th Avenue from SE 201st Street easterly to NW Beech Street, a distance of approximately 0.33 miles. The project will integrate a safe path into the E-Verify, is an Internet based system operated by the existing environment to be used by commuters, students, and local neighborhood residences. The project includes a 10-foot wide porous asphalt bicycle/ pedestrian path, ADA compliant ramp, landscaping and improved drainage features.
