Vancouver Motel Fined

The Washington Department of Labor and Industries has imposed a \$112,450 fine on a Vancouver Motel 6 for repeatedly exposing workers to hypodermic needles while they cleaned rooms. The workers were also never given required training on the use of harsh chemical cleaners they were required to use.

Nod to \$15 Minimum Wage

Portland Mayor Charlie Hales used his third annual "State of the City" address Friday to support a city \$15 minimum wage for city workers. Hales also proposed tax credits for companies that hire people with criminal records.

Gang Shooting at Boss Hawg's


