A Portland-based non-profit will provide emergency shelter services for up to 13 homeless Veterans and seven companion animals starting on Veterans' Day.

Do Good Multnomah, in partnership with several community organizations, has developed a model that creates synergy between neighborhood groups, faith communities, and the business sector to address Portland's homelessness crisis in an immediate and focused way.

Shelter staff will help the veterans navigate through the available housing and employment resources offered by other service providers. The assistance or emergency shelter shelter will be free of charge.

Church members will coordinate volunteer efforts, but religious belief or church affiliation is not a requirement to participate. In addition to the support received from the city of Portland and Multnomah County, initial funding for the shelter's Veterans' Day launch was provided by US Bank.

"This kind of shelter depends on the support and good will of many people," said UCC Senior Minister, Michael Ellick. "Each of us has different gifts to bring to the table. We are honored to work with Do Good Multnomah and to open our building to our neighbors who sleep outside."
