Deadline for voter registration Tuesday, Oct. 13

With less than a month to go before the Nov. 3 General Election, a vote-by-mail ballot that will have a huge impact on the future of Portland, Multnomah County and the nation, potential voters are urged to make a plan to cast their vote and get it returned before the deadline.

Multnomah County Auditor Jennifer McGuirk released a new high school on the Jefferstatement encouraging voters to make a plan to vote.

Everyone has a right to vote if they are a citizen of the United States, are at least 18 years old, and are registered to vote. The deadline to register in Oregon for the election is Tuesday, Oct. 13. The ballots will begin to be mailed out to potential voters the next day on Oct. 14, officials said.

In order to be counted, all ballots in Oregon must be returned and received by county elections officials by the 8 p.m. deadline
