This Document is a legal notice informing all Applicants of MWH-Kiewit Joint Venture intent to solicit and receive Statements of Qualifications with the purpose of prequalifying Bidders to submit proposals to perform Work on specific Bid Packages listed in this advertisement for the Bull Run Filtration Facility Project.

The Bull Run Treatment Program will provide safer drinking water to nearly 1 million residents in Multnomah, Clackamas, and Washington Counties. The City of Portland will construct a new filtration water treatment plant and pipelines to deliver treated water to the existing system.
