Pilot Accused of Attempted Plane Engine Shutdown

Nov. 1 – Former Alaska Airlines Pilot Joseph David Emerson (left) was arraigned in Multnomah County Circuit Court on Oct. 24, 2023, in Portland, Oregon. State and federal prosecutors accused Emerson of trying to engage an emergency fire suppression system while riding in the cockpit jump seat as an off-duty pilot on Horizon Air flight 2059 from Everett, Washington to San Francisco. After a brief struggle with the pilots, he left the cockpit and was placed in wrist restraints in the back of the plane, according to court documents. The plane was diverted to Portland, where it landed safely with more than 80 people on board.
