NEW MISSION FIELDS

Episcopalians May Take in Our New Possessions.

ACTION OF HOUSE OF DEPUTIES

Islands of Porto Rico and Vieques the Districts Decided Upon—Church of England Will Give Up the Former.

SAN FRANCISCO, Oct. 5.—The triennial convention of the Episcopal church accomplished considerable work today through the session of the house of deputies which ended shortly after 1 o'clock. The house of bishops, however, remained in session later and its action will be far-reaching in its effect. In recognition of the importance of the new possessions of the United States, two new missionary districts were constituted. One of these, which consists of the Islands of Porto Rico and Vieques, has long been controlled by the Bishop of Antigua, who owed allegiance to the Church of England. By the terms of a mutual agreement, the monetary consideration being only \$750, the Bishop of Antigua withdrew his right to the religious control of the church in these islands and transferred all church buildings to the Protestant Episcopal Church of America. The second new missionary district is that of the Philippine Islands, which are recognized as being well worthy the attention of the church.

The house of bishops also affected an important change by concurring in the action of the house of deputies in consenting to the division of the diocese of Massachusetts. A fact worthy of note is that the old diocese gives \$100,000 in cash to the new one, besides turning over to it much valuable church property. The princely gift in coin was raised entirely by voluntary contributions.

The bishops also took action on the first seven amendments to the constitution already adopted by the deputies, all of them being amended with the exception of the fifth, which was temporarily held in abeyance. Consent was given to change the name of the diocese of Indiana to that of Indianapolis, as all of the state is not within the boundary of the diocese. This, with the appointment of a committee to take into consideration the examination of candidates for admission to holy orders, constituted the chief work of the bishops, and in the opinion of many delegates, of the convention, today.

An Interesting Feature.

An interesting feature of the convention was the discussion created in the house of deputies by the reading of a proposed amendment to the constitution which provides for "the temporary use of other forms and directories of worship by congregations not in union with this church, who are willing to accept the spiritual oversight of the bishop of the diocese or missionary district." Some of the opponents of the measure professed to see in it a menace to the solidity of the church through the extraordinary individual power it would confer on the bishops, while others unequivocally declared it would open a way for the introduction of mass and other Roman forms of worship. Its champions asserted that the purpose of its proposed adoption was to give the missionaries freer scope in bringing within the church those converts who may be unable or unwilling to accept the book of common prayer. Considerable eloquence was developed by the debate, and when the house adjourned, the convention was not tired of listening to the arguments.

The King's Daughters held sessions at St. Luke's Church, on York Street, and being welcomed to the city by Bishop Nicola, of California. After communion service, reports were read, the election of officers being deferred until the next session.

In the House of Bishops.

The house of bishops in executive session today adopted amendments one, two, three, four, six and seven, to the constitution, all of which have been voted on favorably by the house of deputies. The first amendment, which relates to the election of bishops, has been held over without action for the time being.

As a committee to co-operate with a similar committee from the house of bishops to decide upon the place for the next triennial meeting, the chairman appointed the following: The Right Rev. William Woodruff Niles, Bishop of New Hampshire; Edward Robert Atwell, Bishop of West Missouri; Cleland Kinloch Nelson, Bishop of Georgia; Thomas Underwood Dudley, Bishop of Kentucky; Joseph Horsfall Johnson, Bishop of Los Angeles.

Two new missionary districts were created, one consisting of the Islands of Porto Rico and Vieques, and the other of the Philippines. This was done after the formal acceptance of an instrument, by which the Bishop of Antigua, Archbishop of the West Indies, relinquishes the authority of the Church of England in Porto Rico and Vieques to the Episcopal Church of America for the nominal consideration of \$750. Considerable church property is also included in the transfer. The bishops agreed with the deputies in the creation of a new diocese in Massachusetts. The old diocese will turn over church property and make a gift of \$100,000, voluntarily contributed to the new diocese.

Consent was given to the change in the name of the diocese of Indiana to that of Indianapolis.

The following committee was appointed to consider the general question of examinations for courses in theological seminaries and for admission to holy orders: The bishops of Dallas, Southern Virginia, Tennessee, Massachusetts and the bishop of Ohio of Southern Ohio. Adjourned until Monday.

The convention opened this morning with a large attendance at the prayer service in Trinity Church. The house of deputies then convened for a half day's session, it having been decided to hold no afternoon business meeting Saturday. After the convention had been called to order, several memorials and sets of resolutions were presented and referred to the proper committees. The consideration of amendments to the constitution was then resumed.

The house of bishops met at the usual hour, and continued the consideration of church matters.

Five New Bishops May Be Chosen.

The convention may choose five bishops. A bishop must be elected for the missionary diocese of Olympia, in the State of Washington, to take the place of Right Rev. Dr. Barker, who died recently. Rev. Dr. Clappett is prominently mentioned for the place. Dr. Clappett is rector of Trinity Church in this city.

DISS DE BAR AGAIN.

Notorious Swindler Appears in a London Court.

LONDON, Oct. 5.—Detective Inspector Kane, who has charge of the prisoners giving their names as "Laura Horos," who are in custody here on the charge of conspiring to defraud women of jewelry and money by fortune-telling, said to a representative of the Associated Press this evening: "There is no doubt that Laura Horos is the former wife of General Diss de Bar, though she is married now to a man named Jackson, with whom she has been living for some time in England and on the Continent. There is no doubt that they are both swindlers. They could not otherwise have obtained the influence they have by the name of 'Laura Horos.' We have a mass of evidence, including a charge of assault against the man, and one of active assistance against the woman. Presumably they also have a charge of felony forthcoming. The Magistrate has promised to devote three clear days to the case, so voluminous is the evidence."

NEW YORK, Oct. 5.—Anna O. Diss de Bar served a term on Blackwell's Island about 15 years ago for swindling Luther C. Marsh. It is said that she has since been in prison at Joliet, Ill., and in Italy for impostures similar to those which she practiced on Mr. Marsh.

DEPARTMENT OF PHILIPPINES

Johns Hopkins University Is to Have a New Department.

UNDER CAREY LAW

Application for Irrigation in Harney Valley.

LIVESTOCK MEN OPPOSE IT

Water of Sliver River to Be Drawn Upon—Will Diminish Marshes About Its Mouth—Survivors and Plans Made.

Application for approval of the plans for irrigating a considerable area in the Harney Valley, in Southeastern Oregon, is now before the State Land Board at Salem. Upon the approval of the board depends an extensive reclamation project in that country. This application is filed by the Harney Valley Improvement Company, which has expended about \$5000 in surveys and other preliminary arrangements this year, and which must await the pleasure of the state board before proceeding further with the enterprise. The company was organized last June with an authorized capital of \$100,000. The president is William Henley, the Burns cattle king; L. R. Webster, of Portland, is vice-president, and Drake C. O'Reilly, of Portland, secretary.

The necessity for approval of the plans of the company in this instance arises from the fact that the company is proceeding under the provisions of the Carey act, which requires that the land be approved by the State of Oregon by act of the Legislature last winter. According to the Carey law any person, corporation or association may enter into contract with the State Land Board to reclaim any tract of desert Government land. The applicant must at his own expense make a survey of the section to be reclaimed and submit with his application for contract a map and plan of the proposed reclamation project, with estimates of "first cost" and for maintenance, and statements of the amount of water to be rendered available, the area to be covered, etc. The contract, when entered into by the State Land Board, shall create a lien for the cost of construction and maintenance, which shall be valid against the separate and subdivisions of the land reclaimed, for the amount due as agreed upon, with interest at the rate of 6 per cent from date of reclamation. The conditions under which Congress grants the lands to the state must be fulfilled to the satisfaction of the Secretary of the Interior before the transaction is completed.

In the Harney Valley it is proposed to bring about 100,000 acres of arid land under irrigation. About 50,000 acres of the arid land of the valley is owned by the Willamette Valley & Cascade Mountain Wagon Road Company, which Charles A. Aitschul, of San Francisco, is proprietor. Half of the remainder is owned by the Pacific Livestock Company. It is understood that Aitschul favors the irrigation enterprise, because it would open the country to settlement and make his lands more valuable and salable. The livestock company, however, is hostile to the reclamation project, because the settlement of the country would restrict the free grazing area. That company's holdings are so situated that without extensive irrigation works it is impossible to use a large amount of public land, an extent said to be equal to more than it has title to. Thus it has the use of the whole valley under present conditions, though actually owning less than half of it. When settlers shall occupy the open land the grazing area will be correspondingly reduced.

St. Louis Fair Site Case.

ST. LOUIS, Oct. 5.—The injunction proceedings to prevent the world's fair from being held in Forest Park will go to the Missouri Supreme Court for final decision. Judge Douglas, of the St. Louis Circuit Court, granted an appeal today from Judge Zachert's denial of an injunction last July. The affidavit for an appeal was filed today by C. H. Krum, attorney for Henry H. Werden and John F. Bergheim, the plaintiffs. The granting of the appeal will not hinder work on the fair site. There is no restraining order against the use of Forest Park, and none can be issued until after the Supreme Court has passed on the case.

Will Talk Reciprocity.
