UNKNOWN MAN INJURED NEAR ST. HELENS.—G. A. Hall, a lawyer of St. Helens, called yesterday at the police station and stated that an unknown man had fallen from a train at Warren station and was seriously injured. The train left this city Friday afternoon at 2 o'clock, and presumably the man came from Portland. The County Judge at St. Helens, Columbia County, took charge of the stranger, who talked incoherently and was unable to tell his name or where he came from. The Northern Pacific train crew took charge of the train Friday said that the man acted strangely, and he was warned to keep off the platform of the car, but in rounding a curve he disappeared, and was afterward found injured and taken to St. Helens. He had a considerable sum of money in his possession, also a torn receipt for a poll tax paid in Missouri. He wore a suit of overalls and a colored shirt. Effort are being made to find his friends. Railroad officials stated that the man had been assisted to board the train at Portland by a policeman at the Terminal Depot, but this is denied by the police.

CHARGES WIFE WITH LARCENY.—Trouble has broken out afresh between Mrs. Pauline Gross, of Wilson street, and her husband, Godfred Gross, of 866 Hendricks street. He had in his possession, on Monday, charged with the larceny of clothing valued at \$20, and \$30 in money. The couple separated some time ago, and the husband took one of his sons to live with him. Mrs. Gross took the smaller children, and has supported them and herself by washing clothes for the people of the neighborhood. Last Friday the little boy, who lived with his father, came to live with his mother that he wanted to live with her, and that he had not been cared for. The mother went to the Hendricks-street house, and in the absence of her husband, she says she took a pair of his boots, his bicycle lamp and other little articles. It is for the latter that her husband has caused a warrant to be issued. Mrs. Gross was not placed in jail, but she promised to appear in court when wanted.

APPLES FROM COEUR D'ALENE.—General Passenger Agent Craig, of the O. R. & N., yesterday received by mail a tin box of such weight that extra postage was required to pay for its transportation. In venturing to open it he found that the box contained one (1) lustrous blushing apple. It came from Lemland, on the western side of Lake Coeur d'Alene, in Northern Idaho. The apple weighs just a pound, and measures 15 inches in circumference. It is firm and fragrant and handsome enough to make a market for itself anywhere. It belongs to the Gano variety. For a new country not supposed to be suited to apple production this specimen fully justifies the pride of its grower.

FATAL ACCIDENT TO THOMAS BYRNES.—At 11 A. M. yesterday morning Thomas Byrnes, of Portland, died at Hopewell, 27 miles from Vancouver, as the result of a serious accident sustained while felling a tree on the farm of his brother-in-law. Byrnes was cutting down the tree, and when it fell, he ran to get out of its way. It struck a lot of dead wood and slipped back a dozen feet, striking Byrnes on the back and inflicting fatal injuries. He was well cared for, but died from the effects of the blow seven hours later. Byrnes was well known, having for many years been engaged in railroad and Tongue-shore work. He was 37 years of age. His Portland residence was 290 Burnside street.

WANTS HIS GAMBLING MONEY BACK.—Loren Woolley has begun suit before Justice of the Peace Kraemer against the De Martini Company, 1211 Commercial street, to recover \$275 he lost in playing "21" at the defendant's saloon. Under the law Woolley is entitled to recover twice the amount of money he lost at the game, while the money is paid. He states that he and others went to the De Martini place and played cards with a dealer employed by the company. The dates of the games are given as having taken place on December 9, 15 and 17.

HORSEMAN INJURED IN FALL.—As the result of being thrown from his horse, James E. Church, former manager of the Portland Flouring Mill Company, lies at his home at North Albina with his collar bone broken. Last Friday Church, who is an experienced rider, was mounted on his horse and was going to the mill, when one of the animal's fore feet caught in a hole in the plank, and Church was thrown over his horse's head. He is a brother of Police Sergeant Church, who has a wife and children. Last night he suffered a great deal of pain.

SLIPPERY RAILS CAUSE CAR COLLISION.—Slippery rails caused a collision last night about 10:30 o'clock, between a passenger train Washington, between an Oregon City car and a Woodlawn car, but nobody was seriously hurt. Both car vestibules were smashed. The Oregon City car motorman tried to pull up his car when the collision occurred, but the brake did not act promptly on account of the wet condition of the rails, and a collision was the result. One motorman was knocked from his platform, but was escaped with a few bruises.

YOU DIDN'T EH? Some days ago The Oregonian said: The Astoria Daily News desires removal of the military forces of the United States from Vancouver and permanent establishment of the chief post of the Northwest at Fort Lawton, near Seattle. The article, which is published in this issue, which, of course, is gratefully and gladly reprinted by Seattle papers. The object, of course, is to go inland to Portland and to Oregon.

But the Astorian denies that it is doing so. The Oregonian says it said: The News now makes this statement: The Daily News simply said in substance, that Portland's policy, under the domination of the wheat pool, was keeping Portland in the backwoods of this nation and that would result in the loss of the military headquarters at Vancouver. It was simply our opinion that was expressed. The wish of the News is obvious.

Now let us see. Here is the article published by the Astoria News, and reproduced by the Seattle Post-Intelligencer: Seattle is demanding removal of the military headquarters of the Department of the Columbia from Vancouver, near Portland, to Fort Lawton, near Seattle. The demand, in the present commercial state, is not unreasonable. Neither is compliance with the demand unwise.

It well claims that nine-tenths of the business of this department is done in Washington state and in Alaska, the supplies for which are furnished at Portland and to Oregon. Vancouver headquarters, 100 miles from the mouth of the Columbia, in the backwoods, handicapping the War Department.

All the cities in Washington, except Stevens, Canby, Columbia, Vancouver, Walla Walla and Spokane are away from Puget Sound in that state, while Forts Flieger and Casey guard Puget Sound entrance and Port Lawton protects Seattle. This last is soon to be made a full regimental post.

Portland may whistle to keep her remarks on General Randall, but I should be written on her gate post.

The hardihood of the dental by the News is not surprising, though rather striking. But there is the article. Read it, and see whether The Oregonian misrepresented the News or not. And here it will be pertinent to print again this paragraph from The Oregonian of a recent issue:

Let Astorians ask whether it is a wonder, when such a spirit is shown by their town, that neither the men, the measures, the proposals or the suggestions that Astoria offer—whatever they may be—will get consideration at Portland? It is a situation for which Astoria is responsible, and Portland will see it through.
