HILLSBORO, Or., July 19.—The Indian War Veterans of Washington County met in this city today and conferred with Representative Tongue as to methods of procedure in getting their pensions under the recent bill passed by Congress.

We, the undersigned, constituting the Indian War Veterans of Washington County, Oregon, being fully cognizant of the untiring efforts of our Congressman, Hon. W. H. Tongue, to secure for the Indian War Veterans those rights which are granted to soldiers of all wars, and being grateful for the efforts which have led to success in pensioning those who served us, irrespective of party, hereby resolve:

That, inasmuch as in Mr. Tongue is found all the qualifications necessary for a successful representative of a state of the great Northwest, we do hereby give him a vote of confidence and ask the Washington County Legislature to support him for the high office of United States Senator, and to that end we pledge our influence and support for his elevation to that honorable position, which, in our opinion, he has earned by his indefatigable labors.

RECREATION FOR ISSANE FOLK.

Hot Weather Witnesses More Picnics at the Asylum.

As the building is a large one and of brick, it is comparatively cool and airy, but the patients enjoy their outdoor recreation they can get. For two hours each forenoon, and the same length of time each afternoon, those patients whose condition will permit are allowed to enjoy themselves in the shade of the trees on the lawn or in the grove in the rear of the building.

SAWMILL FOR ABERDEEN.

Construction of a Large Plant Will Be Begun at Once.

ABERDEEN, Wash., July 19.—Scott Weatherax will commence construction of a sawmill here at once. The machinery has been ordered. The plant will cost about \$25,000, and its capacity will be 60,000 to 70,000 feet of lumber per day.

COLD-STORAGE PLANT CLOSING.

ASTORIA, July 19.—The run of fish tonight was about the same as during the

two days previous, and resulted in the canneries and cold-storage plants receiving as many fish as they could comfortably handle. The noticeable feature of the business today was the closing down for the season of the cold-storage plant of the Columbia River Packers' Association, as it has secured all the fish of that character that it desires. It is understood that this plant has put up about 300 tons of pickled fish since the season opened. Elmore's cannery made a record for itself yesterday by packing 1500 cases.

Sheriff Brown went out yesterday and succeeded in arresting one of the men, whom he sent into town in charge of a deputy, while he continued to hunt for the other man. The man arrested had a preliminary examination before Justice Meszick yesterday afternoon, who bound him over in the sum of \$200 to await the action of the Circuit Court.

TO VISIT CRATER LAKE.

Representative Tongue and Governor Geer Will Be in Steele Party.

MEDFORD, Or., July 19.—Will G. Steele, of Portland, who started the movement 17 years ago to secure a National Park for Crater Lake, was in Medford today, arranging for an excursion to that wonderful region. He had previously arranged to go via Ashland, but in view of the fact that he would have had to contend with the Rogue River road, which will go over the Dead End and Ashland road. He expected to leave Medford August 7 with a party of 20, among whom will be Governor and Mrs. Geer, Representative and Mrs. Tongue and several prominent officials from Washington. Citizens of Medford have taken up the matter with Mr. Steele and will give the party a cordial welcome, as this is the first excursion of prominent people to visit the new National Park.

HAYES' APPEAL IS OVERRULED.

Commissioner Hermann Rules on Famous Tillamook Land Cases.

OREGON CITY, July 19.—Commissioner Hermann has overruled the appeal of Charles E. Hayes from the decision of the local Land Office in 39 of the famous Tillamook land cases. Hayes took the contest against Berntha B. Martin as a test, and if he appeals from the decision of the Commissioner to the Secretary of the Interior, which is probable, the Secretary sustains the Commissioner, which is also probable. Hayes will have lost every one of the 39 cases dismissed. In this event G. O. Nash, a junior contestant, will become the main contestant in the contest, and the other recourse Hayes will have will be to file new contests, in which case he will become a junior contestant to Nash, who is a senior contestant, and who has filed junior contests against many of the claims.

NEW YORK, July 19.—Frank K. LAND SALE TO BE GIVEN UP.

Government Valuation on Fort Hall Tracts is Too High.

WASHINGTON, July 19.—(Oregonian News Bureau.)—The attempt to sell lands within five miles of Pocatello, Idaho, at not less than \$10 an acre will probably be abandoned early in the coming week, and the great bulk of this area will remain in the hands of the United States. Under the law opening the Fort Hall Indian reservation, these lands could not be sold under \$10 an acre. Reports received by the General Land Office today confirm the slow sales, and state that the lands lying about Pocatello are for the most part not worth this price, hence only the choice spots can be disposed of. The Secretary of the Interior will recommend that the next session of Congress amend the recent act permitting sale of these lands at a lower price, in the hope of disposing of them. It is estimated that even \$5 an acre is more than much of it is worth, and a law will be asked for not limiting the cost of disposal of the surplus lands.

MYSTERY IS CLEARED UP.

Old Family Bible Furnishes Clue to Heirs of Dead Man.

LOS ANGELES, July 19.—The mystery surrounding the identity of the citizen known as "Charles Hill," who died in the Good Samaritan Hospital in this city on May 17, leaving \$14,000 in cash, has been solved. His real name is Charles Hillier, and his home was at Brimfield, Mass. The story of the search for heirs by the Public Administrator and his attorney, Leon Moss, is interesting. After following the trail of an alleged "clew," all of which came to naught, Administrator Kellogg found among the old man's effects an old family Bible, on the fly-leaf of which was written the name of Charles Hillier, and rendered illegible by age. The writing was magnified, and the name of "Charles" and "Brimfield, Mass." were deciphered. Attorney Moss went to Brimfield, Mass., and without disclosing his identity, found a family named Charles, which had been prominent in that locality for 200 years. The man who was identified as Salem Darius Charles, chairman of the Board of Street Commissioners, Boston. Old man Salem Charles had always been an eccentric character, and no real name had been known for many years. He is said to have made his money in importing cloth while residing in Texas, before and during the Civil War.

BOLD MOVE TO ESCAPE ARREST.

Man Leaps Over High Bluff Into River and Escapes Uninjured.

NORTH YAKIMA, Wash., July 19.—J. Wade, a laborer in the employ of the Washington Irrigation Company, leaped from a bluff 95 feet high and swam the Yakima River without injury or escape arrest. He had been in the employ of a ditch constructor, and received a time check to be presented to the cashier for the money. Miss Ida Carlson, the young woman in charge of the Yakima Hotel, saw a man in the river, and called for help. A raise in the amount stated in the check, and accused Wade of changing the figures. He denied the accusation and offered to remain in custody until she could telephone to the foreman and ascertain the exact amount due Wade. She called the Town Constable, and was attended of telephone the foreman. Wade, tired of waiting for attention in office, and hearing him, walked away. Constable Willis Douglas and Deputy Charles F. Bailey gave chase, and were about to catch their man when he sprang from the rocks, leaped a bluff and landed in the Yakima River, just 68 feet below. FLAXPULPERS QUIT WORK.

Owner of Salem Field Will Try to Import Laborers.

SALEM, Or., July 19.—Falling fax under a hot sun for 40 to 75 cents per day is work that does not suit Salem children, and as a result Eugene Basse went to Portland today to engage Japanese and other laborers to work in the fields. Pulling began last Thursday, and in anticipation of finding trouble to secure help. Mr. Basse had advertised for people of all ages from 19 years up to pull fax. As all the men wanted were the younger men, he found more profitable work than this, those who responded were principally boys and girls over 10 years of age. Some were about 21 years old. About 100 men were at work with a vim on Thursday morning, but for one reason or another nearly all had quit before evening. On Friday a similar experience was had, and today the crowd of workers numbered but 15-12 boys and 3 girls.

LA GRANDE, Or., July 19.—Sheriff J. A. Green, of Whitman County, Washington, is here with one Fred Moxley, who started back to Colfax this evening. On July 14 Moxley hired a horse in Colfax, and it is alleged, did not return it at the time agreed upon. He was arrested by Sheriff Shackelford, of Wallawa County, and held until Officer Green arrived with requisition papers. Moxley, who is believed to have served a three-year term in the Oregon Penitentiary for a crime similar to the one for which he is now held, claims to be innocent.

Irrigation Proposition.

Elleensburg, Wash., July 19.—J. H. Wells, manager of the Kittitas Irrigation Company, today made the farmers under his proposed canal a proposition to take

from them half of their unimproved land and one-third of the improved land, and charge them \$1.50 per acre for water. He said if the landowners would meet him on this proposition, the money is available to construct the canal. His statement was made in public meeting, and he will now make a direct canvass.

Ordered to Manila.

VANCOUVER, Wash., July 19.—Major Frank F. Eastman, who served for a number of years at Vancouver Barracks with the Fourteenth, has received his transfer with Major Bullard from the infantry to the cavalry department and been ordered to Manila.

Contract Surgeon Wallace E. Parkman has been ordered to Vancouver Barracks for assignment to duty in Alaska.

Geer Issues Requisition.

SALEM, Or., July 19.—Governor Geer today issued a requisition upon the Governor of Nevada for the extradition of Bert Healey, who is wanted in this county for the murder of Benton Tracy. Sheriff Withers, of Lane County, has the man under arrest at Reno, Nev., and will return him to this state.

Writ of Habeas Corpus Denied.

SAN FRANCISCO, July 19.—The petition for a writ of habeas corpus sued out by the attorney of Joseph Black, the alleged Massachusetts fugitive, has been denied by the Supreme Court. Black will now be turned over to the Massachusetts officers.

Expert Testimony on the Island's Industrial Outlook.

Boston Herald. Poor Cuba! The sugar market was quick to appreciate her difficulties, and with the prospect of Congress doing nothing for her relief, the price of sugar has declined to a lower point than it has previously touched. So long as it was possible, the Cuban planters have held on to their crop, hoping for some assistance from Congress that would enable them to market it at something like the cost of production. The planters, however, cannot indefinitely extend their loans, and they are obliged, therefore, to market their product and pocket their loss as best they can. Over 1,000 tons of sugar were sent from Cuba to the United States last week, and freight engagements have been made for 60,000 tons. This free selling of Cuban sugar means that the price for the refinery is forced down to a point where it is supposed to have a stock on hand, and they will only buy at a low price, carrying the sugar until they need it. Cuban centrifugal sugar of 96-degree test has sold in New York during the current week, duty paid, at 3-1/2 cents per pound, the lowest quotation recorded. Previous to this 3 1/2 cents per pound has been the price for the best sugar. Uncle Sam collected a duty of 1.00 cent per pound, leaving the value of the sugar in bond at New York 1.25 cents per pound. Allowing .60 cent per pound to cover freight and insurance charges, this left the Cuban planter 1.35 cents per pound as the price of his sugar alongside ship in Cuba—that is, the Cuban planter gets the most for his sugar by shipping for raising the cane, growing it, harvesting and transporting it from the factory to the plantation to the point of export on the sea. Sugar at such a price means ruin for the Cuban planter, and he must stand the loss of almost half a cent. At that rate the Cuban sugar interest cannot long survive bankruptcy.
