

WAR ON BAD MEATS

Health Officers Begin Active Campaign.

BUTCHERS MUST BE CAREFUL

E. Trimbath, a Hillsdale Farmer, Said to Sell Sick Hogs in Portland Market—Fleas Gully in Municipal Court.

Charged with selling diseased meat, E. Trimbath, of Hillsdale, yesterday appeared before Municipal Judge Hogue and pleaded guilty to the charge. He held, however, that he had not known at the time that the meat was diseased, and that it was the place of the butcher to be able to tell the condition of the meat. After some consideration it was decided that an attempt should also be made to make the butcher share the responsibility, and the case was postponed until Tuesday, awaiting the statement of Dr. Biersdorf, City Health Commissioner. Dr. Biersdorf, when seen, stated that the law held one as much responsible as the other, and it is probable that both will be held to answer the charge.

This is the first arrest that has been made, and inaugurates a war that will be waged against the practice of selling diseased meat, and any one offering for sale meat that is not good will be prosecuted to the full extent of the law, without regard to the fact that it is the meat of a sick animal.

Dr. Biersdorf, yesterday, when seen regarding the condition of certain markets as he has been finding them of late.

"We intend to make an active fight in this matter, and to avail ourselves of the protection offered in the law. The ordinance says that 'any one found offering impure meat for sale in this city shall be fined not less than \$10 and not more than \$50,' and it does not attach the responsibility to the man who first offers the meat for sale. Hereafter we will promptly take action, and will not make investigation as to who is to blame. It will be the place of the meat markets to investigate properly the condition of the meat before they take it, and after they have it they will be held responsible."

The authorities have been trying to stop the sale of bad meat for some time, and have in several cases reported meats that were unfit for the market, but yesterday was the first step toward enforcing the law. Two hogs were found in a Sixth-street market, offered for sale, and investigation showed that they had been afflicted with cholera before they were killed. A warrant was at once sworn out for the arrest of E. Trimbath, of Hillsdale, who had brought the hogs to market, and the authorities say that, if he can be convicted, they will make such an example of him that others will be disposed to be more careful. During the summer months here there has always been more or less sickness that the doctors have thought it due to the use of bad meat. This year the health officers have been watching the market very closely. Several times in the last month they have found meat that they did not consider safe for food, and have condemned it and notified the offending parties concerning the law. Especially in the meats killed in the country have they found trouble, and this is attributed to the fact that there are no proper facilities there for the hanging of the carcasses. Of the bad meats found, the trouble has been of a varying character. In some cases it has been in such a stage of putrefaction that it was not fit to be used. In many of the cases the trouble was due to a disease that the animal had contracted while living, and some cases were found where immature veal had been offered for sale. It has been the policy of the officers, to try to induce the people to be more careful, but of late the condition has grown worse rather than better, and upon the finding of the two cholera hogs, Dr. Biersdorf came to the conclusion that the matter had gone far enough, and promptly started out to find the offending parties. Upon making investigation in the community where the offending party was told that Mr. Trimbath had made a practice of killing his sick hogs and sending them to the Portland market, and that he had never taken the proper precaution against disease, saying that the sick ones were as good to kill as the healthy ones.

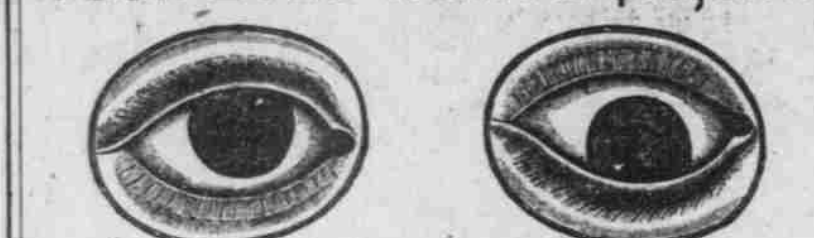

FINDS HER BOY MURDERED

MOTHER ARRIVES TO CLAIM BODY OF ONE OF BELDING'S VICTIMS.

True Name of Frank Woodward, Who Was Killed July 11, is George Woodruff.

Mourning the loss of one that they loved, the mother distracted with grief at having learned from the first time of the death of her son, several members of the family of George Woodruff, who was shot and killed by A. L. Belding on July 11, arrived in Portland yesterday, and at once made preparations for the proper burial of the remains. The name had been published as Frank Woodward, and the family had never suspected that it was one of their number that had met this tragic death until a friend of the family who had wondered that there was nothing heard from them in the matter made inquiry as to the reason for their silence, and then it dawned upon them that they had a special interest. At the time they heard that it was their son that had been shot and that there was no one here to claim the remains they were at Summerville, about 20 miles from La Grande. It was in the afternoon, and, catching up the horses at once, they drove with great haste to La Grande and caught the train for Portland, arriving here yesterday morning. They went at once to the Coroner's office and made inquiry as to what had been done with the remains, and made arrangements to have them disinterred, and a proper funeral given. The remains were last night brought to the parlors of the J. P. Finley Undertaking Company, and the mother sat up with them during the night. A handsome casket has been procured for the body. Several members of the family in different parts of the country have been notified, and as soon as they arrive the funeral will be held. The members of the family are Episcopalians, and say the Episcopal services will be used.

It is a sad thing to talk with the mother and hear her tell of the grief that she has suffered in the past few days. She cannot restrain the tears at the least mention of her son, and can hardly control her grief as she calls up little incidents of his past life. She says that the reports that were made after the death were not right, and that she had never once thought that it could be her son that was killed. "He was a young fellow," said she, "nearly 20, and was a good, hard-working boy. He did not like the kind of life that we were leading, and longed to be in the city. Early in the Spring we left for Eastern Oregon, to take our regular trip through that country, and when we were at Walla Walla he became so discontented with the continuous traveling that he left us. He did not tell us that he was going and I worried a great deal about him. He was engaged to a girl in Seattle, and I thought that he had gone there. I tried to get letters to him, but they did not find him. At last I heard that he was in Portland, and I felt

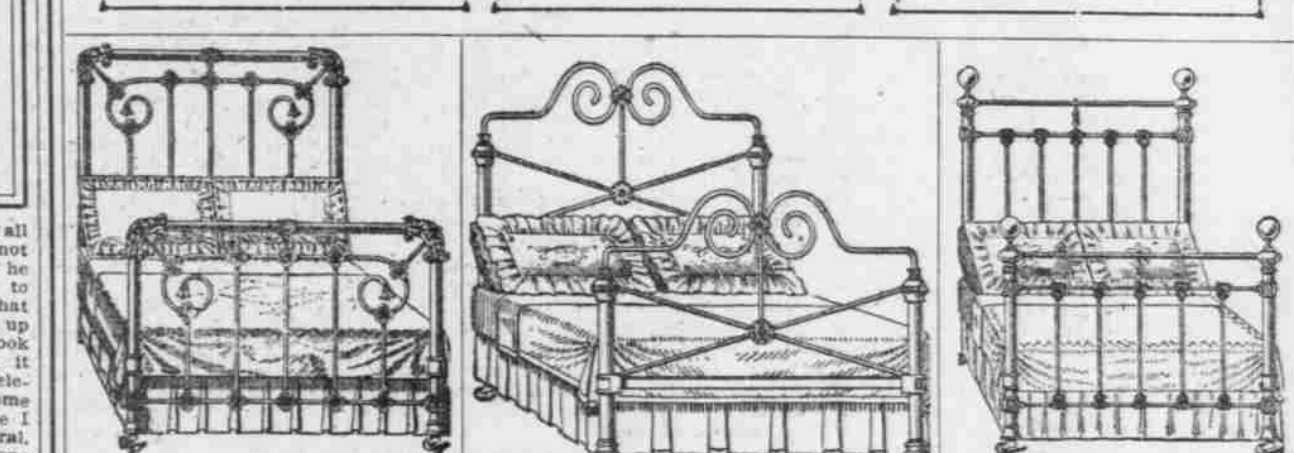
