

ONE PULL BY ALL

Fair Site Settled; Now For Work.

EAST SIDE ACQUIESCES

Disappointed, but Citizens Sav "All Right."

GLAD LONG SUSPENSE IS OVER

Directors Will Ratify Executive Board's Choice of Willamette Heights—Then Come Plans for Great '03 Exposition.

"Hurrah for the fair!" cried a Hawthorne Park man yesterday. "We hoped to see our site chosen, but we were disappointed. The men whose judgment has been best. We East Siders are broad-minded, we are. Our motives were not selfish in advocating our site; we were governed entirely by the feeling that better financial results would come if the fair were in the heart of the city. But since the executive board has outvoted this with other considerations, we accept the verdict cheerfully."

"The members of the board spent weeks of labor in the choice; they gave their services gratuitously; they were swayed by no sinister influence; and they should not be criticised. We East Siders won't kick, nor grant our knock. We shall join in the pull all together. Everybody ought now to get in and whoop it up. Hurrah for the fair!"

The above was but a single echo of public sentiment yesterday. The voice that went up in the city was one of gladness that the long suspense was over. A number of complaints raised themselves above the common talk, but they were not strenuous, neither were they sharp-tongued. The consensus of opinion was that the choice must be the wisest that could be made because it came from men who were the ones qualified to make it. The unanimity of the selection, the absence of private interests from the decision, and the recognized integrity of the committee disarmed criticism and fortified the enthusiasm that commended the choice.

Most of the criticism that did voice itself was from the East Side of the river. The announcement of the choice was a sudden surprise, and for the moment there was spontaneous combustion among some hotbeds. But as the day wore on the people who had let their feelings get warmed up began to cool down. Representative citizens of the East Side stood in with the selection right away. "This is no time for whimpering," said one of them, "that for action. Willamette Heights is Portland's choice. We are citizens of Portland. The men who made the selection represent our interests as much as anybody's, and we shall stand by those men."

"Yes, sir, we are going to get in and dig for the fair," exclaimed Henry H. Newhall, president of the East Side Bank. "I think the site is a good one, and that it will serve the best interests of all persons concerned. The East Side would like to have the fair, but the West Side is entitled to it. Regretment on the East Side? Well, I never heard of it. I have not yet seen people doing any kicking on this side of the river. On the contrary, enthusiasm has been rekindled. Many persons who had grown apathetic on account of the way the site question dragged on now feel themselves warmed up, and they will come forward with the money they subscribed. It is from this time on a long pull, a strong pull, and a pull all together to make the fair an object of lasting pride."

"Do we kick?" responded Dan Kellaher. "No, sir; not a bit of it. Some of the people on the East Side are a little sore, but they will get over it. If any of the good citizens of Portland are grumpy by habit, they don't live in East Portland. You bet we're in for the fair. Whoop it up!"

"Don't let them make you believe they are kicking," exclaimed W. J. Clemens, who was among the men who regarded Hawthorne Park as the only place on earth for the fair. "They will come around to the judgment of the directors. I have come to it already, because I know the directors did just the best thing. No, I haven't any haven't any account. Willamette Heights is the proper place, what's all? I am glad I was mistaken, that's all."

The choice is final, without any shade of doubt. All but two of the seven other members of the board of directors not on the executive committee were interviewed yesterday, and while some of them did not wish to talk for publication, they did not hide their preference for Willamette Heights. The other two, no doubt, will join in to make the choice unanimous. It seems probable, therefore, that at the meeting of the entire board next Friday the selection will be ratified without a dissenting voice.

Even if the board were not so strongly in favor of Willamette Heights, there would be slight possibility now of choosing any other site. It is recognized that a change from the announced selection would have a very depressing effect on the whole fair project, and would reduce public interest to a low ebb, from which it could recover only after a long course of positive action. Besides, the executive committee, according to the by-laws of the fair, is vested with the power of selecting the site, although the choice must be formally approved by the board. The certainty that Willamette Lake will be the site is therefore as strong as to be absolute. Section 2 of article VI of the by-laws says:

The executive committee shall take the necessary steps toward the selection of a site for the Exposition to be held by this company, and to develop a plan embracing the scope and general execution of such site, and the selection of such site and the adoption of a plan embracing the scope of the Exposition shall be subject to the approval of the board of directors. After the adoption of the general plan the executive committee shall have general supervision and control of the work of all committees, and shall organize such bureaus and departments and appoint such managers thereof as they may deem necessary for the execution of such work.

The site selected, the question is, What next? According to the above article of the by-laws, that "what next" is to be supplied by the executive committee, and the sentiment of that body and of the public is that the "what next" cannot be begun too soon. The administration work of the fair, the work of giving the enterprise impetus, and of carrying it along must be started by the executive committee and advanced to the finish. This work will grow up from now on. Plans will have to be formulated and matured. An one director said yesterday: "The public will hereafter have the fair brought to their attention every day."

As the Park site is selected, the question what to do with it will next absorb attention. It is premature as yet to say just what will be done along this line. The directors interviewed by The Oregonian yesterday were in favor of laying out the grounds immediately. They

advocated having this done by competent civil engineers, architects and landscape artists. This cannot be done too soon, for the scope and size of the Exposition largely will depend upon it. The site area for the largest of exhibitions, and yet it will set off a small exhibition just as well.

"The site is chosen," said a director yesterday. "Now lay it out."

The fitness of the site grows in a person's mind as he thinks about it. The location is nearer the center of the city than it first seems to be. It is accessible to water, steam railways and electric railway transportation. It is more in line of such facilities as these than any other site could be. Traffic to the fair will not overtake the river bridges. The people of Albina are just on the other side of the river. Those persons who will have the greatest distance to travel to reach the grounds will be residents of East Portland and extreme South Portland.

The directors have settled in their minds that the level of Guild's Lake can be raised at low cost by pumping water from the river. The engineers have proved that the level of the lake is independent of that of the river, and that there is no seepage of water through the bed of the lake into the river. They advise the use of a centrifugal pump with a capacity of 50,000 gallons an hour. The total contents of the lake are such that if all the water of the Bull Run pipe system were discharged into the lake, 30 days would be required to raise the water up to the six-foot level. Considering that perhaps 2,000,000 gallons of water a day will have to be discharged into the lake, it would be impossible to keep the lake filled by means of the city water system, inasmuch as the city uses the full flow from Bull Run at certain parts of the day. If the city reservoirs were in shape to be used, considerable water might be turned into the lake.

The owners of property embraced within the site are willing to give the use of the land. The grounds are owned by the Mead estate, Sol Hirsch, Jacob Mayer, J. N. Fleischner, Russell & Blyth, L. J. Goldsmith, P. L. Willis and Mrs. S. G. Reed. There are about three dwellings on the site, and the property is of special value. It is thought that \$2500 will compensate the owners for the removal of the houses.

The western part of the site is occupied by Chinese gardens. It is low ground, highly fertile, and is an admirable place of ground for gardening and landscape and floral effects. Development of this part of the site will begin as soon as possible.

The eastern part of the grounds is elevated, covered with underbrush and groves. It will be the main Exposition grounds. Its highest elevation above the river is 120 feet. The prospect from this elevation is a very fine one in all directions. From this high point the grounds slope away gradually to the lake. A tongue of land juts out into the lake and carries a very attractive adjunct of the fair. It is now beautiful farm land.

TO GET G. A. R. MEETING

SUMMER POST DECIDES TO URGE THIS INVITATION.

If Sufficient Funds Are Guaranteed, Delegates Will Work for 1903 Encampment.

At the close of a long and exhaustive discussion last night Summer Post, G. A. R. of the East Side, voted unanimously that it was the sense of the members that the Grand Army of the Republic encampment of 1903 should be held in the City of Portland. There was a large attendance of the members, and the live interest was displayed in the proceedings. Committees from Lincoln, Garfield and George Wright Posts were in attendance to ask appointment of a conference committee from Summer Post, and in accordance with this request M. L. Platt, John E. Mayo and M. Buchanan were appointed.

T. V. McDevitt, of the Lincoln-Garfield Post, made an explanation setting forth the functions of the joint committee. He also made a strong argument for the movement that has been started looking to the holding of the 1903 encampment in Portland. He believed it could be held here, and that Portland could take care of that assemblage.

Paul Pfertner, one of the originators of the movement, spoke most enthusiastically for securing the Grand Encampment. He said that since the discussion had commenced, assurances had come from business men of Portland that they would assist in providing the means for the proper entertainment of the delegates while in Portland. He, too, was confident that Portland can handle the encampment in a creditable manner.

Mr. McDevitt further remarked that it had been estimated that it would be necessary to raise \$50,000 for the proper entertainment of the delegates to the encampment.

Colonel G. E. Caulkins said that while he was not so enthusiastic over the proposition as some of the comrades, he did not want to throw cold water on nor discourage the movement, but he said that the question should be looked into with care. There would be an immense amount of work to do to make the encampment held in Portland a success. There were several questions that presented themselves, and among these was the matter of entertainment. There was a question whether there were a sufficient number of comrades in Portland who would be willing to do a great deal of hard work and in the end give about three months of their time to the encampment. Colonel Caulkins said it would be well to give all these matters careful consideration. He said that he had agreed to vote to hold the encampment at San Francisco, and unless released would have to carry out that agreement. However, San Francisco was not very enthusiastic. Colonel Caulkins remarked further that he wanted to hear what others had to say.

M. L. Pratt, commander of the Oregon Department, made a stirring speech in favor of inviting the Grand Encampment of 1903 to Portland, and gave many reasons in support of this position. M. Buchanan, Judge John E. Mayo and Rev. Henry A. Barden delivered enthusiastic talks all favorable to inviting the encampment to come to Portland in 1903. Nearly every one present expressed himself most favorably to extending the invitation, provided the people of Portland will raise the money required.

It was decided that the joint committee, from all the posts in Portland should now wait on the Governor, Chamber of

Commerce, City Council, Mayor, Board of Trade, Lewis and Clark Commission and prominent citizens of Portland and ascertain if money sufficient can be had for the proper entertainment of the delegates if the encampment be invited to come. The complaints against the defendants were issued on the oath of Thomas McCusker, president of the Civic Improvement Association.
