

TO CONTEST WILL

Mrs. Smalls, Heir to Late J. L. Stubblefield.

AFTER REQUEST TO ORPHANS

In Niece of Testator and Was Remanded to Extent of \$500—Benefactor's Widow Opposed to Such Action.

WALLA WALLA, Nov. 22.—(Special.)—Mrs. Kittie Smalls, heir to the fortune of the late Joseph L. Stubblefield, who left \$100,000 for the establishment and maintenance of an orphan's home in or near Walla Walla, tonight signified her intention of contesting the will. Mrs. Smalls is a niece of the testator, and was remembered in his testament to the extent of \$500. About thirty other heirs, who are provided for in sums ranging from \$25 to \$2500, are said to be behind Mrs. Smalls in the plan to break the will. Mrs. Smalls has procured lawyers, and declares she will file her protests at once. Stubblefield's widow, who is allowed \$600 by the provisions of the will, is opposed to the action of her niece. The trustees named for the proposed orphan's home are preparing to resist the contest. Papers will be filed in the courts Monday.

OREGON CITY POLITICS.

Both Sides in Line for the Municipal Campaign.

OREGON CITY, Nov. 22.—(Special.)—Municipal politics has simmered down to a point where it is possible to predict the nominees for the various offices, in the election to be held a week from today. It looks now as though no convention will be held and that all of the candidates will be nominated by petition only. Mayor Dimick will head the Independent Citizens' ticket, as this name is designated in his petition which was filed in the City Recorder's office this afternoon. Samuel Philester will also run on Dimick's ticket for Councilman in the Second Ward, to succeed Councilman Charles Albright, who will have a place on the Non-partisan ticket, whose candidate for the Mayoralty is ex-Sheriff John J. Cooke. Councilman Rudolph Koerner, who is up for re-election from the First Ward, is with Cooke, and his opponent on the Independent Citizens' ticket is Walter Little, whom Koerner defeated once before. Mayor Dimick has the support of County Judge Thomas F. Ryan, who is a power in the First Ward. Councilman Francis is not out for re-election, and the only candidate for Councilman from the Third Ward so far as is known is C. M. Mason, whose name will likely be placed on both tickets, as will City Treasurer Fred J. Meyer, against whom no opposition has developed. The candidates will probably line up this way:

Independent Citizens—Mayor, Grant B. Dimick; Councilmen, (First Ward) Walter Little, (Second Ward) Samuel Philester, (Third Ward) C. M. Mason; Treasurer, Fred J. Meyer.

Nonpartisan—Mayor, J. J. Cooke; Councilmen, (First Ward) Rudolph Koerner, (Second Ward) Charles Albright, (Third Ward) C. M. Mason; Treasurer, Fred J. Meyer.

Up to the present time little active campaigning has been done, but it is more than likely that things will live up next week. Cooke is known all over the county as a fighter, and will do his best to win, but he will undoubtedly have an uphill fight, as Mayor Dimick is strong with the working men, and they control the elections in Oregon City.

MAY BE MONTANA BANDIT.

Man Killed at Oakland Has Railway Money Orders in Pockets.

OAKLAND, Cal., Nov. 22.—As the result of being struck by a local train while walking along the Oakland Mole last night, Vladimir Vogt, about 35 years old, who may be the robber who held up the Northern Pacific passenger train at Mouth, Mont., on October 24, is dead at the morgue, and his companion, Earl Shultz, claiming to hail from Portland, Ore., is at the Receiving Hospital, suffering from a broken leg and other injuries. The men had been beaten their way from the North, and were run down while walking along the road.

The thing which connects Vogt in some way with the robbery is that in his own handwriting in a notebook is a copy of the reward offered by the Northern Pacific. He also had two Northern Pacific money order receipts. He had sent \$35 on October 12 to his sister, who formerly resided at 22 Gannon street, New York. He was at Butte, Mont., 70 miles from the scene of the robbery, three days after the hold-up.

SENDS POISON IN CANDY.

Wife Knight of the "Liberty Bells," Is Severely Poisoned.

SAN DIEGO, Cal., Nov. 22.—It was learned today that Miss Rita Knight, a member of the "Liberty Bells" Company, who killing engagements in Southern California, had an unpleasant experience in San Bernardino Thursday night. She had received from an unknown source a box of candy and partook of it freely. She soon became violently ill. Three other members of the company with whom Miss Knight shared the box were also made ill, but less seriously. Physicians were called and the young ladies soon began to mend. Miss Knight was able to play last night, and appears at the opera-house here tonight.

ENDORSES COURT CHANGES.

King County Bar Association Favors Turner Bill.

SEATTLE, Nov. 22.—The King County Bar Association today endorsed a number of changes in the Turner bill, providing for an increase of the number of United States Circuit Court districts. One amendment contemplates making a new division of the present Ninth District, which would put Oregon in the "south half" instead of including it with Washington, Idaho and Montana in the proposed Fifteenth District. Another amendment would enable the court to hold sessions here, as well as in Idaho and Montana cities.

SQUAW'S HAVE STREET BRAWL.

Full Each Others' Hair in City of Pendleton.

PENDLETON, Nov. 22.—(Special.)—Pendleton, daughter of Peo, Chief of the Lemhi Indians, engaged in a most disgraceful brawl this afternoon on Court street with another Indian woman. The latter, according to reports, was of the same tribe. The fight was a desperate one, and finally climaxed in the middle of the street in three inches of mud, their hands fastened in each other's hair, and rolled each other in the mud. Jennie is a graduate of the Chemawa training school, and 19 years ago was a handsome, cultivated woman. She is now a dissolute blanket squaw.

LECTURES AT THE BARRACKS.

Colonel Goodale Arranging for Sunday Night Entertainments.

VANCOUVER BARRACKS, Wash., Nov. 22.—(Special.)—Colonel G. A. Goodale is now trying to arrange for a series of lectures to be given every Sunday evening at the Post Hall. The lectures will be for the benefit of the enlisted men, and it is hoped enough of the officers will be willing to relate their experiences in different parts of the country so as to extend the lectures throughout the winter. The first one will be given by Colonel Goodale Sunday evening, his subject being an account of a trip through Japan, illustrated with stereoscopic views. Colonel T. E. Wilcox has promised to give an account of the early Army posts in the Northwest, and Dr. J. B. Clayton will describe his trip to St. Pierre on the relief ship sent by the American Government.

SHORT IN HIS ACCOUNTS.

San Francisco Druggist in Charge of Sub-Postoffice.

SAN FRANCISCO, Nov. 22.—Charles H. Royer, a druggist, has been arrested by detectives of the Postal Department in connection with his drug business. Royer had charge of a sub-postoffice, and he is said to be short in his accounts with the Government to the extent of \$1400. Before the arrest was made, Royer attempted to commit suicide by taking carbolic acid. It is alleged that he admitted the shortage, saying that he paid the money to creditors, but intended to replace it soon, with the aid of friends.

KILLED IN JUNEAU MINE.

Debris From Cave-In Causes Death of Two Men.

SEATTLE, Wash., Nov. 22.—A special dispatch to the Post-Intelligencer from Juneau, Alaska, says that Victor Knokk, brakeman, and Charles Wiorala, shoveler, were killed at Mexican mine, Tuesday, yesterday. Owing to the weight of concentrates loaded on the cars, a cave-in scattered debris over the two men, killing them. Besides the two killed one man was injured. No blame is attached to any one.

MINE SELLS FOR \$150,000

BOWDEN MINE AT GOLD HILL CHANGES OWNERSHIP.

New Company of California Men Is Capitalized at \$500,000—Heavy New Machinery to Be Installed.

MEDFORD, Nov. 22.—(Special.)—An event of considerable importance occurred in this city this evening, whereby the noted Bowden mine and Braden mine, situated near Gold Hill, Or., with its splendid water power, has been transferred to a corporation capitalized at \$500,000. The principal owners of the property now are Los Angeles and Boston capitalists, among them being F. T. Griffith and I. B. Hamilton, of Los Angeles. Several capitalists in Greensburg, Pa., are also interested in the new company.

HON. J. J. HOUCK AND MESSRS. S. W. MCCLINTON AND L. F. JORDAN, OF GOLD HILL, OR., WERE THE PROMOTERS OF THE DEAL.

The original owners of the mine were George C. McDonough and James F. Davis. There has been a considerable amount of secrecy concerning the consideration of this deal, but it has leaked out to such an extent that it is pretty generally known. The purchase price paid by Hamilton and his associates was in the neighborhood of \$150,000.

SOUTHERN OREGON IS COMING TO THE FRONT AS A MINING COUNTRY.

As the mining country, and as the purchasers of this mine are going to put in new and heavy machinery, and go right down into the earth after the yellow metal, it is predicted that this enterprise will prove a paying investment for its stockholders, and a great benefit to Jackson County. GIVEN REWARD OF \$1 50.

Seattle Workman Who Found \$20,000 Box of Gold Dust.

SEATTLE, Nov. 22.—How would you like to find a box of gold dust worth \$20,000 lying on the street, and return it to the owner and for your trouble receive the munificent reward of \$1 50? That is what happened in Seattle this week.

Some time ago a shipment of gold dust was received from the North on one of the steamers, and was ordered taken to the United States Assay Office, on Ninth and Cherry streets. The Seattle Transfer Company undertook the job, and, somehow, the delivery of the precious metal, the driver lost one box of the dust. An advertisement was inserted in the papers, saying that a reward would be paid for the return of the gold dust.

A poor workman found the box, which was heavier than he could carry and had it carted to the office of the transfer company. In his imagination there floated visions of the huge chunk of dust the owner would give him when he restored to him the box. The owner was notified, rushed breathlessly into the office, identified the box, opened it, found the dust all there, and handed deep into his trousers pocket, and gave the finder \$1 50.

Shocked beyond description at the "big" reward, the poor workman staggered out of the office, murmuring "Thank you!"

CLAIM BALANCE DUE.

Fraser River Fishermen Sue Salmon Packers' Association.

VANCOUVER, B. C., Nov. 22.—A writ of summons has been issued by the Supreme Court in this city, commencing a legal action arising out of a dispute between the Fraser River fishermen and the firm represented in the Fraser River Fishermen's Association, regarding the enumeration of the salmon pack of the last season, and the sliding scale price therefor. The plaintiffs claim for an alleged balance due for fish sold and delivered to the defendants by an agreement dated June 14, 1902. The particulars are as follows: The balance of 14 cents on 2,923,425 fish—\$44,000 42. When the season opened the price agreed to be paid was 18 cents for a pack of over 200,000 and under 250,000 cases, 20 cents for 250,000 to 300,000 cases, and 22 cents for 300,000 to 350,000 cases. The catch was 251,483 cases, and paid at the latter rate. The fishermen now claim that there were less than 250,000 cases put up, and that the sliding scale should be paid 18 cents for their fish, hence the difference of 14 cents per salmon.
