IS A PLAIN WORKER

Bryan Says He Never Again Will Be a Candidate.

HE DEFINES FUTURE ISSUES

Ex-Democratic Leader Names Tariff, Money, Trusts and Imperialism—Says Leaders Don't Want True Democrats on Ticket.

NEW YORK, Feb. 14.—The Evening Telegram printed this afternoon an interview with William J. Bryan in which Mr. Bryan said he would not be a candidate for the Democratic Presidential nomination next year.

"I have said on many occasions that I am not and will not again be a candidate for renomination," said Mr. Bryan, "and you cannot make that statement too emphatic. Under no consideration would I again go into the field, and I say this now for the benefit of my friends in the East. I am a plain worker in the Democratic ranks and am content to remain as such."

"That being the case," he was asked, "what in your opinion ought to be the real issues of the next campaign on the Democratic side?"

"Events make issues," answered the former candidate, "but the trust question and the question of imperialism are just now necessary issues. The tariff question and the money question are also very necessary issues, and there are many others, but those I have mentioned are now actively before the country and before Congress."

As to probable candidates, Mr. Bryan said that he preferred not to discuss the subject.

"What do you think of Judge Parker, of the Court of Appeals, from this state?" was asked.

"I have heard a great deal of favorable comment about Judge Parker," was the reply; "but when I ascertain that men are aspirants for the nomination I will make it my business to investigate these men and the principles which they are supposed to represent. Then I will be prepared to discuss them."

"I notice that I am credited with having suggested the name of Governor Garvin, of Rhode Island, as an available candidate. That is an erroneous impression. I read his annual message to the Legislature, and I find it to be a purely Democratic document. For that reason I suggested that it might be wise to consider men of his stamp among the possible candidates. But it seems that the men who have the making of Presidential candidates nowadays do not want to find truly Democratic men to represent them."

LEAVES DEMOCRATIC PARTY.

Wyoming Leader Declares Allegiance to Republicans and Roosevelt.

CHEYENNE, Wyo., Feb. 14.—Colonel Walter R. Stoll, for many years one of the leading members of the Democratic party in Wyoming and several times elected to high positions by the party, has withdrawn from it. In a long letter to State Chairman Hammond, Colonel Stoll states that the Democratic party is without organization, leadership or a well-defined policy; it makes professions in platform, but fails to carry them into practice; looks one way and travels in an opposite direction; is powerless for good, etc.

Colonel Stoll pays a glowing tribute to President Roosevelt, and says he deserves the united support of the people in his mighty fight against the trusts.

The action of Colonel Stoll is the sensation of the hour here in Wyoming. He announces that from this time on he will be affiliated with the Republican party.

STOCK DIE FROM COLD.

Severe Wyoming Weather Too Much for Cattle and Sheep.

CHEYENNE, Wyo., Feb. 14.—The blizzard which has been raging over Southern Wyoming for the past three days is over, but has been followed by weather so intensely cold that stockmen, especially sheepmen, are very apprehensive. From Gillette it is reported that stockmen expect heavy losses, due to the severe cold. Since the storm passed, the mercury has fallen below zero all over the state. Rotaries and wedge pins have been busy, but it is with great difficulty that the roads have been kept open at all.

All trains are running late, and there is no probability of the situation improving so long as the present cold snap continues and the snow drifts.

Mercury Falls Low in Wyoming.

CHEYENNE, Wyo., Feb. 14.—Last night the temperature went to 15 below at Cheyenne, 25 below at Laramie and 35 below at Evanston. Two more days of this cold weather will surely result in heavy stock losses. Trains are moving, but their passage is greatly impeded by drifting snow.

Ten Below at Denver.

DENVER, Feb. 14.—Last night was the coldest of the winter. The minimum temperature in this city was 19 below zero, but in the mountains it was much colder. The weather is moderating today, but it is not expected the temperature will rise to the normal for several days.

Grand Opera for New York.

NEW YORK, Feb. 14.—The question whether New York will have grand opera is to be decided by a conference between the Metropolitan Opera & Real Estate Company and Heinrich Conrad. The statement sent out today regarding the conference is as follows:

"At a meeting of the board of directors of the Metropolitan Opera & Real Estate Company, held Friday, February 13, 1903, it was resolved that the executive committee be directed to negotiate with Heinrich Conrad regarding the Metropolitan Opera House, with power to conclude a lease in case satisfactory terms can be arranged."

To Give Drunkards Treatment.

NEW YORK, Feb. 14.—Dying in prison cells within 48 hours of each other, their deaths in each instance attributed to alcoholism, while at least one was the victim of a fractured skull, the fate of two men has led the four coroners to start

a movement to give such persons medical treatment before imprisonment. The city coroners were unanimous in the opinion that the commitment of men suffering from alcoholism, as is now practiced is a bad system. One of the men, James L. Taggart, of Brooklyn, was found by the police in an area way and locked up. He died after a short time, and an autopsy disclosed a fractured skull and hemorrhage in the brain. The other, arraigned in the court, was committed in the Tombs in lieu of a fine. He died three hours later. External examination has led the coroners' physician to the belief that this man also died from a brain hemorrhage.

NO HOPE FOR FISHERMEN

Packed Ice Prevents Rescue by Seminoles at Bay Islands.

ST. JOHNS, N. F., Feb. 14.—Lieutenant Sturtevant, the executive officer of the United States cutter Seminole, which is endeavoring to reach the icebound American fishing schooners, started at daylight this morning to make a dash, and hoped to cover the run to Bay Islands within 10 hours.

The Seminole returned to Channels Harbor this afternoon. She was unable to get around from Cape Ray, owing to the heavy northwest gale, accompanied by a snow storm, which broke ice against the land, making it impossible for the vessel to proceed to Bay Islands. She reports that the coast is tightly packed with heavy drift ice, and that nothing can be

done until the winds change. The local navigators believe the Seminole will never succeed in her attempt to rescue the five American fishing schooners, which have been frozen in the ice in Bay Islands since the latter part of January.

Engineer Davis Caused the Wreck.

PLAINFIELD, N. J., Feb. 14.—The jury to investigate the wreck on the Central Railroad of New Jersey at Graceland, N. J., on January 27, rendered a verdict today in which James N. Davis, engineer of the Philadelphia express, is blamed "for his failure to observe the signals displayed."

The verdict says that sufficient evidence was not produced to show that the company's officials were negligent. Davis died of injuries received in the wreck.

School Teacher's Fatal Fall.

CUMBERLAND, Md., Feb. 14.—Miss Ora Montgomery, 22 years old, a school teacher in Westernport, slipped and fell while running after a recalcitrant pupil. Her neck was broken in her fall down the stairway. She died almost immediately.

Natural Gas Burns Firemen.

PITTSBURG, Pa., Feb. 14.—Six firemen were badly burned early today in a natural gas explosion following a small fire in a Clark-street house. The most seriously injured are Captain Fred Hutchinson and Lieutenant William E. Key. All will recover. The explosion partly wrecked the building, causing a loss of \$1500, and was caused by a leak in the gas main.

STRIKE BACK AT BAER

Officers of Civic Federation Resent Coal Magnate's Statements.

NEW YORK, Feb. 14.—New Yorkers connected with the National Civic Federation resent the statements made before the Strike Commission in Philadelphia by President Baer, of the Reading, that the Federation never was convened to hear the report of the coal operators on the result of a conference with the striking miners, and that the Federation leaders had deserted the cause they had espoused.

Oscar S. Strauss, who is a member of the executive council of the Federation, said Mr. Baer's statement was wide of the facts.

"The Civic Federation did everything in its power to bring about an adjustment of the difficulty," Mr. Strauss said, "and after repeated efforts succeeded in having the operators confer with the miners. Had Mr. Baer been willing to make the concessions he now offers at the time of his coming before the Federation, I feel sure there would have been no coal strike."

"The Federation is actuated by the highest motives, and always aims at fair play," said Henry White, general secretary of the United Garmentworkers of America, "and the fact that Mr. Baer feared his good offices showed that he was unwilling to meet the strike issue squarely. The many achievements of the Federation in settling strikes, preventing strikes and adjusting difficulties are a refutation of Mr. Baer's charges."

Receiver Is Asked For.

CHICAGO, Feb. 14.—A petition has been filed in the Superior Court by E. M. Baumgartner, who says he possesses \$5000 worth of stock in the firm of Siegel, Cooper & Co. The petitioner asks the court to dissolve the charter of that concern, and wants the business wound up and a receiver appointed. He asks for an injunction to restrain the collection of its accounts.

MONEY FOR STATE

Ways and Means Committee Ready to Report.

THEY WILL ASK FOR \$1,314,500

This Is \$334,000 Less Than Appropriation Two Years Ago and Includes Fair Bill and Portage Railroad.

SALEM, Or., Feb. 14.—(Special.)—The joint ways and means committee has practically concluded its work for this session of the Legislature and on Monday will introduce and recommend the passage of three bills covering the general and contingent expenses of the State of Oregon for the coming two years. The three bills to be reported will include appropriations to the amount of about \$1,314,500.

The subject of Normal School appropriations has been the center of a strong fight in the ways and means committee. A majority of the committee were in favor of cutting out at least one normal school and at one time it had been practically agreed that the Drain Normal School receive no appropriation at this session. But a strong lobby appeared in behalf of the Drain Normal School and there was reason to believe that unless Drain was cared for the entire bill would be defeated. Members of the Legislature who were expected to look out for the normal schools felt compelled to favor an appropriation for the Drain School; in order that their own schools might not suffer they came to the support of Drain. The total appropriations for normal schools amount to \$88,136 as compared with \$116,240 two years ago. The demands from the normal schools at this session amount to \$119,656, but the committee cut them down over \$30,000. The several schools have been allowed appropriations as follows, as compared with two years ago:

The ways and means committee has rejected more than half the claims that have been presented by various persons upon a multitude of grounds. In no case was any claim allowed unless it possessed merit from a legal as well as a moral standpoint.

After having looked over the bills, Secretary of State Dunbar said that the ways and means committee had drawn the best appropriation bills he had ever seen. He believed that the committee had been allowed that should not be, and that no claim had been allowed in an excessive amount. In some instances he thought that too little had been allowed.

The item list of appropriations will be found elsewhere.

YOUNG SWELLS' ESCAPEDE

They Appropriate Another's Carriage, Beat Him and Fleed.

CHARLESTON, W. Va., Feb. 14.—John H. Winder, general manager of the Kanawha & Hocking Valley Company; Dan Hanna, son of Senator M. A. Hanna, and others are charged with assaulting Hon. W. G. Caldwell, a member of the Legislature from Ohio County, here early today while the latter was going home from the legislative ball in a cab.

The other men had been at a club during the night, so it is charged. They were on their way to the Kanawha & Michigan depot and wanted a hack. They hailed the hack in which Representative Caldwell was riding and attempted to enter it. Caldwell protested and said the hack was his. Winder and Hanna tried to enter the hack, and it is charged, Winder dealt Caldwell a hard blow in the face, rendering him unconscious. Representative Caldwell was thrown out of the hack and the others took charge of it.

Caldwell was picked up by friends and taken to the hotel in a serious condition. Winder, Hanna and others left on a train for Columbus, O. A warrant for their arrest was sworn out by Caldwell and telegraphed to Point Pleasant, W. Va., but there has been no response up to this afternoon. The affair has caused a sensation here. Representative Caldwell is resting well under the care of physicians. He was badly hurt, and may lose one eye.

It is announced that the friends of John H. Winder, in the coal business here, secured the countermanding of the warrants for the arrest of the parties, and that their private car passed over the Ohio-River bridge at Point Pleasant unmolested. The warrants were sworn out by Captain J. B. White.

Winder represents the interests of J. Pierpont Morgan in Ohio and West Virginia, and all the coal operators here, it is said, pleaded to have the order of arrest rescinded.

Winder is here frequently on business, but it was the first visit of Hanna and the others.

It is stated that Caldwell's friends will offer a resolution in the House of Delegates inquiring into the case and countermanding of the order for service of the warrants.

DENY THE WHOLE STORY.

Winder and Hanna Say They Never Even Saw Caldwell.

COLUMBUS, O., Feb. 14.—The private car bearing John Winder, general manager of the Kanawha & Hocking and Sunday Creek Coal Companies, and Dan R. Hanna, son of Senator Hanna, reached Columbus from Charleston, W. Va., late this afternoon, and was transferred to the Big Four and taken to Cleveland. Dan R. Hanna stopped here an hour with John Winder and spent the time at his office in this city.

Winder, when seen by the Associated Press representative about the story of assaults on Representative Caldwell at Charleston Saturday morning, said that the entire story was a falsehood, and that none of his party was connected with it whatever. "We did not even see Caldwell," he stated. He stated that he had stopped in Charleston over night and came on to Columbus this morning.

Dan Hanna was also interviewed. He told practically the same story as did Winder. He stated that W. A. Clark, Jr., was not in the party, and denied that he even knew the man. As to Caldwell, he stated that he never saw him at Charleston or anywhere else. "The entire story is a party mix-up with another," said Hanna. "As far as the assault goes, I know nothing about it."

Mr. Hanna and a party of two or three left Winder's office shortly before 12 o'clock, and started for Cleveland a few minutes later.

Senator Clark's son was not with them at Charleston.

Young Clark Is in Butte.

BUTTE, Mont., Feb. 14.—W. A. Clark, Jr., son of Senator Clark, who was reported to have been connected with the alleged assault upon Hon. W. G. Caldwell at Charleston, S. C., is in Butte at present. Mr. Clark was greatly surprised that his name should have been connected with the affair.

To Abandon an Arizona Fort.

DENVER, Feb. 14.—An order has been received at Army headquarters in this city from the War Department for the abandonment of Fort Grant, in Arizona. The four troops of the Fourteenth Cavalry, stationed there, will be sent to Huachuca, Ariz., and that post will be the headquarters of the regiment. The abandonment was recommended by the Army Board upon the report of General Frederick Funston, because the fort has not a proper water supply.

Liberal College to Leave Oregon.

KANSAS CITY, Mo., Feb. 14.—Plans have been completed for the opening here of Liberal University, which some time ago purchased the Pepper building, a large estate in this city, for the purpose of removing the university from Silverton, Or. The college will be in charge of Thaddeus B. Wakeman, formerly of New York, and a personal friend of Colonel R. G. Ingersoll. Lectures will be begun this Spring and the regular classes will be instituted next fall.

The Boys' and Girls' Aid Society appropriation is increased from \$2000 to \$2800, with the promise that the society shall receive no aid from the state under any other act. The Florence Crittenton Home will receive \$2000 instead of \$5000 as two years ago.
