HURRICANE AT SEA

Perilous Experience of the China Liner Indravelli.

TWO DAYS OF ROUGH WEATHER

Decks Swept by Continuous Sens, Boats Smashed and Cabins Flooded-No Loss of Life-Ship Brings Heavy Cargo.

The Portland & Asiatic liner Indravelli, Captain Craven, has arrived after the roughest possenge of any steamer of the company since the line was started. For days she was virtually at the mercy of the elements and though she was somewhat battered up, she came though at without any loss of life. Two days out from Yokahama the steamer ran into a hurricane that made progress almost im-

The storm really began on Sunday, February 8, when the Indravelli encountered a fresh gale. This swelled to whole-gale ortions on the following morning. A sea mountain-high was running and im-mense quantities of water were shipped. Time and again huge waves swept the ship's deck fore and att. From 4 o'clock in the morning until noon the fury of the gale did not abate a particle. The steamer lurched and isbored heavily, at times under the foaming sea, again with her stern high out of the water and the enern nigh out of the wave and the cave to, but this could not be accomished without putting the ship in the rough of the sea. The waves dashed in so port lifebonts, stove in the side ports and flooded the cabins. As it was impossible to keep steerage way, oil was used to some advantage. During the afternoon the gale continued, but by night the weather had moderated eligibily. Tuesmorning opened with the wind fresh strong and gradually lessening in ce. Tuesday afternoon they had fine

With all the damage done, there were no serious casualties. Several sailors were knocked down and bruised by the seas that tore along the decke and the 14 Jap-anese and rour Chinese passengers in

anese and rour Chinese passengers in the steerage were made deathly seasick.

The indravelli's round trip was made in 29 days. She sailed out from Astoria December 16 and on the way across en-countered adverse winds, high seas and frequent gales. The 189th meridian was crossed December 21 and the ship reached Yokohama January 2, where she met the Indrasamha. Leaving Yokohama four days later the steamer arrived at Kohe days later the steamer arrived at Kobe on the 8th, making a two days' stay in that port. Moji was reached on the lith, and sailing the following day the steamer arrived at Hong Kong on January 17. The last of her west-bound cargo was dis-charged, the eastbound freight taken aboard and on January 25 the return trip

began.

Out from Hong Kong the Indravelli got into a strong northeast monsoon, with fog for two days and a high boad sea. She arrived at Moji February I. sailed on the 2d, reached Kobe on the 3d, sailed on the lith and arrived at Yokohama the next day, where she found the Indrapura in in part. Leaving out from Yokohama on the 7th the steamer two days jater had a 7th the steamer two days later had a spell of the hurricane weather that made things interesting. The Columbia River Hightship came into sight late in the af-ternoon of the 28th and at 9 o'clock the following morning the steamer crossed in. She left up from Astoria at noon Friday and anchored for the night down the river, reaching Alaska dock at 8 o'clock

yesterday morning.

The Indravelli brings a large cargo, most of which is matting. The hatches were opened soon after her arrival and by nightfall good progress had been made in the work of discharging her.
