

RAID ON DUES

Chief Hunt Cleans Up the North End

WITH ONE SUDDEN SWOOP

He Gathers in Thirty-Nine of the Disorderly.

ONE SOUTH END DEN INCLUDED

Whole Night Police Force Put on Duty and City Jail Swarms With Women of the Underworld—What is the Meaning of It?

A dipnet stirred up the murky waters of the North End last night. It wasn't a drag-net, for either the meshes were large or the net not of sufficient size to catch all the lawbreakers, for the scoops merely ruffled a portion of the pond.

As a result of a systematic raid, 39 women of the red light district were caught in the net. Eight joints of notorious character were raided in the North End, and then with a far swing the net dipped away, down in South End, to a saloon reputed to be as bad as any beyond the line, and gathered in five women from the Star Cafe, on First street, near Sherman.

Without a word of warning, without a "bunch" of any kind, 39 policemen, acting under the orders of Chief Hunt, descended upon the unwary divekeepers and, heading the captives like sheep, crowded the police station, and the female quarters upstairs to suffocation. Though many attempts were made by the keepers of the women to bail them out, this a good Saturday night's trade might not be utterly ruined, they were turned down, and the entire band must wait until tomorrow, unless an order goes forth and bail will be accepted.

Whole Night Force on Duty.
The entire second night relief of patrolmen were brought into service that the raid might be accomplished. Instead of reporting on duty at 12:30, according to custom, the members of the second relief were ordered to be ready for business at 9 o'clock. Not a whisper of the Chief's intentions had gone forth, and the patrolmen were as surprised as the divekeepers as to the reason for their enforced early hour.

Just at 9 o'clock Captain Bailey, who as captain of the second relief, had been called into command three hours sooner than usual, was called into the private room of Chief Hunt. There a general order was issued and Captain Bailey placed in command of his men. Then the patrolmen were called into the room by fours and instructed in their duty for the night's work.

Marching out by fours into the quietness of the evening, soon after 9 o'clock, they went straight to work. Four went to First street and rounded up the women in the rooms of the Star Cafe. The other squads dropped into the selected dives of the North end and without a word of explanation drove forth the black-lashed damsels who were primping themselves to catch the eye of the sailors and farmers on pleasure bent.

Fourth Street is Exempt.
But the net as it scooped did not touch Fourth street. Where the red lights burn the brightest the damsels sang, danced and conducted themselves as they pleased without the fear of a raid. Third street suffered, the most, while Second street at one corner was wrapped in mourning.

The saloons which were raided were: The Owl, on Third between Burnside and Couch; Pulliam's place, between Burnside and St. Paul, in the same block; the Majestic, on Third, near Couch; the Cosmopolitan, at Third and Davis streets, under the Paris House; the Regent and Henry Ray's place, at Second and Couch; the Titmouse, on Couch between Third and Second, and the Senate, owned by "Livestock" at Second and Davis. In addition, the Star Cafe, on First street, near Sherman, was forced to disgorge five women. The women who were taken from Lou's place are managed by Frank May, the former owner of the saloon, whose license was revoked. The others were directly connected with the saloons. On Second street the officers went into the upper story. Here a Chinese and a negro were found, and also arrested. At the other places only the ground floor was searched. At the Majestic more than half of the women were upstairs and escaped.

No resistance was offered by the divekeepers. Some wanted an explanation, but they remembered Captain Bailey, who not so very long ago was a patrolman on that beat, so they refrained from pressing the delicate matter.

Strange Crowd at Jail.
Hardly ever in the history of the police station has the like of the assemblage last night been witnessed. Conveyed by the watchful officers, the women arrived by the dozens. They were placed in the detective's room, and here Chief Hunt interviewed them in a body and took their names, or such as they were pleased to give him. Names in the high society of the North End change with every new moon.

Some of the captives were giggling, some chewed gum, some looked mighty glum indeed, but all went through the same mill of examination.

Then by the half dozen they were taken into the elevator, and Police Matron Summons found her hands full. Where all the 39 women could be placed for sleeping was a mystery to the matrons. Officers of the force, and the reporter was not allowed to break into the cloister on the upper floor.

Attracted by the excitement, a hundred odd men gathered around the doors and gave the officers much trouble in keeping the way clear. One man, said to be a real estate dealer, got into an altercation with Officer Price by refusing to move on. He was promptly arrested, but released on his own recognizance by Chief Hunt.

While the bewopement and often profane women were being brought by the dozens into the station, a little girl not more than 14 years old was escorted in by Officer Blower, who found her leaving the Astoria train with no fare to meet her. Apparently she is a runaway, but stoutly refused to give her name, and in the press of business and wondering at the crowd of brazen women passing before the counter.

Chief Calls Them Vagrants.
The North End doesn't know quite what to think of the raid. Naturally there is a mighty howl because "that place down there, lots worse than mine," wasn't raided too. But from the rumors that are flying about the station, the other places may soon see a squad of policemen when least expected. Some say it is a grandstand play of Chief Hunt. Others take a more serious view of the situation. They are afraid that the powers that be in many places, moved to action by the complaints given publicity, have been forced to inaugurate a clean-up epoch. August

not generally accepted as housecleaning time, but a part of the North End got an application of the scrubbing brush last night which it will remember for some time to come.

"I noticed that none of the places on Fourth street were touched," suggested a reporter to Chief Hunt after the curtain had been rung down on the matinee performance.

"There is no policy about this at all," replied the Chief. "These people have been arrested as vagrants. They are an undesirable class of people. I do not care to discuss why Fourth street was not touched."

"All these women came from dance halls, didn't they, Chief?" asked the inquisitive man.

"There have been no dance halls in Portland since I have been Chief of Police," firmly answered the man who ordered the raid.

"Have you ever seen any dancing going on?" he asked directly of the reporter.

"Yes, sir, in the Favorite saloon, a month ago."

"That wasn't a dance hall, they were only waiting. That's a mighty different proposition," said the Chief, and there were none to say him nay.

SUES THE POLICEMAN.

Ryan Claims Damages for Being Shot While Fleeing.

Patrolman F. W. Hemsworth, who shot Thomas Ryan, an ex-convict, because he tried to escape from arrest in a Chinese opium joint, has been sued by Ryan in the State Circuit Court for \$1000 damages. The papers were served on Hemsworth yesterday by a Deputy Sheriff. The complaint recites that the officer shot Ryan with a revolver recently, inflicting a severe wound, which made Ryan sick, sore and lame.

Officer Hemsworth and Jailer Hogboon, early one morning of this month, raided a Chinese opium joint at 82 Second street. They arrested several persons, including Ryan. On reaching the street entrance of the building, Ryan started to run. Hemsworth commanded him to stop, and when he did not do so, shot at him twice with his revolver. The second shot took effect in the man's left leg.

The Oregonian, two weeks ago, published numerous editions of higher courts to the effect that a person who is trying to escape arrest for a misdemeanor; nor in the case of a felony, except where the shooting is absolutely necessary. The officer is liable for damages if he violates the law in this respect. The decisions of the courts on this subject are almost unanimous.

HAD TO PAY LIENS ON HOUSE.

Mrs. Ausplund Sues Contractor and Bond Company for Amount.

Oneida Ausplund has sued the Astoria Indemnity Company, W. J. Clemens, agent, and J. W. Higgins to recover \$250 on account of liens which she was compelled to pay on a house. The complaint filed in the State Circuit Court yesterday recites that Mrs. Ausplund in June last let a contract to Higgins to build her a two-story dwelling-house in Hawthorne street. Higgins secured her against liens or other damage by a bond for \$250 in the Astoria company. In October following she notified the company that Higgins had failed to pay for certain materials as agreed, and as a consequence the company took the contract off his hands, and completed the structure. The Astoria Indemnity company, so Mrs. Ausplund avers, sold the house to J. J. Bracken, and the City Retail Lumber Company to file liens on the house, and to prosecute suits against her, and she was forced to liquidate the same amounting to \$250. She wants this sum, and also the costs of the Indemnity company.

HOME FOR INDIGENT MINISTERS.

Mrs. Webb Bequeaths Site in University Park to Methodist Church.

The will of Mrs. H. P. Webb, deceased, was admitted to probate in the County Court yesterday. She bequeathed three lots in University Park for a home for indigent Methodist ministers and their wives or widows, if the Methodist Conference decides to build such a home, otherwise the property is to go to the Conference claimants. Ground in Jefferson township, Knox County, Ohio, is given for a Methodist Church. Lots in Alden Addition and Portsmouth Villa are devised to various relatives. The estate is valued at \$200.

New Companies Incorporated.

Incorporation articles of the American District Telegraph Company were filed in the County Clerk's office yesterday by George H. Parsons, William Dunsmuir and James E. Kippel, capital stock \$25,000. The objects announced are to construct and operate lines of telegraph for general business and for police, fire and burglar alarm and messenger business, to operate a system of night watch signals, and furnish night watchmen for all purposes.

Articles of incorporation of the Gold Placer and Dredging Company were filed yesterday by J. W. Wilderman, John T. Grayson and Thomas K. Muir, capital stock, \$100,000. The objects are to operate mines, etc.

Winfield S. Sterling, Edward B. Sterling and John K. Kollock filed articles of incorporation of the Sterling-Tall Sheep Company in the County Clerk's office yesterday; capital stock, \$1000. The purpose is to own, hold and breed sheep on public ranges.

Because He Was Cruel and Stingy.

Clara Beckman wants a divorce from John Beckman, on the ground of cruelty and inhuman treatment, and she has commenced suit against him in the State Circuit Court. Away back in 1881, at their home, then in Sweden, she alleges that John struck her with his fists, and did the same thing at Reims, Ill. In the year 1885, in 1887, after they had moved to Portland, Mrs. Beckman avers that her husband not only struck her several times, but also beat her mother, Hanna Kind. Various other acts of the same kind are alleged. Beckman is further charged by his wife with having provided for her and the children in a stinted and miserly manner, in which she might accumulate money. She asserts that she was compelled to leave him. There are three children, Henry, aged 15; Edith, 14, and Clarence, 14, of whom she seeks the legal custody.

GENERAL PENROSE IS DEAD

Well-Known Retired Army Officer Is Stricken by Typhoid Fever.

SALT LAKE, Utah, Aug. 29.—Brigadier-General William H. Penrose, U. S. A., retired, died of typhoid fever at his home in this city tonight. General Penrose was commissioned in Michigan as Second Lieutenant in the regular Army in 1861, became Colonel of the Fifteenth New Jersey Volunteer Infantry in 1863, and at the close of the war was a Brigadier-General of Volunteers. He re-entered the regular service in 1868, and was retired as Colonel of the Sixteenth in 1868.

Two sons survive him—Major George H. Penrose, of Fort Townsend, Wash., and Captain C. W. Penrose, of Fort Brady, Mich.

South Pole Expedition Heard From.

BERLIN, Aug. 29.—The German South Pole expedition, which sailed from Kiel on the steamship Gauss August 12, 1891, has arrived at the island of St. Helena. In an article published in the Messager des Eclaircissements, Professor Siegel, of the University of Prague, asserts that the expedition has been a failure, and gives the public no further knowledge than it had before regarding the Antarctic regions.

NOT BOOTH'S AMBITION

NOT AFTER UNITED STATES DISTRICT ATTORNEYSHIP.

Lane Leader Is Not Seeking a Federal Position or Any Other Political Preferment.

HILLSBORO, Or., Aug. 29.—(Special.)—A warrant has been issued for the arrest of John Tom McNamara, a young fellow of about 22 years of age, charging him with the theft of two rings from Harvey Humphreys, a clerk in a meat market and feed store in this city. McNamara was seen to issue from the building while Humphreys was playing ball in the streets. The thief then took the rings to the local jeweler, who returned them to the owner. McNamara was drunk and it is supposed that he left for Portland. He is an old offender, having been in the Reform School as a boy, having served several times in the county jail for petty larceny, and having served a term in the state penitentiary for larceny. He is identified as having black eyes and red hair.

TO CONTROL SHINGLE OUTPUT.

Provincial Manufacturers Come to a Mutual Agreement.

VANCOUVER, B. C., Aug. 29.—The shingle manufacturers who are members of the British Columbia Lumber & Shingle Manufacturers' Association have reached an agreement among themselves relative to the allotment of the cut of Canadian shingles among the various mills. Each mill will be allowed to cut so many shingles daily on a basis arranged according to the capacity of the mill. For instance, if a mill has a capacity of 100,000 shingles, it will be reduced to cut in the ratio that the smaller mills are curtailed in production.

The scheme is satisfactory to all concerned, and will come into effect just as soon as the mills again commence cutting shingles for the Canadian market.

CLEVELAND IS HUMOROUS

Talks of Pleasures of Fishing, and Tells a Yarn of His New Boy.

NEW YORK, Aug. 29.—Ex-President Grover Cleveland has been making merry with the members and guests of the Old Colony Club at a clam bake on Marshall Island, says a Times special from Bourne, Mass. The feature of the day was a short, humorous address he made.

"I hope," said he, "that the club will persevere in its efforts toward the unrelenting preservation of the Buzzard's Bay fisheries, and I am willing to take out all the benefits of the club in fishing."

"Within the past few years I have been widely jeered and derided for spending much of my time at fishing. For those who jeer and deride me I have only a quiet and unqualified contempt. I am only fishing because I like it, and I hope that I will continue to go fishing until as near the end of my life as I can get."

"I should like to say right here that I am more interested in the protection of the fishing at Buzzard's Bay than about my own private interests. I care more for these fishing interests than I do about the policy of the next Federal administration."

"I hope that the Old Colony Club will keep up its fight for the protection of the fisheries. Let there be no relaxations nor compromise. Keep up the fight unceasingly."

"Perhaps some of you are aware that an interesting event has recently taken place in our domestic circle. I am proud to say that another future fisherman has quite lately increased the population of Buzzard's Bay by one."

"Now, some people are in the habit of telling fish stories and some people, notably a well-known physician of my acquaintance, are accustomed to weight their catch of fish on their own private scales. Although this happy event was not the occasion for telling any unusual yarns, I put my own scales into requisition and ascertained that my new private scale, the tally was an even nine pounds."

VATICAN FAVORS '04 FAIR

Official Invitation From America Will See Holy See Represented.

ROME, Aug. 29.—The negotiations regarding the Vatican's participation in the St. Louis Exposition, interrupted by the illness and death of Pope Leo XIII, have been resumed. Although the personal opinion of Pope Pius on the subject is not known, the Vatican officials think it will be favorable to the project of having the holy see represented, if officially invited by the United States Government by means of an invitation similar to those sent to the European powers.

Before Pope Leo died the wish was expressed to have the Pope's public presence exhibited at the Exposition. Like those of the late Queen Victoria, and it was proposed to send the same ship for both exhibits. King Edward himself is said to have proposed sending his mother's presents, but Pope Leo's health being at that time precarious, the Vatican authorities feared that if he died while the public gifts were away it might create an awkward situation.

Now the question arises whether, with the death of Pope Leo, these presents have not lost their interest, and whether something else would not be better. Many suggestions on the subject are made, and it is remarked that the Vatican library alone has precious works, unique in the world, besides documents of special interest to the United States, being connected with its history.

Toronto's Annual Exhibition Opens. TORONTO, Aug. 29.—Toronto's annual exhibition was opened today. The late Queen Victoria's jubilee presents, valued at \$2,000,000, and the Coldstream Guards Band, of England, are to be the main attractions. The presents will afterwards be shown at the St. Louis Exposition.

BOUND OVER FOR PEONAGE

Wentworth Alabama Man, His Son and an Officer Must Answer.

MONTGOMERY, Ala., Aug. 29.—The charge of peonage against Marion Priestwood, a wealthy turpentine dealer, has been heard before United States Commissioner Tutwiler, at Troy, Ala., with the result that the defendant, his son, who was the committing magistrate in the case, and Will Goodson, a tenant, who acted as Constable, were bound over to await the action of the Federal grand jury.

The evidence before the Commissioner alleges great abuse of the victim, Bob English, a white man, and his two sons, involving practically starvation and other hardships for a family of ten persons for many months.

FLOOD IS FALLING.

Kansas and Missouri Rivers Will Slowly Recede From Now On.

KANSAS CITY, Mo., Aug. 29.—The local Weather Bureau today predicted that the Kansas River would begin to fall slowly from now on, and that the Missouri, after rising about another foot, would be at a standstill. Kansas streams west of here continue to fall fast, and all danger of a rise that would wreck Kansas City's bridges seems to have passed. Men were put to work today on the James-street bridge, a portion of which was washed out yesterday for the second time. The Kansas River here has gone up an additional two feet and a half since yesterday, while the Missouri has risen two feet.

Lightning Fires a Courthouse.
