

TRUE TO RABBIT

Sweetheart of Chicago Youth at Jail.

WILLING TO WED HIM SOON

Affecting Meeting Between Criminal and Mother.

GRAND JURY TAKES UP CASE

All Four of the Outlaws Who Battled So Hard With the Officers Endicted on Several Counts—An Early Trial.

CHICAGO, Nov. 28.—Indictments were voted by the grand jury today against Harvey Van Dein, Peter Neidermeyer and Emil Roedel, the three young handies who were arrested yesterday. An indictment was also voted against Gustav Marx, who murdered Officer Quinn, and was with the others in the majority of their crimes.

Van Dein's mother called on him at the police station today. The meeting was affecting.

"We've got mothers like other people, haven't we, Pete?" was what Van Dein said to Neidermeyer last night. This morning Van Dein's mother read the re- mark in a newspaper and wasted no time in going to her boy.

Mrs. Van Dein said: "You have sinned, Harvey, and you must suffer. But remember you are not beyond redemption, and your mother is suffering with you."

For a few seconds the prisoner sat as if dazed. Then he caught sight of a smaller and more girlish figure standing beside his mother, and he arose and walked toward the door of his cell. Mrs. Van Dein, speaking between her sobs, said:

Sweetheart Comes Up.

"Oh, my son, my son." She put her arms through the bars and put her hands upon the prisoner's shoulders. Then Mamie Dunne, Van Dein's sweetheart, stepped forward and shook hands with the prisoner. At this point Van Dein displayed his first sign of emotion.

Mrs. Van Dein again put her arms through the bars toward her son. Inspector Lavin, who had been warned that an attempt might be made to pass firearms to the prisoner, caught the grief-stricken mother by the shoulders and gently drew her back.

"We will come again, Harvey," said Mrs. Van Dein, as she left the cell-room. A moment later, when questioned by the police, the prisoner resumed his usual indifference.

It was said today that Miss Dunne is willing to marry Van Dein before he stands trial.

That another murder was planned by Van Dein, Roedel and Neidermeyer appears evident from the confession of one of the trio, Roedel, none other than himself being selected as the possible victim. In his confession Roedel says he was the driver of the car in which the three last few weeks have been held by Neidermeyer and Van Dein were ready to "get rid of him," as he expressed it.

"I never got much," he said. "They used to buy me something to eat and give me a few nickels once in a while. They afterward got 'sore on me because they thought I might give them away. Marx told me that Neidermeyer and Van Dein were going to 'do me up.'"

Marx is the man whose confession led to the capture of his companions yesterday.

"Van Dein and Neidermeyer knew that I was the only one who could implicate them in the car-burns," continued Roedel, "and they hanged for my life. They would have killed me yesterday, even when all of us faced death. If there had been an opportunity, but I knew it and watched them. I had to protect myself against their murderous designs as well as the men who tracked us."

"Not long ago Van Dein struck me into the woods somewhere in Indiana. He pretended he was searching for dynamite that was buried; but I knew he wanted to kill me. When I thought he was ready to do the job, I covered him, and he made a move I would shoot him on the spot."

"I don't know just how I escaped from that bloody mob yesterday. When I try to think of the details of the chase my mind wanders. It is like a dream."

Detective Driscoll, who was shot in the stomach by Neidermeyer, is still alive.

Grand Jury Indictments.

The grand jury voted indictments charging Roedel with complicity in five murders, against Neidermeyer for four murders, and against Marx for four murders. Roedel will stand trial for one murder.

The following are the crimes for which indictments were voted by the jury:

Van Dein, Roedel and Marx, for the murder of Otto Baender, July 3. Neidermeyer, Van Dein and Marx for the murder of Frank W. Stewart during the car-burn robbery, August 30. Van Dein, Neidermeyer and Marx for the murder of John B. Johnson, at the barns at the time Stewart was slain; Marx for the murder of Detective John Quinn, November 21.

Van Dein and Neidermeyer for the murder of Adolph Johnson, August 1, at North One Hundred and Seventy-eighth and West Ninth avenue in the saloon of E. C. Legros, also the murder of Legros at the same time.

Ognizance cannot be taken in Illinois of the murder of Brakenham L. J. Sova in Indiana Friday, nor of the shooting of Detectives Driscoll and Zimmer in Indiana. It is the intention of State's Attorney Dineen to bring the men to trial as quickly as possible. It may take two trials, as all four of the men worked together, but it happened when the greater crimes were committed one of the number was absent. Roedel was not at the robbery of the car-burn, and had no part in the murders committed that time.

Marx was alone when he killed Officer Quinn, and was in jail yesterday when the murders were committed in Indiana. Either one of these two, therefore, will probably have a separate trial, unless a general plea of guilty is made by all four men.

MURDERER WHEN ONLY A BOY

Neidermeyer Shot Railroad Detective Who Tried to Put Him Off Train.

He ordered me from the train, and when I refused to get off he threw a coal at me. I threw back at him, and one of the jumps hit him on the head. Then he drew a revolver and fired twice at me. Both times he missed me, and then I drew my revolver. I fired six shots, and three of them hit him. I shot him in the head, in the abdomen and in the side. He ran a few feet and fell dead on top of the car. I searched him and found no money. Later the train crew came along, and I heard they found \$40 in his pockets. I was 'sore' when I learned what I had missed. I was only a boy then, but I did not intend to be run over by an officer, and when he tried to make me get off the train, I decided it would be my life or his. After shooting him, I got off the train and went from there to Winnipeg, and heard no more about the case.

Neidermeyer also admitted he was the leader of a gang that held up and robbed a Baltimore & Ohio passenger train near St. Louis, and committed two years ago. The robbery was committed near the spot where the three men were discovered yesterday by the police, and Neidermeyer said tonight that the daylight in which he and his companions were found yesterday was the exact spot where he and his partners in the train robbery had hid before holding up the train.

Yesterday when captured near Liverpool, Neidermeyer, speaking in a low tone to George Hamilton, one of the men to whom he had surrendered, asked him if he would give him a promise. Hamilton said he would, and Neidermeyer replied: "Well, if you will give me my mother one-half of the reward money that is hanging over my head, I will tell you where he is. Before he could talk further, the crowd pressed in close, and Neidermeyer refused to go on. Today Hamilton was in the city to give evidence against the three men before the grand jury, and Neidermeyer told of his part in the robbery of the train.

"None of these other boys was in that affair," he said. "I had a partner who since that time has been leading a decent life, and I'll never tell his name. We two were all there was to it."

DOES NOT FEEL HE IS AN EXILE

Captain Carter Contends He Has Been Much Sinned Against.

KANSAS CITY, Nov. 28.—The train bearing Oberlin M. Carter arrived in Kansas City at 6:30 this morning. The ex-officer and his little party immediately transferred to the regular eastbound Santa Fe train, which started for Chicago at 7:30. But little attention was paid to the party, which made every effort to avoid notice. Breakfast was eaten on that train as it left Kansas City.

During his wait, ex-Captain Carter talked interestingly of his future.

"Believing in your innocence, as you do, do you ever think of yourself as a sort of man without a country?"

"Not at all," replied Carter. "Why should I? Just because certain men have done me a terrible injustice, that is no reason for me to feel bitter toward my country."

"No, I have worked too hard for my country to feel bitter toward her. She has had the best years of my life. I never wronged her as poor Nolan did in the story, and I love her. It is curious," he went on to mention, "how some people seem to rejoice in pulling men down."

"As to my future," said Carter, "I really have no plans. I must wait first to vindicate myself before the American people."

"Will you consider your vindication complete unless you are restored to rank in the army?"

"Of course," Carter said in reply, "my vindication is not complete until I am restored to rank. But that's too far ahead, I can't talk about that, can't consider it at present."

"It is reported you have had an offer from the Holland government to go to the engineering work on the drainage of the Zuyder Zee."

"I have no offers under consideration," he said.

HIS DEPARTURE FROM PRISON

Ex-Captain Tells of Everything Save His Future Plans.

LEAVENWORTH, Kan., Nov. 28.—A few minutes before 4 o'clock this morning Oberlin M. Carter, ex-captain of engineers, walked out of the portals of the Federal prison at Fort Leavenworth, a free man.

At the gates he was met by his uncle, L. D. Carter, and immediately driven in a hack to the Union Depot in this city. The last movement was a ruse to throw the newspapers, whom he wished to see, off the track. At Union Station he was met by a representative of the Associated Press, and while Carter still refused to be interviewed as to his plans in the future, he said:

"I will catch the Missouri Pacific train out of here at 5:14 o'clock to Kansas City, and there, after breakfast, will take the fast Santa Fe train direct to Chicago. I will spend the day with my mother, who is over-anxious to see me."

While awaiting his train, the ex-army officer conversed freely on a large number of subjects, but always skillfully avoided the subject of any kind in regard to his conviction or his plans for the future. He spoke at length about the prison, but even then turned the talk from himself to generalities. In regard to himself he said:

"I am feeling as well as could be expected under the circumstances; deprived to an extent as I was, of exercise, I could not expect to be better situated."

It was thought last night that an officer of the Department of Justice might be at the prison gates to rearrest Carter on an old indictment, but such was not the case. When he decided to leave, the gates were thrown open to him and he passed out of the prison wall for the first time since he was brought into court during his attempt to escape a release by an act of habeas corpus. He was released just as he was on his arrival at the time of his incarceration.

Life of Mayor Threatened.

ST. LOUIS, N. Y., Nov. 28.—"I see that you are supposed to be a politician. Now, you countermand that appointment. You will never serve your term out. I swear before your election. You promised us, and we will see that you keep some of it."

This letter was received by Mayor-elect Alan C. Fobes from an anonymous writer. It has reference to the appointment of Public Works. There is considerable bitterness over the appointment on account of the fact that Thompson was dismissed by Mayor Kline for working against him in the primaries. Mr. Fobes has made no promises and laughs at the letter.

Shoots Boy Instead of Burglars.

CHICAGO, Nov. 28.—George Reynolds, the 17-year-old son of Captain Peter Reynolds, of the Chicago Police Department, was shot and killed early today by a bullet fired by John Wheeler, a photographer, who had shot at three burglars whom he had caught rifling his showcase at 1001 North Dearborn street. Reynolds struck Reynolds in the mouth, and he fell to the pavement unconscious. Wheeler did not know until after Reynolds had been found by the police and taken to the hospital that his bullets had found a mark. Reynolds died in the ambulance.

Carter Arrives in Chicago.

CHICAGO, Nov. 28.—Using every means to avoid notice, Oberlin M. Carter, once Captain of Engineers in the United States Army, arrived at Chicago tonight at 8:45 o'clock, and was at once driven to the home of his brother, Stanton Carter, 26 North State street. When the Santa Fe train bearing Mr. Carter drew into the Dearborn-street station, his brother and his attorney were there to meet him. Carter had a long talk with his brother, and at some later time he might make a statement.

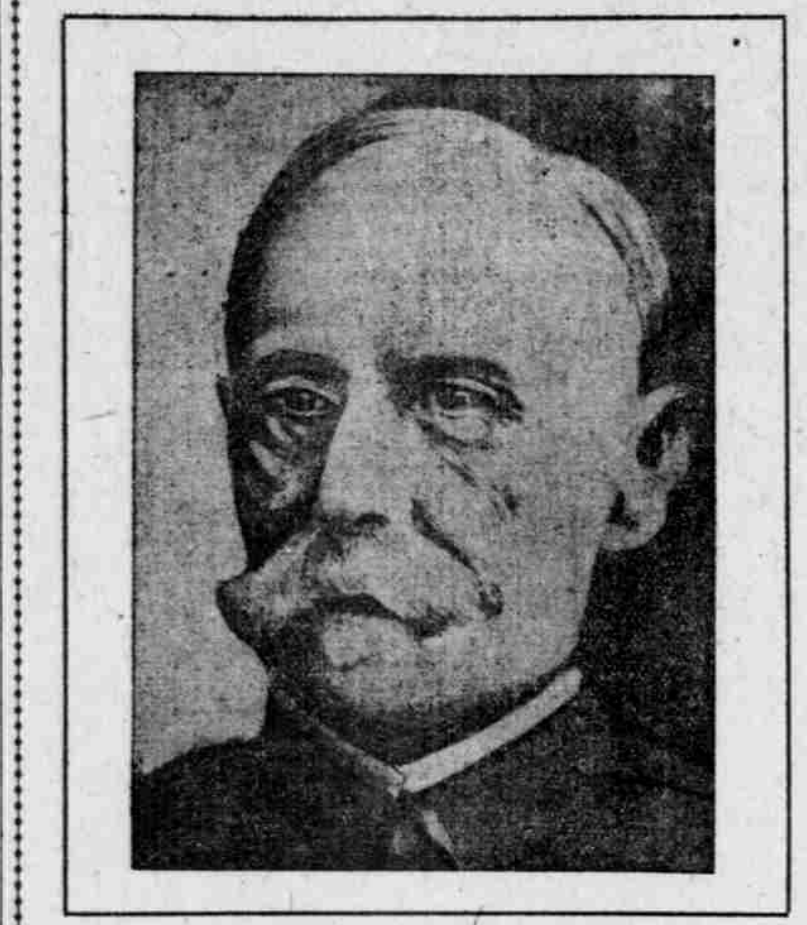

ABOUT TO RESIGN AS COMMANDER-IN-CHIEF OF THE BRITISH ARMY



LORD ROBERTS, WHO IS IN POOR HEALTH.

LONDON, Nov. 28.—Although no public announcement of the fact has yet been made, it is understood that Lord Roberts is about to resign as Commander-in-Chief. He has been much more ill than generally known, and the condition of his health requires him to spend the winter in a Southern climate.

The appointment of the Royal Commission to advise the government concerning the creation of a board for the administrative business of the War Office, and the consequent changes involved in generally regarded as foreshadowing the position largely ornamental, and Lord Roberts is understood to consider that his present ill-health offers an opportune excuse for his retirement, thus leaving the field clear for any changes which may be recommended for the King's approval by the commission.

From the terms of the reference to the commission it is quite evident that it was appointed to find a practical means of carrying into effect the recommendations of Lord Roberts, a member of the commission, who urged the abolition of the post of Commander-in-Chief and the appointment of a general officer to command the army, making him responsible to the Secretary for War for the efficiency of the military forces. Lord Roberts further recommended the establishment of advisory and executive boards, presided over by the Secretary for War on the lines of the Admiralty Board.

contract for her present American tour fixed on \$5000 a concert as her remuneration, and previous to each concert the money was to be shown to her or her legal representative in due form in the box office before she went on the stage.

Mme. Patti was seated in her apartment and received a message from her lawyer that the advance sale of seats had only brought in \$1800, so she refused to go to the theater. The local manager of the theater pleaded with Mme. Patti to stay. He told her it meant the disappointment of a great many people and an injury to the reputation of his house. But she would not budge.

Finally the owners of the theater were reached by telephone. They had already paid \$500 for a box at the concert, but rather than disappoint their patrons they promised to make up out of their own pockets the needed \$3200 to insure Mme. Patti's appearance, and she was so informed. Then she drove up from the hotel, reaching the theater only a quarter of an hour before the concert went on. It lasted about 30 minutes. As late comers contributed enough to balance the \$500 the owners had paid for their box, the performance cost them roughly \$2000, or something over \$2 a minute.

The scale of prices for the concert had been so arranged that the house would have lost \$10,000 if it had been entirely sold out.

Patti Summoned for Contempt.

NEW YORK, Nov. 28.—Justice Fitzgerald, of the Supreme Court, has issued an order commanding Mme. Adelina Patti, the singer, to appear in court and show cause why she should not be punished for contempt of court for having failed to obey a subpoena with which she was served about two weeks ago, ordering her to appear in the Supreme Court and explain her connection with the concert company incorporated for her farewell tour in America. Mme. Patti left town, and her default was noted when the case was called and she did not respond. At the time she pleaded that she did not understand the subpoena.

ALL FAVOR CLOSER RELATIONS

British and French Statesmen Speak at Banquet.

PARIS, Nov. 28.—The members of the British Parliament and their ladies who are now in France, went this afternoon to Versailles, where, after a flattering reception, they witnessed an interesting series of dances of the period of Louis XV, executed by members of the opera ballet corps. At the conclusion of the dances a luncheon was served at which a number of short speeches favoring closer relations between France and England were made. Delegate Miller, of Canada, in his remarks referred to the bonds uniting Canada and France. Especial importance is attached here to Mr. Miller's words because of the suggestion they contained that the British colonists might not accept the operation of the Anglo-French arbitration treaty in questions directly affecting the colonies.

Diplomatic Relations Desired.

BERLIN, Nov. 28.—M. Miletschewitz, the Russian Minister here, has requested the United States Ambassador to forward to Washington an autograph letter from King Peter to President Roosevelt, informing him of his accession to the throne.

Russians and Robbers Battle.

ST. PETERSBURG, Nov. 28.—Dispatches received here by a semi-official agency report that a collision between Russian troops and a band of Chuchchubs, the notorious robbers of Manchuria and Southern Siberia, has occurred at Tachichon, in which five Russians were killed and nine severely wounded. A report from Sienwenda says the troops of General Ma have appeared in that district and are plundering friendly Chinese villages.

Alleged Royal Folk Degenerates.

PARIS, Nov. 28.—The trial of the so-called Baron de Adolphe and Count de Warren, on the charge of immorality, which has been before the lower courts for a long time, reached the Superior Court today and attracted some attention.

VOTE TO END STRIKE

Northern Colorado Miners Accept Terms of Operators.

RETURN TO WORK MONDAY

Third Time the Proposition Had Been Balloted Upon—Counsel of President Mitchell is Finally Heeded.

LOUISVILLE, Colo., Nov. 28.—The miners of the Northern Colorado coal fields tonight voted to return to work on the terms granted by the operators, which embrace compliance with every demand made by the unions. This is the third vote taken on the proposition. The first vote rejected the proposition by a majority of 101. The second vote was heavily against it on account of the opposition of District President Howells and "Mother" Jones, although representatives of President Mitchell urged the acceptance of the proposition.

Today, it is said, telegrams were received from President Howells withdrawing his opposition and the men voted strongly in favor of resuming work. The mines have all been kept in good condition, and work will be started Monday. It is estimated that 1200 men will go to work, and that the capacity of the mines is 3000 tons a day.

Hearing of Miners Begun.

TELLURIDE, Colo., Nov. 28.—The preliminary examination of Secretary Carpenter and 11 other members of the local Miners' Union on charges of conspiring for the purpose of rioting and conspiracy to break the law, will begin today before Justice Warrington Robinson. The courtroom was crowded. Ex-Attorney-General Engley appeared for the accused, and Assistant District Attorney Howe presented the case for the state.

Eleven of the 12 union men were bound over to the District Court. Five were charged with misdemeanor and conspiracy to commit misdemeanor and the others only with conspiracy. The bond of the first five is fixed at \$1000 each and the others at \$750.

Leaders of Miners Are Confident.

TRINIDAD, Colo., Nov. 28.—Tonight ends the third week of the coal miners' strike in district 15, with no perceptible change in this (Las Animas) county, which produced more than twice as much coal as any county in the entire district prior to the strike.

The miners' officials reported tonight that they had the strike well in hand and were confident of victory.

The injunction case of the United Mine-workers against the Victor Fuel Company to restrain the latter from interfering with union men visiting any properties of the company ended today. Judge Lindsey dismissed the proceedings on grounds of lack of evidence.

Men Accept Reduction in Wages.

PITTSBURGH, Nov. 28.—The Deewee Wood plant at McKeesport will be placed in full operation the coming week. The men employed in the plant will have accepted a reduction of 30 per cent, and others will go back to work at smaller reductions, which take effect January 1. Over 2000 of the employees of the Denninger Tin Plate Works today agreed to accept a 20 per cent reduction and the plant will again start up Sunday night. The 600 employees of the Independent Tin Plate Plant, at Fortville, had accepted a 20-per cent reduction and that plant will resume Monday morning.

Men in Bullpen Secure Writ.

DENVER, Nov. 28.—A special to the Republican from Cripple Creek, Colo., says that J. H. Hagg, attorney for the Western Federation of Miners, to night secured writs of habeas corpus in the cases of Sherman Parker, Victor Pool, J. Kennison, W. D. Davis, W. B. Easterly and Patrick Mulligan, all union miners, now in the bullpen, supposed to have been arrested on suspicion of complicity in the blowing up of the Vinland mine, but against whom no charges have been made. The writs are returnable December 2.

More Blast-Furnaces Close.

PUEBLO, Colo., Nov. 28.—Tonight marked the closing down of the remaining blast-furnaces of the Miners' plan of the Colorado Fuel & Iron Company. But one blast furnace is left in operation, although there is a large force of men engaged in overhauling the various departments. The wire mill closed down tonight and the men were given to understand that there would be a resumption of that department soon after January 1. It is expected that when the works start again there will be a complete reorganization.

DECLINES TO MEET MINERS.

President of Utah Fuel Company Takes Strikers to Task.

SALT LAKE, Nov. 28.—Vice-President Kramer, of the Utah Fuel Company, has replied to Governor Wells' telegram of yesterday asking if he (Kramer) would meet a committee from the Miners' Union and endeavor to settle the coal miners' strike in Carbon County.

In his reply, Mr. Kramer positively declines to meet representatives of the United Mine-workers of America, on the ground that the present condition of affairs was brought about "for the sole purpose of aiding their organizers in stalling their union in its supremacy to the law, order, dignity and peace of the state, and the absolute exclusion from work of all employees of the Utah Fuel Company who would not join their union."

Mr. Kramer states that his company has at all times been willing to submit to the State Board of Arbitration any grievances that may exist between the employer and employee covering such questions as may properly come before the board.

Protests Against Russian Activity.

TOKIO, Nov. 28.—M. Oishi, former Minister of Commerce and Agriculture, who lately visited Manchuria, has vehemently protested in a public speech against the incessant increase of the Russian forces in the Far East. He declares it is necessary to suspend the negotiations and demand an instant stopping of reinforcements, and in the event of the refusal to resort to an appeal to arms.

Many Lives Lost in Storm.

BERLIN, Nov. 28.—It is estimated that 100 persons lost their lives in the recent storms on the North Sea. All vessels arriving in the Weiser and the Elbe report seeing much wreckage, and many corpses were picked up. The bodies, however, to pick up any of the bodies, owing to the high seas which were running.

Police Stop Anti-Austrian Riot.

ROME, Nov. 28.—A number of students here today attempted to make another anti-Austrian demonstration, but were easily prevented by the police from carrying out their plans, a steady rain helping the police to disperse the crowd.

Czarina Passes a Good Night.

SKIERNEWICE, Russian Poland, Nov. 28.—The bulletin concerning the condition of the Czarina, issued today, says: "Her Majesty passed a good night. The local inflammation is taking a normal course."

Russia Has Not Replied to Japan.

ST. PETERSBURG, Nov. 28.—Russia's reply to the Japanese proposals at Tokio has not yet been dispatched.

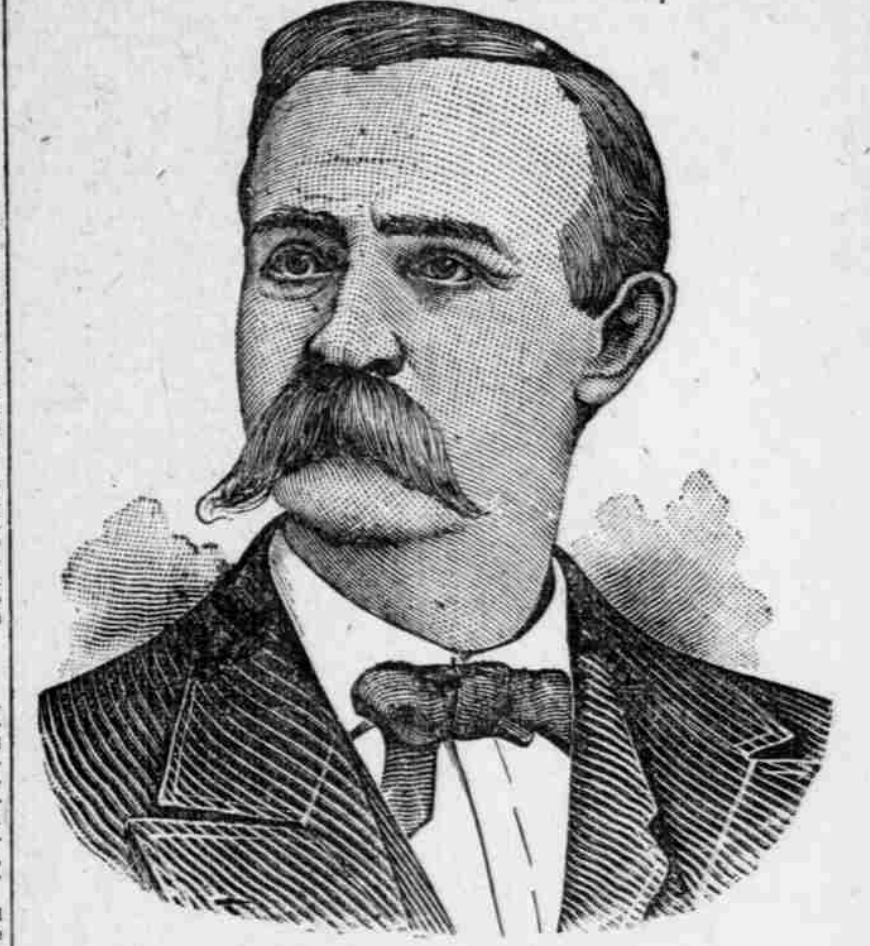

ESTATE OF RAILWAY MAGNATE

APPRAISED AT \$28,301,765.

Report Was Filed Several Months Ago, but Has Been Kept a Profound Secret.

NEW YORK, Nov. 28.—The appraisal of the estate of Collis P. Huntington, who died on August 13, 1900, shows he left a net real and personal estate in this state valued at \$28,301,765. The personal property amounted to \$35,504,585, from which are deducted the debts due by the estate, the expenses of administration and the executors' commissions.

This appraisal was directed by the Surrogate's Court. The executors appointed by Mr. Huntington will be his widow, Mrs. Arabella B. Huntington, Isaac E. Gages and Charles H. Tweed.

The beneficiaries under the will are: Mrs. Huntington, whose share amounts to \$15,000,000; Henry B. Huntington, a nephew of Mr. Huntington, who receives \$2,500,000; besides a contingent interest in a portion of the estate.

The report of the appraiser was filed many months ago, but was kept a profound secret until discovered today.

Deposed Executive Quits Land.

WASHINGTON, Nov. 28.—The State Department has received a cablegram from Minister Powell, at San Domingo, dated yesterday, stating that up to that time the provisional government had not accepted the resignation of the retiring President, Woe y Gil, with his Cabinet had sailed for San Juan on the German warship Falke.

Marine Guard Is Withdrawn.

WASHINGTON, Nov. 28.—Commander Meritt, of the gunboat Newport, has reported to the Navy Department under date of November 27, that Santo Domingo is quiet, and the marine guard has been withdrawn from the city so recently surrendered to the Dominican insurgents.

Police Wound Strikers.

BORDEAUX, France, Nov. 28.—The striking dock laborers made a demonstration in front of the town hall tonight. The police drew their swords and charged upon the rioters, wounding a number of them. Several of the officers also were wounded.

Santos-Dumont Coming to America.

PARIS, Nov. 28.—Santos-Dumont announced that on December 12 he will start for New York, where he will arrange for his participation in the aeronautic competition to be held at the St. Louis Exposition.
