

HENEY PRAISES JEROME'S WORK

Crusade Against the Corrupt
Members of the Bench
and the Bar.

WANTS IT IN HOME CITY

Favors Like Action in San Francisco,
Where a Few of the Judges,
He Declares, Are
Crooked.

United States District Attorney Francis J. Heney is taking the keenest interest in the crusade inaugurated by District Attorney Jerome, of New York, against corrupt members of the bench and bar of that city. While Mr. Heney never met Jerome personally, he is well acquainted with the latter's brother, being once associated with him in Arizona, and evidently holds the most profound admiration for the efforts of the District Attorney in purging the legal fraternity of some of its most undesirable members.

"In my opinion," said Mr. Heney last night, "what District Attorney Jerome is doing is the most important work now being performed in the United States, and it ought to be followed vigorously in every large city in the Union. To my mind, a corrupt judge is the most loathsome creature on earth, and unfortunately, under the present machine system of politics in all the large cities, more than a few dishonest men secure these positions, and my own home city, San Francisco, is no exception to the rule.

"Fortunately, a large majority of the judges are honest, there and elsewhere. The few corrupt ones do an incalculable amount of harm. President Roosevelt, in an address to the students of Harvard College a few days ago, called attention to the fact that 'many of the most influential and highly remunerated members of the bar in every center of wealth make their especial task to work out bold and ingenious schemes by which their wealthy clients, individual or corporate, can evade the laws which are made to regulate, in the interest of the public, the use of great wealth.

"The pernicious example set by lawyers," continued Mr. Heney, "has a demoralizing effect upon members of the bar engaged in less remunerative practice, who are thus tempted to adopt equally or greater reprehensible methods to win lawsuits.

"Perjury has become the most common crime in the calendar, and all lawyers know that it rarely happens that a case, either civil or criminal, is tried without some perjury being committed on one side or the other, and much of this perjury is planned and suggested, either directly or indirectly, by the attorney.

"Exposure and conviction of a few of the attorneys who enjoy remunerative business will have a wholesome effect upon the bar in that vicinity at least, and will tend to elevate the moral standard of both the bench and bar, and this would in turn become a great check upon 'raff' generally."

SELIGMAN MEN ARE DUE

COMING TO PORTLAND TO LOOK
INTO THEIR PROPERTY.

Will Go Into Other Features Than
Those Upon Which Street Rail-
way Was Bought.

Tomorrow two representatives of the Seligman interests will arrive in Portland to begin a second and very important examination of the Portland Consolidated Railway Company, recently acquired from its former owners. When the purchase was about to be made engineers were sent, together with financiers, who made a careful examination into the present condition of the property. So favorable was their report that the pending negotiations were speedily closed. The representatives who will make this second examination will go into other features than the physical aspects of the property, its earning power, present traffic and how that may be increased, and will formulate the policies that will to a large extent be adopted in the future conduct of the property. Frank Brown, of Philadelphia, has been in Portland for some time as the representative of the new owners, and it is understood that the work of the men to arrive tomorrow will be under his direction.

F. I. Fuller, general manager, will probably remain in that position, but all other official places will soon be occupied by new men. At the time the deal was consummated for the purchase it was with the understanding, voluntarily made on the part of the old officials, that resignations of any or all officers would be forthcoming whenever desired by the new owners, and that the old officers wished to be relieved from duty at no distant date. Formal resignations have not since been handed in, because not requested, but it is understood that President A. L. Mills, Vice-President and Superintendent Charles F. Swigert and the secretary, Miss May Swigert, have requested that their services be terminated not later than September 1, and that the new owners are making arrangements for transfers to new officials at about that date.

All is in readiness, or nearly so, for construction of the new line from the end of Union avenue to the Columbia River, which will be the future route of the Vancouver cars, and on the work already announced also as projected on the Albina line. This work will be prosecuted vigorously to completion, if possible, before winter weather sets in.

BEAN IS INDORSED

Prominent Lawyers Urge His
Appointment.

TELEGRAPH THE PRESIDENT

Message Is Also Sent to the Attor-
ney - General Recommending
Oregon Supreme Justice
for Judgeship.

R. S. Bean, of the Supreme Court of Oregon, is the choice of many of the bar of Multnomah County for appointment to the vacancy existing upon the bench of the United States District Court. He has been recommended as the man for the place by telegrams sent the President and the Attorney-General, which messages have been signed by one or more members of every prominent law firm in Portland, at least 100 in all. One telegram was sent to President Roosevelt Friday afternoon, and another to Attorney-General Moody yesterday morning, both urging the appointment of Judge Bean in the strongest terms.

For sometime the bar of the state has felt that if it were to be heard in any recommendation made to the President and the Department of Justice in relation to the Federal Judgeship, it would be necessary for the rank and file to agree upon some man of unimpeachable character and reputation and learned in the law, who should be its choice.

There are four men in Multnomah County who would be acceptable to the bar of the county, but each man has friends who are steadfast, and who would not allow themselves to swing into line for the other candidate. These acceptable lawyers are Judges M. C. George, J. B. Cleland, A. F. Sears and Henry E. McGinn.

After a great deal of discussion, as it is understood, it was decided to go outside the county family in search of a man of broad understanding under whose banner all could assemble in common cause. All three members of the Supreme Court were acceptable, but Justice Wolverton and Moore united in the support of their associate upon the bench, and it was decided to join in endorsing Judge Bean for the place.

The telegrams sent to the President and to the Attorney-General, so it is understood, dwell upon the career and the capability of Judge Bean as making him an ideal man for the position. It is pointed out that he has been first a lawyer of ability before the bar, then a trial judge whose conduct in court has won him recognition with the bar of the state for fairness and sound decision, and last as an appellate judge whose opinions have taken high rank with those of other jurists and have gained him distinction as a man of deep legal learning and one firmly grounded in the principles of the law.

The reputation of the applicant in private life is pointed out in the recommendations sent the department, his name for good citizenship and dignity of bearing being held as grounds in his favor. It is argued that he is a man adapted by inclination acceptably to fill a position upon the Federal bench, and qualified by experience to discharge the duties devolving upon him with calmness, fairness and fearlessness, having no favorites and expecting no favor.

The attorneys of this city who have commenced the movement in favor of Judge Bean are confident that their recommendation will meet with favor throughout the state, and that all sections will join in naming Judge Bean as the unanimous choice of the bar of the state for the office to be filled.

RANCHER STRUCK BY CAR

MAY LOSE HIS MIND AS RESULT OF
ACCIDENT.

Received injuries at Sixteenth and
Overton Street While on
Way to Fair.

As a result of injuries received in a street car accident at 10:20 o'clock last night, James Crook, aged 40 years, a rancher from Roche Harbor, San Juan Island, may lose his reason. Crook is at present in the Good Samaritan Hospital, where everything possible is being done for him by the attendants.

At the time of the accident Crook was riding on a Sixteenth-street car toward the Exposition grounds. The car was crowded and he was standing on the inner running-board. At Sixteenth and Overton streets the car upon which Crook was riding was passed by another car traveling in the opposite direction. Crook was leaning out from the car, and was struck and hurled to the ground with great force.

Both cars were immediately stopped and the police notified of the accident. Crook was carried to the sidewalk by a street-car employee, and then the two cars continued on their way. When the police arrived the number of either car or the names of the motormen and conductors could not be learned. Crook was struck on the side of the head, and was injured so badly that he was out of his mind when the police arrived at the scene. He asked repeatedly how the accident happened and wanted to know what city he was in. His condition was pitiable. Blood was flowing from his nose and mouth when he was carried from the street, all indications being that he had been struck a terrific blow. In addition to the wounds on his head, Crook sustained a severe sprain of the right arm and complained of pains in his back. He was removed by the police to the Good Samaritan Hospital, where his injuries were dressed.
