

MAINTAINING WAR ON DISEASE

Roosevelt Applauds Scientists Who Battle With the White Plague.

KOCH'S THEORY REJECTED

Tuberculosis Congress Recognizes Disease May Be Conveyed From Cattle to Man—Women's and Child Labor Condemned.

WASHINGTON, Oct. 3.—"I feel that no gathering could take place fraught with greater hope for the welfare of the people at large than this assembly."

This was President Roosevelt's parting words to the delegates to the sixth triennial international congress on tuberculosis, which finally adjourned today in Rome, Italy.

The President thanked the delegates for what they had done and were doing to stamp out the great white plague.

Heroes Among Doctors. "You have come here," said the President, "to combat with the whole, the most terrible scourge of all diseases in the world. The chance of all control that disease lies in the work of just such men as those who are assembled here."

The President declared that medical scientists have shown as much heroism in the fight against tuberculosis as ever was shown by a soldier on the field of battle.

Oppose Female and Child Labor. The congress also endorsed legislation for the regulation of factories and workshops, the abolition of child labor, and the securing of sanitary dwellings to increase the resisting power of a community against tuberculosis and other diseases.

The delegates evinced keen interest in a report by the congress by Dr. J. Stafford concerning tuberculosis in Ireland. Dr. Stafford asserted that in Ireland the problem of wiping out tuberculosis was left in the hands of local authorities designated by Parliament with delegated powers.
