PATRONAGE SOON WILL RAISE ISSUE

Shall Oregon Congressmen Have Voice in All Appointments?

BOURNE CHANGES HIS TACK

After Sharing in Choice of Postmasters Which Belong to Representatives, He Would Absorb Other Federal Pie.

OREGONIAN NEWS BUREAU, Washingion, April 24.—Just how Federal patronage is to be dispensed in Oregon is as yet an open question; under the new Administration there have been no appointments which would give a clew as to the intentions of President Taft. Whether the Congressmen are to be

as to the intentions of President Taft. Whether the Congressmen are to be consulted about other than Postoffice appointments or whether Senator Bourne shall have exclusive say in the filling of Federal offices in Oregon is not yet known. Nor is it known whether the President intends to consult other Republican leaders in the state. The Judgeship has no bearing on this question, for in naming Federal Judges the President is ignoring political indorsements and selecting only such men as, in his opinion, are qualified to sit upon the bench. That is his general rule, applied in Oregon as well. But probably at no distant day the President will be called upon to make various appointments in Oregon, and the nominations then made will indicate the purpose of Mr. Taft with respect to the control of "pap."

Bourne Rejects Own Plan.

During the last Congress, when there were four Republicans in the delegation, an attempt was made to control Federal patrenage in Oregon by majority vote of the delegation. Sometimes this rule worked of the delegation. Sometimes this rule worked, sometimes it did not. This plan was suggested by Mr. Bourne and he was the first to abrogats it. Likewise he is the only member of the present delegation who is unwilling to renew that majority arrangement.

In most states the Congressmen have absolute say in the selection of all Postmasters in their respective districts. Because the Senate had to confirm all Presidential Postmasters, Mr. Bourne, at the beginning of his career

Bourne, at the beginning of his career in Washington, instated that the Senators should have a say in their selection. So the Congressmen acquicased against their personal desires, and in return for this concession and at the insistence of Senator Fulton the House members were given a very at the insistence of Senator Fulton the House members were given a voice in the selection of all other Federal officials in Oregon. This was to even up the distribution.

Now Mr. Bourne, the sole Republican in the Senate from Oregon, is not favorable to the old plan of division, especially since his colleague, Senator Chamberlain, has repeatedly declared that he will take no part in the distribution of offices. Mr. Bourne is now willing that the Congression. is now willing that the Congressmen shall name the Postmasters, but he demands the right to select all other Federal appointees in Oregon and from Oregon. Inasmuch as a large number of the Presidential Postmasters appointed during the last two years were selected by Mr. Bourne and accepted Congressmen, Messrs, Ellis and Flawley are not inclined to agree to the Senator's latest proposition. They take the position that Mr. Bourne

the Senator's latest proposition. They take the position that Mr. Bourne named Positinasters whom they should have named, and now that he has had this concession, while they have had this concession, while they have had the opportunities of participating in the selection of other officials, they should not be cut off from all say in the appointment of general Federal officers in the state.

Neither Congressman has talked with the President about the policy he intends to pursue, and it is doubtful if the President himself has given the matter any consideration whatever. It is barely possible that, when the time comes, the President may decide to consult the entire delegation, or he may, as President Rossevelt sometimes did, consult the Republican organization in the state, in which even; the National Committeeman would be given a voice in selections. Mr. Bourne will undoubtedly resist any proposition which denies him the sole right to control the patronage of Oregon other than Postmasters, and is expected to object as vigorously to the participation of the National Committeeman as to the participation of the two Congressmen, for he is fully aware that Ralph Williams would rarely, if ever, indorse cambidates, from the Statement One camp, whereas he, personally, is anxious that only Statement One inen shall be appointed.

Taft Wil Indicate Policy.

When the new Federal Judge has been installed upon the bench developments are likely which will indicate the policy of the President towards the Oregon Congressional Delegation. Then it is that the President will appoint a new United States Marshal for Oregon, as well as deputy clerks and marshals authorized by the haw creating the new Judgeship. So far as known, no member of the delegation is interested in the reappointment of Marshal Reed; but up to the present moment no one has indicated any other candidate for this office. There is little likelihood that Mr. Bourne's candidate for the Marshalship will be acceptable to the Congressmen or to Mr. Williams. Therefore, it is expected that trouble will start when it is officially announced that the President is waiting for names for this office.

Before those appointments are made, the delegation will probably have an understanding with the President, and the decision then reached will probably continue in force throughout the Taft administration. When the new Federal Judge has

FIGHT HARRIMAN RULE

WESTERN TRAFFIC OFFICIALS ORGANIZE REVOLT.


