

HUGE IRRIGATION PROJECT STARTS

Nyssa, Snake, Owyhee and Malheur Valleys to Have Water in 3 Years.

SETTLERS SIGN CONTRACTS

Boise-Owyhee Irrigation Company Will Irrigate 200,000 Acres at Cost of About \$6,000,000 and Settlers Become Jubilant.

NYSSA, Or., June 5.—(Special).—The country surrounding the Nyssa, Owyhee, Snake and Malheur Valleys was assured of irrigation today by the signing of contracts by settlers with the Boise-Owyhee Irrigation Company...

For several weeks there has been contention whether it was best for the people to induce the Government to reclaim the service to irrigate the lands from the Malheur River or allow a private company to take water from the Owyhee River and store it in the immense reservoir of the Boise-Owyhee Irrigation Company.

The Boise corporation is composed of wealthy capitalists, backed by the Trowbridge & Niver Company, of Chicago. It submitted a proposition to irrigate this land for \$2 an acre, \$2 to be paid December 1 and no further payments due and no interest on deferred payments until the December following the season's use of water.

Then the work of signing the contracts began. Eugene F. Pratt, living 10 miles south of Nyssa, signed the first contract for 1200 acres. Others followed as fast as they could be taken care of and more than 20,000 acres was contracted for. Word was received from settlers not present representing as much more land, saying they would be bound by the action of the meeting.

Vice-President Speer, of the Trowbridge & Niver Company, in a short speech, announced that active work along the line would be in operation in 60 days, and the company would begin to deliver water to the lands of the Owyhee Valley next season and over the entire project in three years.

Many settlers have been on this land waiting for irrigation 20 years. Much enthusiasm prevails that water is assured and almost in sight. Tributary to Nyssa is over 1000 acres of land at an altitude of 2200 feet, perfectly adapted to all kinds of fruit. This will be cut into small farms. Nyssa is assured of the headquarters of the construction company as a supply point for work involving an expenditure of \$6,000,000 to \$7,000,000.

SMITH SERVES 11 YEARS

ANNOUNCES HE WILL NOT GO BACK TO PHILIPPINES.

Governor-General Says Conditions in Islands Are Good and Taft's Policy Works Wonders.

SEATTLE, Wash., June 5.—Coming in today on the Minnesota from the Philippines, James P. Smith, Governor-General of the Islands, announced he expected never to return there.

"When do I expect to return to the Philippines?" As a matter of fact, it is a question in my mind whether I ever return. I have been out there 11 years and I am beginning to believe I have served there long enough. Frankly, I do not expect to return.

"I went out with the California volunteers 11 years ago," said Mr. Smith. "After the war closed and the military government I served as collector of customs, being mustered out as a Brigadier-General. I became a Justice of the Supreme Court, then a member of the Commission and afterward Governor-General. I've had 11 years of active service in the islands and really, I wish I had never left the bench. I like that work and I am not anxious for the more strenuous occupation of governing any district."

The policy enacted by W. H. Taft, when he was Governor-General of the Philippines, has been pursued consistently and it has worked a marvelous change in conditions. Over here you magnify the talk of agitators who are insisting upon independence. As a matter of fact, the majority of the people in the islands are delighted with American rule.

Mr. Smith is on a six months' leave of absence, his official point being San Francisco, his old home. He will remain in Seattle until Monday night, when he will depart for California.

During his stay here he is the guest of local United States Army and Navy officers and the management of the Alaska-Yukon-Pacific Exposition. This morning the Governor-General's party was taken to the exposition and conducted over the grounds.

KALAMA HOME DESTROYED

U. P. MAKES PLANS

Expects to Run Into Seattle by July 1.

WILL RENT N. P. TRACKS

Negotiations Long Pending for Use of Line From Tacoma Tunnel to Seattle Tide Flats—Depot Construction Is Being Rushed.

SEATTLE, Wash., June 5.—(Special).—If plans of J. D. Farrell, vice-president and general manager of the Oregon & Washington, are as successful as he hopes, Union Pacific trains will be running into Seattle on July 1. While the deal for the purchase of a one-third interest in the Northern Pacific right of way between Vancouver and South Tacoma at the entrance to the Union Pacific tunnel was still pending, negotiations had been begun for the use of the Northern Pacific tracks from the latter point to the tide flats. As early as April an announcement was made it was quite likely the Union Pacific would rent the Northern Pacific tracks at Tacoma, pending the completion of its tunnel.

One of Mr. Farrell's purposes in visiting New York, besides the big deal, is to secure the use of the Northern Pacific tracks until the tunnel is finished. The announcement that the Union Pacific is asking for the right to erect a temporary passenger station on its South First-avenue freight terminals is thought significant by railroad men in connection with the application for the use of the tracks. There was such a hurry in making the application to the Board of Public Works that no plans could be submitted.

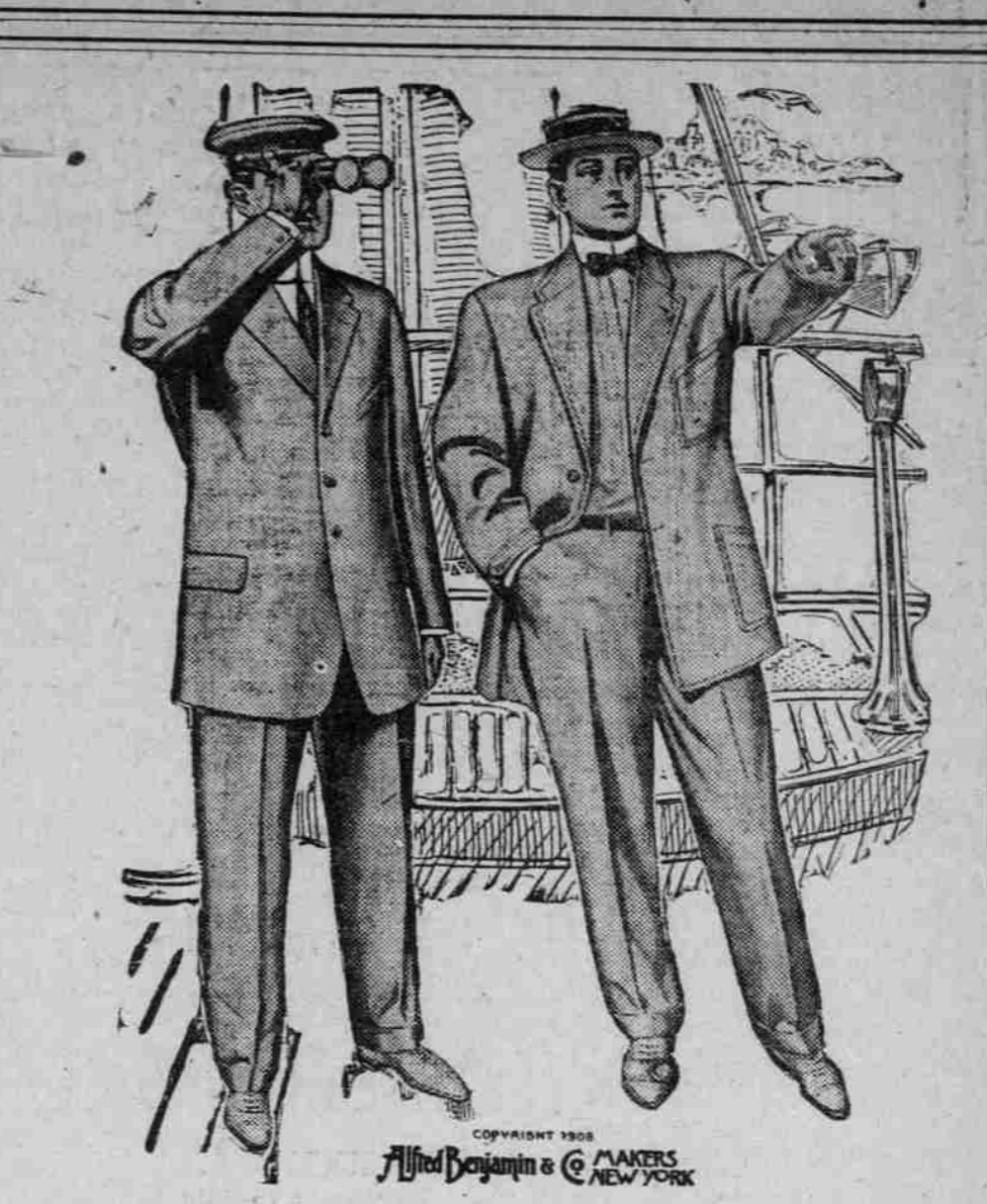
