

ORDER OUT FOR OPENING PAGEANT

Military and Fraternal Organizations Will Be in Line Tomorrow Night.

SEVEN DIVISIONS DETAILED

G. A. R., Third Oregon Infantry and Spanish War Veterans Will Parade With Secret Societies and Platoon of Portland Police.

Orders detailing the organization of the big military and fraternal parade of tomorrow night, marking the opening pageant of festival week, were issued yesterday by Brigadier-General William E. Finzer, grand marshal of the parade.

General Finzer divides the column into seven divisions, the leading divisions being composed of military and veteran organizations, including the Third Oregon Infantry, the Spanish-American War Veterans and the G. A. R. The orders, as given out from the festival headquarters last night, follow:

(d) The fourth on Yamhill, head of column facing east and resting on Tenth street.

(e) The fifth and sixth on Twelfth street, head of column facing north and resting on Yamhill.

(f) The seventh on Taylor, head of column facing east and resting on Twelfth street.

(g) The side of the Grand Marshal will report to him, mounted at Tenth and Morrison at 8 P. M. June 7.

Millions of Choicest Blooms Will Be Displayed in Six Days Crowded With Gorgeous Pageants and Speed Events.

lowed only for the purposes of eating and sleeping.

The parade of tomorrow night, the formation of which is noted elsewhere, will be a splendid spectacle. Military organizations and fraternal societies will combine in a couple of miles of illuminated pageantry. Gaily decorated floats, now being kept in the background that the surprise at their splendor may be all the more complete, will appear profusely. In the column, Red fire will add to the electric illumination so that the whole two miles of the procession will be a blaze of gay light.

With Tuesday the levy that the Rose King has culled from the choicest rose gardens of the city will be on display at the Lewis and Clark Exposition grounds. Countless thousands of matchless blooms will make up this lavish display. At night there will be the spectacular electrical pageant conveying Rex Oregonus, embodiment of the Rose King and his suite.

Wednesday again the tribute of roses will be on display. In the afternoon five miles of automobiles, burdened with the floral tribute in beautiful designs, will wind its way through the thronged streets of the city. Horses and vehicles, bearing their great display, will parade in the afternoon.

That night the extraordinary illuminated display of Oregon's resources will pass in review through the town.

Friday and Saturday the Festival will be expressed in gay races of horses and automobiles. Saturday night the Festival week ends in an appropriate burst of glory. Such is the programme of the week in its essentials.

MONDAY TO BE HOLIDAY FOR CITY EMPLOYEES.

Major Lane yesterday morning declared Monday, June 7, a holiday for all municipal employees. He had two reasons for so taking this action.

First, he feels that all men should have an opportunity to vote on the many highly important amendments and for city officers at the regular election, secondly, he desires that all shall have ample time to celebrate the opening of the Rose Festival. Taking these two matters into consideration, he felt justified in designating tomorrow as day of rest for all those who serve the city, who can possibly leave their labors. Of course, there are some, such as police and firemen, who will be unable to leave work.

You who are the subjects of the domain each has a part to perform. It is expected of all you who have roses that you will pay the tribute that the Festival King levies. Tens of thousands of the roses have already been promised. Tens of thousands more are demanded. If you have only a bush or two send a dozen or half a dozen. If you have a yard of roses, as many of you have, send 100 or 1000. Deliver them Tuesday or Wednesday to the receiving depot on the prominent business corners along Washington and Morrison streets. There they will be received and delivered to the Exposition grounds where the decoration of exhibit and parade features is to be effected. Portland expects every rosegrower, amateur and professional, to do his duty.

CARS TO STOP FOR BOUQUETS

Schedule of St. John and Woodlawn Lines Is Announced.

J. H. Nolte, who is looking after the gathering of roses on the Peninsula by the special car that will run between the St. John and Woodlawn lines, makes a special request that all roses be cut with long stems and that the names of the people giving the roses be placed with the roses when left at the several stations. Long stems are needed to preserve the freshness of the roses and make it possible to arrange bouquets to be given out at the Union and North Bank depots.

Tuesday morning the special rose car will leave the North Albina car barn at 7:20 o'clock and run to St. John and back, then out Union avenue to Woodlawn, gathering roses from the stations along the railway. People on the Peninsula are urged to have their roses at the stations beginning at St. John, and at all the stations in time to be brought in by the rose car. People in Multnomah Addition may send roses to Killingsworth avenue to Mr. Nolte's office early enough to be picked up by the car when it returns from St. John. The same can be done along the Upper Albina carline.

Tuesday the rose car will start out at 7:30 o'clock to get the roses to the California building in time for the display. Mrs. A. B. Stone, president of the North Albina Rose Culture Club and committee, will be in this building to receive and arrange the exhibit there. Other days of the coming week the rose car will start out at 8 A. M.

WILL NOT EXCEED 21 FEET

Serious Flood at Portland Regarded Improbable by Weather Bureau.

Snake River is falling at Lewiston and from all indications and reports at hand, Forecast Official E. A. Beals is unable to predict a higher stage of water than 21 feet at Portland. He looks for this stage to be reached by Wednesday. Unless there is a material change in conditions, the water will not come above that mark at Portland. This will be 12 feet under the top of high water of June, 1894.

Today will mark the fifteenth anniversary of the flood of 1894, at that time the water at Portland was around the corner of the Perkins Hotel and the gauge stood a fraction above the 22-foot mark. At Portland yesterday the reading was 18.7 feet, about one-half of the stage registered in 1894.

The Snake River reached a stage of 18.5 feet yesterday at Lewiston and began falling. In June, 1894, the Government placed the high water mark at that point as 26.6 feet. On three subsequent years the water has been higher at Lewiston than at present. On each of these occasions, it passed the Bonnera mark.

At Bonnera Ferry, on the Kootenai River, there is only a three-foot stage, and at the Dalles, on the Columbia, the river is eight feet short of a flood stage. The Snake River at Portland will be five feet short of flooding Friday street and will be only two feet over the Couch street dock.

EAST SIDE TO HAVE DIVISION

Automobile Pennants Will Boost That Side of City.

East Side automobiles will appear in the automobile parade Wednesday afternoon in a division by themselves. A. C. Dunning, A. L. Dufpy and W. H. Markle, committee from the East Side Business Men's Club, made arrangements for placing East Side automobiles in one division. The places are being given out. The places are East Sixth and Alder streets; East Couch, between Grand and Union avenues; Holladay avenue between East First and Larabee streets.

It is desired that automobiles from the East Side should come to either of these three places the day of the automobile parade at 1 P. M. and get their pennants to be carried in the parade. There will be men at these places to deliver the pennants.

LIGHTS AND DAZZLE

Electrical Floats Will Be Blaze of Splendor.

TELL STORY OF OREGON

Magnificent Parade Tuesday Night Will Be Symbolic of State's Resources and Wealth of Poetic Lore.

Magnificent in conception, lavish in execution, the embodiment of pomp and splendor with a touch of the spectacular, the big electrical pageant of Tuesday night will be all that and more.

Wonderfully designed floats mounted on trolley trucks, will tell the fabulous story of the Oregon country in this parade. There will be 16 of these cars and they will give a deft and subtle expression of the riches, poetic and material of the domain. They will be formed as the imperial pageant of his Royal Highness, Rex Oregonus, ruler of the Festival land.

Scores of workmen have been spending weeks in the preparation of the superstructures for this panorama. The conception is that of George L. Hutchins, general manager of the Festival, and he has supervised in the carrying out of the intended effect. Out at the working "den," where the thousand and one amusement features are being created, these floats are now being given their finishing touches of paint, bunting, roses and finery.

Route of Electrical Parade.

This pageant will move Tuesday night at 8 o'clock from Nineteenth and Washington streets. It will proceed down Morrison street to Third, Fifth and Washington, east to Fifth and then around the depot loop to Fifth and Washington and out Washington street to Nineteenth where it will disband.

Fifteen thousand brilliant lights will illuminate the various floats. Every car will be set in a cluster of bright lights and the effect will be heightened by the burning of tons of red fire.

Heading the pageant will be a highly illuminated car bearing Festival and streetcar officials. Immediately behind this will come the imperial car of the Festival King and behind that the Imperial suite. Here is a statement of the various cars and floats and the meaning they conveyed, as prepared yesterday at Festival headquarters.

Floats and Their Meanings.

Car No. 1.—Rex Oregonus, King of the Oregon country, ruler of the Festival, will revel in pomp and pageantry to the delight of his myriad of loving subjects. This mighty monarch who sways an empire that is a paradise for realm rich in sweetest perfume and perennial beauty, feels the royalty of other climes to be palatial. He is a monarch of the balm of the sea that mingles with the crystal drops of melting snow from the Cascade towering ranges and makes the Elysium for youth and age alike.

Float No. 2.—Father Time slides swiftly ever, where the hour glass sends no sands of life as the golden days pass by the land of Oregonus.

Float No. 3.—The Fates with distaff high spin the magic web of destiny, and the living cloth of fate and snarles and tangles in the realm of Oregonus.

Float No. 4.—The Queen of Diamonds that tricked a thousand sunbeams in the gems of purest rarest serena lays tribute at the feet of Rex Oregonus, that she may enjoy eternal bliss in a land like this.

Float No. 5.—The Queen of Stars, dejected from the vault of heaven, sheds lustre on the night that great Oregonus might point the way to the portals of his paradise.

Float No. 6.—The Queen of Beauty, who finds Oregon a perennial fountain of youth, smiles bewitchingly on the Mighty One.

Float No. 7.—The Queen of Flowers, who rosette hues galore, reigns concurrent with Oregonus to these matchless gardens of the gods.

Float No. 8.—The Queen of Fragrance, whose delightful perfume cheers every heart, distills her secret charm from the blossoms of the East.

Float No. 9.—The Lily, Queen of the East, greets the rose and bows to Oregonus as she breathes new life and hope in his ever realm of wonderland.

Float No. 10.—Lalla Rookh, the Princess of the East, with her golden gossamer train for the Vale of Cashmere, never saw a prospect more enchanting than the land of Oregonus.

Float No. 11.—Queen of the Nile, where Africa's sunny fountains lure the water to the languors of the Nile, in obedience to Rex Oregonus, pays glowing tribute to his roses rare and his climate that melts the golden ages through.

Float No. 12.—The Mongolian Pheasant, who breathes new life and hope to the land of Oregonus, has every prospect is pleasing and only man can be given out.

Float No. 13.—Peace bath its victories no less than war. And Oregonus, whose holiday avenue between East First and Larabee streets, is charmed by the wiles and smiles of Oregonus, will live forever in the land of the Golden Rule.

Float No. 14.—The Queen of Pearls, whose opalescent gleams have bought the ransom of midnight kings, has come to bask in the splendor of Oregonus, the Robinson of jewels.

Float No. 15.—The Polar Bear, King of the Arctic, last but not least, pays respects to Oregonus and begs eternal happiness in the land of glory where our happy dreams come true.
