

# AUTO UPSETS AND HURTS THREE MEN

### Mose Winters, of Portland, Is Victim of Serious Accident Near Monmouth.

## MACHINE TURNS TURTLE

### Driver's Hat Is Jostled and in Reversing Machine as It Swerves, Car Turns Over—Occupants Receive Broken Bones.

INDEPENDENCE, Or., June 19.—(Special.)—In an automobile accident this afternoon between here and Monmouth, a machine belonging to Mose Winters, of Portland, was run over, and Mr. Winters, Archie Tetherow and E. W. Strong, of Monmouth, were seriously injured. Winters was driving the machine, a Cadillac, at a rapid rate, when Strong, in some manner shoved Winters' car over his eyes, causing him to swerve the machine to the side of the road. Winters quickly reversed the machine, and in doing so caused the automobile to turn a complete somersault, landing on its side. The car was so smashed that it is a total wreck. The occupants were thrown out, injuring them severely. Winters, who has been visiting at the home of his brother-in-law, E. E. Hewitt, suffered a badly wrenched leg, and his face was cut in a frightful manner. Mr. Tetherow, of Monmouth, was the worst injured, his nose and the bones in his face being broken and smashed. One of his teeth was knocked out and forced through his lips. E. W. Strong, a retired lumberman and now a druggist at Monmouth, received a broken arm and his face was badly lacerated. The machine was towed into Monmouth, while the victims of the accident were taken care of at a nearby farmhouse until a physician could be called. Dr. Butler was called immediately and moved the patients to their homes, where at last reports they are resting easy. The party had attended the races at Independence, and was returning to fill an engagement at Monmouth.

## ROME GOES UP HILL

### McLoughlin Injunction Denied by Judge Eakin.

## SECOND MOVE EXPECTED

### Those Who Oppose Locating Historic Building on Public Square Will Prepare Second Restraining Order With Bond.

OREGON CITY, Or., June 19.—(Special.)—Circuit Judge Eakin this afternoon declined to grant a temporary injunction restraining the moving of the historic home of Dr. John McLoughlin, the founder of Oregon City, to the public square at the top of Singer Hill. He granted a temporary restraining order early this morning, and set the case for hearing at noon, but when he learned that no bond had been filed he immediately dissolved the injunction and later in the day heard the arguments on an application for a temporary order. As was expected this morning, Attorney John F. Clark filed a complaint calculated to stop proceedings, in which Caleb Cross, who has been antagonizing the proposal to move the building to the public square, instituted an action against Fred S. Baker, the contractor who is moving the building, and E. G. Caulfield and E. E. Brodie, president and secretary, respectively, of the McLoughlin Memorial Association. Mr. Cross contended that if the home of McLoughlin is placed on the square, the public would be injured thereby, and that he would be unable to command a view of the scenery from the square. State Senator Hedges appeared for the Association, and advanced the argument that no possible damage could result and that the complaint failed to show that he had any right to sue for the public and that the allegations were entirely insufficient. The court will file a second attempt made to prevent the building going on the square. Judge Eakin ruled that no injunction would be issued against proceeding with the moving of the building, and it is entirely probable that the people who are trying to have the building restored to preserve the memory of McLoughlin, will secure another injunction if they are prevented from establishing the permanent location of the structure on the public square, under permission of the City Council.

## EUGENE LORTON RESIGNS

### Chairman State Board of Control Prefers Private Life.

OLYMPIA, Wash., June 19.—(Special.)—Eugene Lorton, chairman of the State Board of Control, today tendered his resignation to Governor Hay. Chairman Lorton's term expires this month, and Governor Hay tendered him resignation in his letter. Lorton explained his reasons for resigning, saying: "I cannot afford to neglect my own private business and devote all my time to the duties of the office." Mr. Lorton was one of the first appointments made after the election of the late Governor Cosgrove. He has been appointed by Governor Mead at the request of Cosgrove. He is owner and publisher of the Wash. Walla Bulletin. His services for the state have been at a personal pecuniary loss, and he would not have anything to do with him if Governor Hay has not yet announced whom he will appoint as successor.

## GRANGE CHAPLAIN DEAD

### Oscar Eaton, Aged 88, Passes Away at Home Near Oswego.



OREGON CITY, Or., June 19.—(Special.)—Oscar Eaton, for many years chaplain of the Oregon State Grange, died at 6 o'clock this morning, at his home near Oswego, aged 88 years 10 months and 11 days. He had been in failing health for some time and had been unable to attend the recent sessions of the State Grange at McMinnville. Mr. Eaton was a native of New York state and came to Oregon about 29 years ago, settling near Oswego. He was a Civil War veteran. He is survived by four children, Mrs. A. J. Thompson, of Oswego; Louis Eaton, of Pendleton; and Mrs. H. E. Thompson and Miss D. G. Eaton, of British Columbia. The funeral will probably take place next Tuesday at public auction in the state addition, though definite arrangements have not yet been made.

## ACCIDENT ON INDEPENDENCE RACING COURSE

### Horse Beaks Loose and Goes Tearing Dawn Track, Smashing Sulky and Harness.

INDEPENDENCE, Or., June 19.—(Special.)—The Independence Driving Association held its last day's races today before the largest crowd of the three days. The first heat of the 2:15 was won by Atabel in fast time. In scoring for a place in the second heat the wheels of the sulky of Perry Nausey, driving Son Nort, and H. C. Cox, driving Lou Miller, became interlocked, tearing one wheel of the sulky in two. Nausey was seated and tearing the tires from all the other wheels. Son Nort started to run and the broken sulky turned over, spilling Nausey. The sulky dragged over him, injuring him slightly and rendering him unconscious for a few minutes. The horse then had free rein and started to tear the track into the fence and cutting himself badly. He ran half-way around the track before coming to a stop, tearing the sulky and harness to pieces. Mr. Cox got another sulky and started, getting second place in the second heat. The second race was five-eighths of a mile dash. Five horses were entered and three got away in a bunch, but the two belonging to Mr. McLoughlin did not get a good start. Mr. McLoughlin entered a protest, which was upheld by the judges, they calling the race off, with instructions not to divide the purse.
