Included in \$500,000 Sewer-
age Project.

LEGISLATURE'S AID SOUGHT
J. H. Nolta and I. N. Day Would
Create District of 40,000 Lots.
Residents Favor Move Which
Could Add Waterfront.

Creation of a drainage district embracing about 40,000 lots, for the dredging of Columbia Slough, at an estimated cost of \$500,000, is one of the most important projects that will be placed before the Legislature, which will open its sessions at Salem tomorrow.

A bill is being drafted and will be introduced into the House by J. H. Nolta and in the Senate by I. N. Day, members of the Multnomah County delegation, for the creation of the proposed district. It is to provide for a commission of five men who will serve without pay and will have charge of the territory, as it now only abuts the First ward. The bill will be introduced by the Governor, but thereafter it will be elected by the people of the district as their territory.
