

AUTOPSY CONFIRMS HYDROPHOBIA CASE

Mayor Drafting Ordinance for Muzzling of All Dogs During Hot Season.

RABIES EASILY PREVENTED

Health Officers Say Disease Should Not Be Difficult to Treat When Caught in Time—Kier Urged to Try Pasteur Cure.

An autopsy, in which State Health Officer White assisted, yesterday gave confirmation that the death of Frank Griffith was due to hydrophobia. While the autopsy was under way preparations were made by Mayor Albee for the passage of an ordinance requiring the muzzling of all dogs in the city between July 1 and September 15, of each year. This ordinance will bear an emergency clause and will be brought before the Commission Wednesday.

Within the past year more than 100 dogs which have been under observation of health officers have died of hydrophobia and 24 persons have been treated after they were bitten by rabid dogs. Mr. Griffith is the first person in the city who failed to receive treatment in time to avert the disease.

Doctors Warn Kier. Charles B. Kier, who was also bitten by Mr. Griffith's dog, has been warned by the physicians who attended Mr. Griffith to take the Pasteur treatment at once. Dr. E. H. Thornton received a slight bite from the same animal and will take the Pasteur treatment.

The report of the Oregon State Board of Health for the first three months of the current year, devotes considerable space to hydrophobia. Dr. White, of the State Board, and Dr. L. J. Wolf, of the City Health Board, yesterday said that theoretically rabies should be the most easily controlled of all contagious diseases, but practically it is the most difficult.

"The difficulty lies in the lack of uniformity of rules and regulations, the fear of political influences; the idiosyncrasy of so-called 'animal lovers'; the ridicule of the public press and, far too frequently, the antagonism of the physician who has never seen a case of the disease and therefore denies its existence," says the report of the State Board.

Affected Dogs Wander.

It is recommended that care to muzzling dogs should be exercised not only in Portland, but through the country districts, since one of the first symptoms is the tendency of the dog affected with rabies to wander away from home. Ninety-five per cent of the cases of rabies are said to have resulted from dogs wandering away from their owners.

Arrangements for the funeral of Mr. Griffith will not be completed until next Tuesday, when his brother, Grant Griffith, is expected to arrive from Lancaster. Mr. Griffith had no relatives living in Portland.

NEW CARLINE OPEN TODAY

Service to Westover Terrace Travellers Scenic Route.

Another scenic streetcar line will be added to the Portland list this morning by the operation of a new carline from Twenty-fifth and Pettygrove streets to Westover Terrace. This streetcar is located upon the hills to the north of King's Heights, and presents to the eye one of the most wonderful views obtainable of a city. The cars will begin operating at 5:30 this morning, and will cover the entire distance of 4.54 feet in 15 minutes, it taking 14 minutes to make the return trip.

Beginning at Twenty-fifth and Pettygrove the track turns upon Cornell road and continues on its winding thoroughfare until it reaches Westover road. Here the car winds its way to Cumberland road, which follows the contour of the hills. The car runs to the south and east a greater portion of the city is presented.

Westover Terrace was leveled by means of a hydraulic system established by use of the waters of Guild's Lake. The plans of the terrace were made by the famous landscape architect from Boston, and have many attractive features. Connection is made with the Willamette Heights cars.

'DOPES' MAY GO TO ASYLUM

Judge Stevenson Would Test Sanity of Drug Fiends and Drunks.

First application of the theory of Municipal Judge Stevenson that certain forms of delinquency are fostered by the use of alcohol and drugs, was made yesterday when he caused three young drug addicts to be turned over to the County Court to be examined for insanity. The boys, part of the number caught in a recent campaign against the sale of cocaine, are George Miller, William Rose and John Holt.

Judge Stevenson believes confirmed users of liquor and drugs are not benefited by rockpile sentences, and that it is a cowardly evasion of a civic duty to lock them up merely to have them out of the way. If the examining physicians will agree with the view that these men are truly insane, a number of old landmarks may find in the insane asylum a better home than they have known for many years.

Auditorium May Be Delayed.

That the prospects are poor for Portland's getting an auditorium in the near future is the statement of Commissioner Brewster. The plans prepared by the New York architects call for a structure to be erected on land covering a block and a half, while the city owns but one block. Funds for purchase of half of another are not available.

W. W. Scott Is Divorced.

After two weeks of married life W. W. Scott was allowed a decree of divorce from Louise Scott by Circuit Judge Kavanaugh yesterday. Scott's complaint against his wife was that she started "sousing" right away after the marriage, and has been intoxicated almost continuously since. He said that she took great delight in calling him unprintable names.

"BORN TO SUCCEED," SAYS ORCHESTRAL LEADER

Herman S. Heller Takes Inspiration From Napoleon, Whom He in Many Respects Resembles—"Good Music" Is His Promise to Portland.

N many respects Herman S. Heller, now fulfilling a professional engagement in this city, resembles Napoleon the Great. Napoleon had an enthusiastic belief in his lucky star that he was born to succeed, that he had a magnetic personality, that there is much in a name, and that there isn't any such word as "fail." The Napoleon of Jena and Austerlitz won on that policy as conqueror.

"I have a fixed belief in my lucky star," said Mr. Heller, last night. "I was born to do big things in music. I say this without vain glory, or without a wish to blow my own horn."

"In other words, you are a Napoleon of orchestral music," was queried.

"Life is a battle," he says. "Life is a battle. My life is music. I do not say that I am Napoleon, and don't wish to conquer the world, as he did, but have as much right to believe in my lucky star as he did. I drink my inspiration from Napoleon, my belief that I shall yet win the front rank in orchestral work. My specialty is symphony. I believe that if I could be allowed, once, to lead the Portland Symphony Orchestra, such would be the effect I would produce as leader and the kind of music played, that I would be the only conductor afterward at all the other concerts. The men themselves would ask me to be their leader. All I ask is a chance."

"But you are a stranger in this city," was pointed out. "What about the rule of the Portland Symphony Orchestra, where all the conductors are elected by vote from the membership and on a democratic basis, that no person is eligible for election as conductor unless that person shall have played with the orchestra for one year prior to such election?"

"Oh, that wouldn't affect me," said Mr. Heller, with an easy air. "Once they heard me play, gave me permission to be their conductor—only once—the rest would be easy to me. It is a matter of personality, interpretation and phrasing. Suppose I utter the sentence three times: 'It is going to be a fine day today.' I can say it in three different ways by changes in inflection, in expression, in meaning. So it is with music. I can beautify every phrase by my interpretation."

"What musical experience have you had?"

Engineering Once Studied.

"I graduated in harmony, counterpoint, violin-playing, etc., from the Royal Conservatory of Music, Prague, Bohemia," replied Mr. Heller. "I also studied mechanical engineering, but determined to devote my life to music. When I was 17 years old, I wished to be free, to try life in free America, and landed in New York City. I had no difficulty in securing engagements as first violin, in orchestras, and I played violin solo with Creatore's band at Atlantic City, N. J. I was also first violinist with the Philadelphia Symphony Orchestra, Fritz Scheel, conductor—ah, that was an orchestra! For the past four years I have been orchestral leader at the St. Francis Hotel, San Francisco. What I did in symphony work in San Francisco I hope to duplicate in Portland. I am also a composer. I wrote the music for

'Prince Hagen,' the social drama written by Upton Sinclair, and produced with success at San Francisco. I wrote the music for the jinks of the San Francisco Press Club in 1912 and 1913."

"What do you think of Kibelak as a violinist?"

"To me, he is cold," said Mr. Heller. "I admire Kreisler more. Yes, indeed, I stand for good music. The people of Portland want it, and I am going to give it to them. Watch me!"

FUGITIVE SWINDLER TAKEN

Lake County Sheriff Captures Man Who Broke Jail in California.

Bernard C. Sitz, who some weeks ago broke jail in Bakersfield, Kern County, Cal., after he had been sentenced to serve five years in San Quentin penitentiary, was in the Multnomah County Jail yesterday, on his way back to California in charge of Charles H. Smith, a Deputy Sheriff from Bakersfield. Sitz was recognized and arrested at Bend, Or., last week by Sheriff Snyder, of Lake County, Or., who happened to be in that city.

Sitz, according to Deputy Sheriff Smith, sold to oil prospectors for an aggregate of about \$12,000 oil lands in Modoc County, Cal., of which he didn't own a foot, operating from Bakersfield by means of false abstracts. After his jailbreak he returned to Portland, where he was in the business of locating settlers. He is 27 years old.

Skating Rink May Give Bond.

Commissioner Bigelow last week made a visit incognito to the skating rink at Lenta, over which there has been much controversy, and yesterday, at a hearing of both sides of the question, he suggested as a compromise that the rink people put up a bond to close nightly at 10 o'clock and to have the place closed all day Sunday. The rink folks agreed, but the other faction asked for time until Tuesday to make reply.

ARMSTRONG DENIES RESIGNATION STORY

Superintendent Says He Did Not Offer to Quit Office to Stop Investigation.

KIENLEN WILL COME BACK

Sergeant Who Had Charge of Chinatown to Return to City When His Leave Expires—Gambling Inquiry to Be Resumed.

Despite denials by County Superintendent Armstrong that he offered to resign his position in consideration of the abandoning of a grand jury investigation as to his conduct while City Civil Service Commissioner, the attitude of the District Attorney's office when questioned as to the report, leaves an air of mystery. Deputy Maguire refused to discuss the report, except to say that he would take no action to influence the decision of the jury one way or the other.

A form of indictment will be drawn up Monday and submitted to the jury to vote a true or not true bill. The charge under which the indictment will be drawn has not been definitely determined. It may be either malfeasance in office, acceptance of a bribe or violation of the corrupt practices act.

Jury Takes Day Off.

No evidence upon the municipal scandal was heard by the grand jury yesterday, but it will meet Monday with a broadened field, probably to take up a probe of the reports that residents of Chinatown have been paying for immunity from prosecution. Among those likely to be called as witnesses are Captains Silver, Keeler and Riley, beside a number of police officers familiar with conditions in Chinatown.

While a natural inference of corruption is to be drawn from the fact that 20 or more games in Chinatown went untraced for more than six months, the trail of the "snack" is difficult to pick up.

Word has been received from Sergeant Kienlen, formerly in charge of Chinatown, that he expects to return to duty when his six months leave of absence expires next month. It is believed that his observations in Chinatown were such that he can throw some light on the question.

Offers Made to Testify.

That the protection went clear around the policemen in the prevailing theory of the information continue to reach the District Attorney from unexpected sources. Government officers are the list of those who by the nature of their duties have been in a position to learn things. One former police officer who closed with Deputy Maguire yesterday and is believed to have furnished valuable information.

As the present grand jury sits until the beginning of the September term of court, the probe is proceeding in a leisurely manner. It will not be necessary to hold the jury in session all the time, but it may be called together at any moment when new evidence is ready for presentation.

SHORT DAY TO BE URGED

WELFARE COMMISSION WOULD PROTECT MINORS.

Week of 48 Hours With Minimum Wage of \$1 Daily Will Be Recommended.

Preliminary to recommendations to be made by the Industrial Welfare Commission regarding employment and wages of women and minors, the Commission will hold a public hearing at 320 Commercial Block on Tuesday, August 5 at 10 A. M.

Following is an outline of recommendations contemplated by the Commission:

—No girl under the age of 15 years shall be employed in any manufacturing or mercantile establishment, laundry, hotel or restaurant, or telephone or telegraph establishment or office, more than 8 hours during any day, or more than 48 hours in one week.

That no person of either sex, under the age of 15 years, shall be employed in any of such establishments after the hour of 6 o'clock at night.

That a minimum wage of \$1 a day shall be established for girls between the ages of 16 and 18 years, working in the above mentioned occupations, except as shall be otherwise arranged for by the Commission in cases of apprentices or learners.

NEW RAIL LINE IS SCENTED

Inspection Party at Chehalis Supposed to Be Milwaukee Men.

CHEHALIS, Wash., July 12.—(Special.)—A party of three strangers, who

declined to reveal their identity or to make known their business in the city, was here yesterday looking over the old Union Pacific grade through the west part of the city. They were arrested by Sheriff's deputies in a raid on the Rhode & Rupert saloon, 273 Burnside street, a few days ago for playing cards for money. The saloon was exonerated by the grand jury.

Heinrich Eismann was indicted for non-support of Marie Eismann, his wife, under the law passed by the last Legislature making failure of a husband to support his wife or children a felony. The indictment was returned against Orin J. Wood, alias O. C. Ryne, charging him with obtaining money by false pretenses by passing a worthless check for \$12.50 on Dahl & Penne.

"STRAW" BONDS HIT

Perjury Charges to Follow Falsifications in Court.

STORE'S PRICE TAKES JUMP

Property Worth Only \$350 When Assessor Calls Is Valued at \$2000 When Hyman Cohen Wants to Give Bail for Jake.

District Attorney Evans yesterday caught Hyman Cohen and I. Segel in the act of trying to become bondsmen of the "straw" variety for Jake Cohen, held on a charge of assault and battery, and stated that he would go before the grand jury and seek to have them indicted for perjury.

Cohen, who has a store at 273 Front street, gave his cash value as \$3000. The records in County Assessor Reed's office showed that he had given its value as \$350 in a sworn statement for assessment purposes. On learning of the oath taken in the District Attorney's office, Mr. Reed promptly jumped the assessment up to \$1200, and Cohen fumed and wrung his hands in despair. He had told Mr. Evans that his store was assessed at \$1000.

Segel swore, when seeking to qualify as a bondsman, that he owned the property at 1129 Emerson street, and that this property was worth \$2000 in excess of \$400 which he owed on it. The assessment rolls showed that he was the owner of the property, and that the property is assessed for only a few hundred dollars.

When Mr. Evans succeeded George J. Cameron as District Attorney about the first difficulty he encountered was finding defendants and bondsmen when cases were called. The bonds did not show where the bondsmen lived or what they owned, and letters addressed to them came back unanswered. These are what are known among the legal fraternity as "straw bonds."

With the assistance of J. L. Hamersley and Robert F. Maguire, two deputies who have had some experience in banking, Mr. Evans formulated, for the benefit of prospective bondsmen, such a list of questions as bank officers ask when one desires to borrow money, and adopted a system of making the would-be bondsmen swear to the truth of their answers and write the answers themselves. This leaves the way clear for perjury prosecutions in cases where deception is practiced.
