The commission also recommends that the money received for the cap-ital stock shall be invested only in first-class securities, such as legally is-sued bonds, warrants of any county, city or school district of the state, or security that is negotiable at any time. Surplus funds can be invested in other securities, but no loan or in-vestments shall be made until it is approved by a committee having

in other securities, but no load of in-vestments shall be made until it is approved by a committee having charge of the finances. Whenever a company desires to re-duce its capital stock it must have the approval of at least two-thirds of the stockholders, and the capital' stock cannot be reduced below \$100,000. They also recommend that the or-ganizers of any company shall be jointly and severally liable for all debts or liabilities of the company un-til it has qualified and a license has been issued by the Commissioner, and if the company does not commence to issue policies within two years of its date of incorporation the Insurance Commissioner, or a stockholder, may petition to the court to require the company to commence business or close its affairs.


