

SHERIFFS CONFER ON HARVEST PLAN

Ten Northern Idaho and Two Washington Counties Take Protective Measures.

I. W. W. SECRETARY JAILED

Governor Alexander Will Accompany Investigators Today on Visit to Troubled Districts—Hostile Camps to Be Closed.

MOSCOW, Idaho, July 14.—(Special.)—Sheriffs of 10 Northern Idaho counties and two Washington counties, together with Governor Alexander, of Idaho, and farmers of Northern Idaho, began a conference here today to consider a system of harvesting the grain and fruit crops.

The sheriff called the meeting after it had been reported to them that Industrial Workers of the World had threatened to interfere with the harvest.

Before the conference began it was reported that the Industrial Workers' Hall at St. Maries had been raided yesterday and the secretary of the organization, Neil Gayney, arrested. He was arraigned in court charged with distribution of literature covered by the Idaho sabotage act, which is a felony. Gayney pleaded not guilty and was put under \$1000 bond for a preliminary hearing.

Every precinct of Latah County was represented here when the Latah County Protective Association was formed. Means to combat any action that will be taken by the Industrial Workers of the World were discussed. A plea by Governor Alexander that the people of Moscow and Latah County meet the situation without outside assistance forestalled the introduction of a resolution at the conference calling on the Federal Government for troops.

The Governor asked that business men close their stores, if necessary, to assist in the harvest; that the farmers gather their crops without the aid of strangers, who, he said, might be Industrial Workers of the World and destroy their grain; and that the lumbermen reopen their plants, even if they must operate on a small scale.

The sheriffs of Latah and Clearwater counties will go with Governor Alexander tomorrow for a personal investigation into the situation. They will visit every Industrial Workers' camp, and said today they will order them closed. The Industrial Workers established the camps after they had called strikes on the lumber companies.

The sheriffs of Boundary, Bonner, Kootenai, Benewah, Shoshone, Latah, Lewis, Clearwater, Idaho and Nez Perce counties, in Idaho, and the sheriffs of Asotin counties, in Washington, were represented in the conference to devise ways to protect life, property and the right of the men to work.

FIREFIGHTERS TO ORGANIZE

Stationing of Lookouts to Guard Washington Crops Proposed.

OLYMPIA, Wash., July 14.—(Special.)—That there shall be no grain crops burned in Washington and that the crops are harvested none of the grain in warehouses or elevators is to be destroyed by fire if preaching prevention can be accomplished. The plan of H. O. Fishback, State Insurance Commissioner.

The last Legislature granted \$10,000 to carry on fire-prevention work and made him State Fire Marshal. He has engaged the services of Captain W. A. Groce, formerly of the Coast Artillery, to carry on the work in Eastern Washington. He is instructing the farmers in removing fire hazards by having chains and strips of cloth on the roads cut, by showing how to make fire breaks and organizing them into squads for fighting fire, as well as seeing that they have the necessary fire apparatus. In addition, he proposes, if possible, to have lookouts stationed on mountain peaks, where they can see the smoke of fires, and these guards will watch at night to see that no fires break out and to head off any "firebugs" that might try to start a series of fires.

FIVE ALIEN ENEMIES JAILED

Eighteen Alleged I. W. W. Held at North Yakima.

NORTH YAKIMA, Wash., July 14.—Five alleged alien enemies and three alleged draft evaders are in the county jail today, having been placed there by United States Marshal McGovern. He intimidated the five alleged enemies will be held indefinitely. Eighteen alleged Industrial Workers of the World are in jail subject to the orders of Lieutenant Stevens, of the National Guard.

The District Attorney said the Federal Government will take over the alleged alien enemies and alleged draft evaders and the others will be held by the military.

47 ARE TAKEN FROM TRAINS

I. W. W. Cards Found on Nearly All Held at Seattle.

SEATTLE, Wash., July 14.—Forty-seven men and boys have been taken from freight trains in this county by soldiers and deputy sheriffs in the past three days and lodged in the county jail. A majority of the prisoners were found at Eastern Washington.

Three transcontinental railroads cross the mountains through this county. Thirty-five of the prisoners have been charged with misdemeanor, Industrial Workers of the World cards are said to have been found on a majority of the persons arrested.

STRIKE WATCHED BY LISTER

W. J. Patterson, Aberdeen, Holds Conference With Governor.

OLYMPIA, Wash., July 14.—(Special.)—Governor Lister is keeping in close touch with the strike situation on Gray's Harbor. The eight-hour day for loggers will be maintained and an increase for mill workers and shipyard workers are said to be the basis for the strike.

W. J. Patterson, Aberdeen, was in Olympia today for a conference with Governor Lister. It is admitted that the situation is regarded as serious and the movement is being watched carefully.

Union Iron Workers Go Back.

SAN FRANCISCO, July 14.—A majority of the 300 riveters employed at the Panama plant of the Union Iron Workers returned to work today, following a walk-out yesterday, which automatically forced 400 additional men to idleness.

EXILES CAMPING ON ARIZONA RESERVATION

Food Provided by Railroad Carrying Deported Men Out of Arizona.

FOOD ALL GONE AT HERMANAS

Night Rain Adds to Discomfort of Bisbee Refugees.

HERMANAS, N. M., July 14.—Every scrap of food and every drop of water was consumed by the Bisbee deported strikers here last night. Only the car of food from El Paso prevented actual suffering.

The deportation camp was established near the freight train on a "Y" half a mile from the station. Campfires burned all night and sentries from the deported men walked the picket line to prevent anyone leaving. A rain storm drove the men back into boxcars from the outdoor camps, where

FIRST TOBACCO OBTAINED

Friends Make Trip From Bisbee by Automobile to See Relatives and Bring Food—Detention of Week Is Expected.

COLUMBUS, N. M., July 14.—Tonight the United States in Indian Territory deported miners, millmen and small merchants, who are camped on the desert half way between Columbus and the Mexican border.

A small city of canvas has sprung up on the site of the Mexican refugee camps established by General Pershing and 1140 men are sleeping on beds tonight for the first time since Wednesday at Bisbee. They came here today under escort of United States cavalry.

All afternoon the men have been working in blistering sun setting up tents, digging pits for field kitchens and hauling firewood. It was declared to be the hottest day of the summer here and many men were forced to quit and rest in the shade of the khaki tents, which were erected under the direction of the soldiers.

The first government rations were issued to the men for their supper, consisting of canned beans, corn, potatoes and bread. Tomorrow at breakfast they will receive a ration of coffee, the first they have had since leaving

Chaos Gives Way to Order. Under the direction of the Army officers and soldiers, an orderly, well policed camp was established out of the chaos which followed the arrival of the tired and travel-stained men shortly after noon.

Lieutenant Sheekjerian, provost marshal, was in charge of the work of establishing the camp and of organizing the refugees into a regiment composed of battalions and companies for feeding and caring for the needs of the men. He has relieved Attorney William H. Cleary, in charge of the camp. The Bisbee attorney, who had a bath, shave and a change of linen, was not recognized when he appeared at the camp today.

Armed Protection Desired. Now that the men have settled for them the problem of where they were to go, they are beginning to consider when they will be returned to Bisbee, where they have their families, homes and many of them business affairs. They are almost universally agreed they will be ready to return to Bisbee when accompanied by United States soldiers and not before.

One American miner said tonight: "We are preparing to fight a hard battle, but not until the soldiers go along to protect us."

Men Closely Guarded. Army officers also are in the dark as to what the next step will be and say they have orders only to feed and care for the wants of the men. The exiles are not being treated as prisoners, but are being guarded by soldiers with side arms and no one is permitted to enter their camp without a pass.

The men believe the President will order them sent back to their homes, but there is no information in camp upon which to base this supposition. The men continue to complain about having money and valuables taken from them at Bisbee, but are unable to give names of anyone who robbed them. They also allege their families were not being permitted to draw money from the Bisbee banks, but this report was not confirmed by any specific facts.

Ten automobiles arrived here from Bisbee ahead of the train, carrying quantities of supplies brought by friends of the deported men. These supplies were not permitted to be issued today, but will be when camp is established. Mrs. Rosa McKay, State Representative from Cochise County and wives of the deported miners, also came here from Bisbee by automobile.

Many of the men were given an ovation by the men as they walked along the line of March, the men lifting their hats and cheering. Their "little leader," Attorney Cleary, smoking a corn cob pipe, was also cheered as he stood at the head of the line, giving orders to the men in charge of each car regarding the rations.

Men Bathe Blistered Feet. Mrs. Myrtle Reel, who came here to see her husband at the camp, reported today she recognized the Bisbee merchant who entered her house at night while she was alone.

After the exiles had completed establishing camp, they all went to the big water tank in the camp and bathed their blistered feet, washed their clothes and in the night they slept in the wedge tents. They obey orders without comment and seem to have accepted their lot until the President and ex-Governor George P. Hunt in whom they have every confidence, relieve their plight.

When the unhaven and unwashed crowd marched up to the refugee camp this afternoon they presented one of the strangest sights Columbus has seen since Villa's Mexican bandits dashed into the town on March 9, 1915.

Many Enter Hospital Tent. Many were without hats and wore soiled handkerchiefs on their heads to keep off the sun. Others limped from blistered feet, while old men and the physically unfit had difficulty in marching the mile to the camp from the railroad. One man fainted after reaching the camp, and the hospital tent was crowded with minor cases during the afternoon, though no serious illness has been discovered.

Milo Nickola, a Montenegrin miner, wore a bloody bandage around his head where he said a special deputy hit him with a revolver at Bisbee. His shirt was stained with dried blood.

A cook in a restaurant in Bisbee marched to the camp wearing his cook's coat and apron, not having had time to get his coat and hat.

REFUGEES EXPRESS THANKS

Governor of New Mexico Says Situation Well in Hand.

Sheriff Simpson telegraphed that the strikers showed no disposition to create trouble.

Governor Lindsay assured the people of Silver City that the situation was well in hand, following receipt of a message from the Silver City Chamber of Commerce, asking protection.

"We don't want this mining camp polluted by such undesirable citizens," ran the telegram.

OREGON WILL SEND 101

NEW OFFICERS' CAMP ORDER IS BASED ON DRAFT CENSUS.

INSTRUCTION GIVEN FOR ADDRESSING MAIL TO MEN AT NATIONAL GUARD CAMP AT PALO ALTO.

SAN FRANCISCO, July 14.—Wide discrepancies in previous estimates of population and the revised census based upon selective draft registration in states of the Western Division of the Army resulted today in a reapportionment of quotas for the second camp for officers of the Reserve Corps which will be held here today by H. E. Collins, a telegram from the War Department to Major-General Hunter Liggett, commanding the division.

The number of men from each state to be certified to the camp under the new apportionment follows: Oregon, 101; California, 478; Utah, 65; Montana, 142; Wyoming, 146; Nevada, 20; Washington, 175.

SAN FRANCISCO, July 14.—Major-General Hunter Liggett, commanding the Western Division of the Army, requested today that the members of the Twentieth National Guard Camp at Palo Alto, Cal., be addressed to Menlo Park, Cal., where the military postoffice has been located, thus saving confusion and delay in delivery. 15 PERSONS ARE EXECUTED

Amsterdam Says 58 Condemned to Death at Antwerp.

LONDON, July 14.—The Echo de Belge is quoted in a Central News dispatch from Amsterdam to the effect that 58 persons were condemned to death at Antwerp and 15 of them were shot on July 6.

Among them, the newspaper says, were three sisters, who were accused of smuggling letters.

F. A. Mable Seeks to Recover Loan. VANCOUVER, Wash., July 14.—(Special.)—A suit to recover \$1,000 which F. A. Mable loaned to the Washington Gold and Copper Mining Co., to develop mines of the company near Cape Horn, was filed here today by H. E. Collins, trustee for R. H. Stockton, of St. Louis, Mo., to whom Mable has assigned his claim. Mable claims to have advanced the money for development work at the mines between July 1, 1911, and July 1, 1915, and has had no return from the same. In addition to the principal interest on the amount at 6 per cent is asked.

RYE BREAD TO BE USED

NORTHWEST BAKERIES WILL MAKE FURTHER SAVING.

Conservation of Millions of Bushels of Wheat Each Day Effectuated With Little Effort.

Bakeries throughout the Northwest, having agreed not to take back day-old bread from the retailers, are going to go a step farther in the saving of food materials, in co-operation with the Federal Government, if the plan of H. F. Rittman, ex-president of the Master Bakers' Association, is adopted generally.

It advises the exploitation of rye bread on at least one meal of each day, so that the supply of white flour may be conserved. In recent demonstrations various forms of using rye flour were shown to be most palatable, and the food value of the bread also favors its general adoption by consumers.

"If one of the three meals of the day was served with only rye bread on the table, the supply of wheat for the allies would be increased by 150,000,000 bushels," said Rittman.

"This phase of the food saving would be as great in the good that it accomplished as the return of the stale loaves, which, contrary to public opinion, were not entirely lost as a factor in the supply of food."

FOREST FIRE PREVENTED

Hard Work of Logging Crew in Tenney Camp Stops Blaze.

RYE BREAD TO BE USED

NORTHWEST BAKERIES WILL MAKE FURTHER SAVING.

LOGGING IS COMMENCED

Lewis River Industry Opens, Giving Employment to Many.

The Dayton Sawmill Company at Hall, 14 miles east of Woodland on Cedar Creek, is also contemplating a resumption of operations, to employ about 75 men.
