

Before the city of Fortland could pay such bonds at maturity it would be necessary for the holder, in view of the above in-dorsement, to produce satisfactory evidence to show that a successor was regularly ap-pointed in the place of the trustees named and that he had authority to accept pay-ment and surrender the bonds by virtue of the trusteeship.


## Three Alleged Slackers Arrested.


## Lou Lane Marston Wanted.
