

PACIFIC NORTHWEST LIBRARIANS MEET

Eleventh Convention to Be Held Here Thursday.

3-DAY SESSION SCHEDULED

Discussions Will Be of Interest to Educators; Will Be Done at Central Library.

Pacific northwest librarians will open a three-day convention next Thursday in Central library, designed to prove of interest not only to library workers but as well to all interested in educational work. The occasion is the 11th annual convention of the Pacific Northwest Library association.

At the first session, commencing at 9:30 o'clock Thursday morning, September 2, Dr. Jonah B. Wise, trustee of the library association of Portland, will deliver an address of welcome to the visitors. John Ridington, librarian of the University of British Columbia, will respond.

Movies to Be Discussed. The many ramifications of library work, as affecting the libraries and the moving picture, publicity, music, advertising, and general education, will be discussed by the visiting delegates.

During the first session Thursday morning Charles W. Smith, associate librarian of the University of Washington, will give the "President's Outlook." Reports of officers and the various committees will then be read. A series of five-minute talks will mark the afternoon session of September 2, wherein the speakers will discuss library problems from many points of view.

Book Review Symposium Stated. In the evening session a "book review symposium" in charge of Zulama Kostomarov, acting librarian of Portland, will be held. Dr. Richard F. Scholz, professor of history at the University of Washington, will speak on "The Forming of Public Opinion." Dr. Scholz is a Rhodes scholar and was an active member of the president's late commission preparing data at Paris. He has been attached to the teaching staffs at Harvard and California and is editor-in-chief of the Pacific Review.

"The Trend Toward County Libraries" will be discussed by Milton J. Ferguson of the California state library at Sacramento at the opening session Friday morning. Sarah V. Lewis of the Seattle library will talk on "Our Place in the Sun and Other Platitudes."

Gertrude Andrus of Frederick & Nelson's department store in Seattle, where she is manager of the book department, will speak on "Education and the Book." Addressed by Mrs. J. Marvin of the Oregon state library at Salem and John B. Kaiser, regional director for the Pacific northwest library, Tacoma, will also speak.

Luncheon Held on Friday. Friday noon the program includes a luncheon at the University club. Friday afternoon a survey of the Portland library system will be made. Addressed by Mrs. J. Marvin of La Grande, Clara Van Sant of Medford, Ellen F. Howe of Seattle and others will be made during the evening session.

On Saturday unfinished business of the convention, new members growing out of the meeting, report of various committees and a concluding address will close the convention.

During the afternoon the delegates and visitors will be taken on a complimentary trip of the Columbia highway.

JAIL PROTECTION ASKED Father and Son Put Under \$500 Bond to Keep Peace.

PENDLETON, Or., Aug. 28.—James B. Beebe and son, Earl Beebe, of Hermiston were placed under \$500 bonds to keep the peace in Justice Parks' court here Friday. Clyde Herbert, a patient from the county hospital, charged that an altercation arose over the ownership of a desert land claim. Several years ago Beebe and son filed on the desert claim, but left it. Later Herbert filed on the land. He lived on the property and proved it up, securing a patent from the government Wednesday. Hebert had been warned by the Beebes, it is said, that they would demand the property as soon as he secured patent. Wednesday he got the patent and straight away went to the city jail at Hermiston, where he was locked up. He was accommodated, and Thursday morning came to Pendleton, where he asked the sheriff to come to him. He told officials that the Beebes had threatened to kill him.

Hebert told how he left one morning on a train for Portland and was overtaken by the Beebes on a faster train at The Dalles.

Hebert says he was then taken to a Portland hotel, where the Beebes forced him to deed over the patent and send it to the land office at La Grande.

Hebert wrote a second letter to La Grande telling of the alleged conspiracy and came to Pendleton. So did Beebe and his son.

Despite the bond to keep the peace, Hebert is afraid of the Beebes and begs to be locked up in jail.

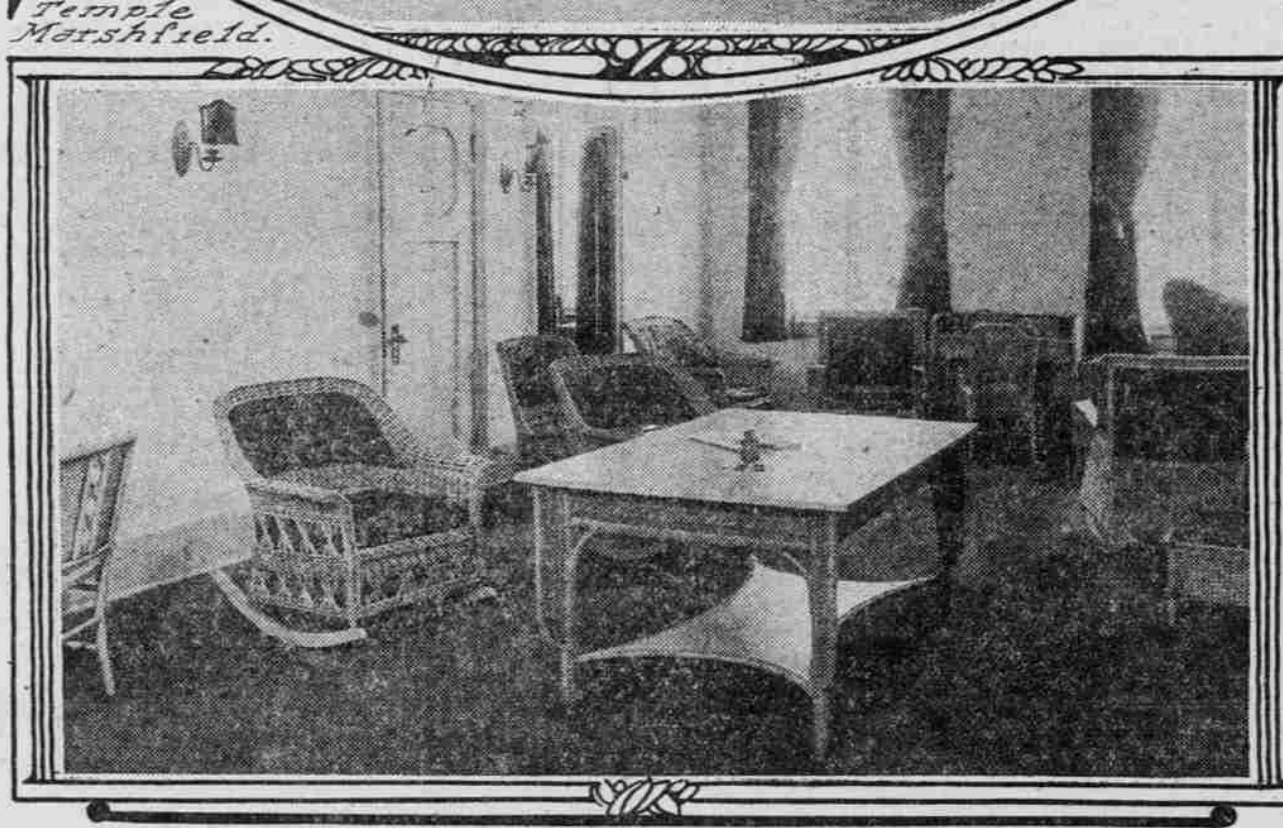
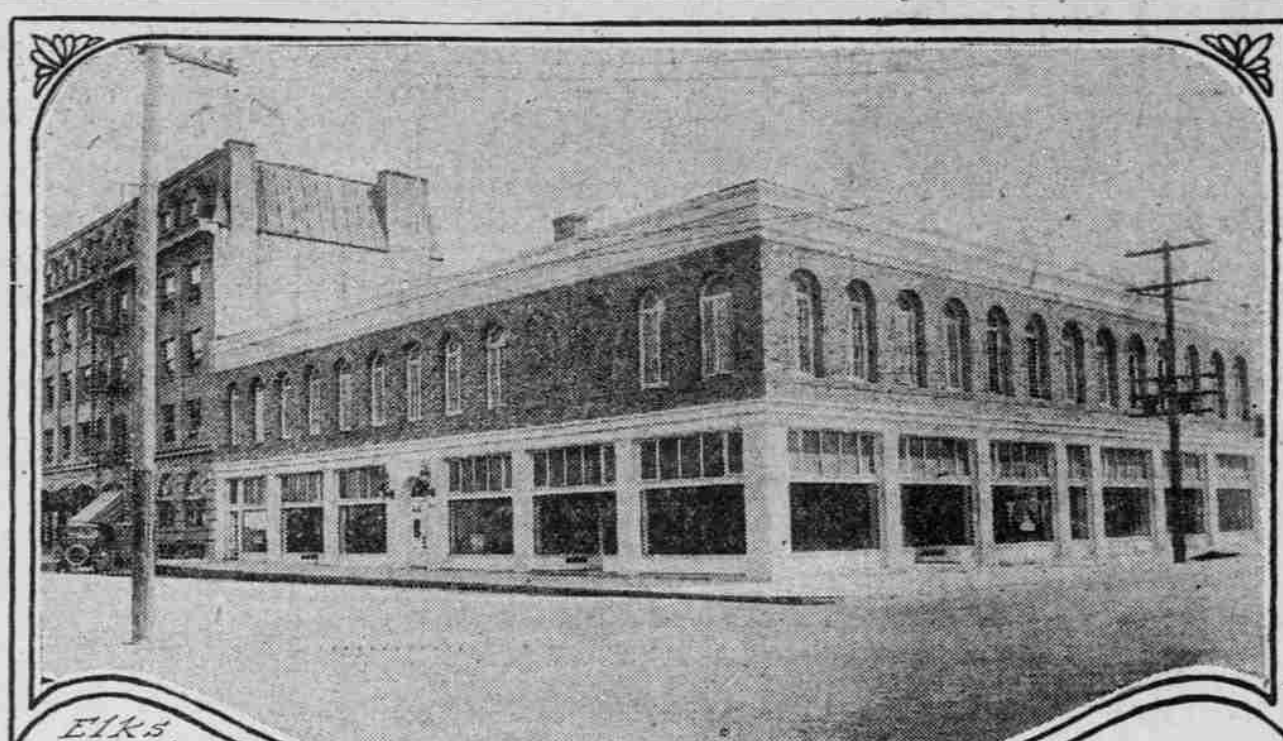
PREFERENCE IS DENIED Tacoma Abolishes Rule Favoring ex-Service Men.

TACOMA, Wash., Aug. 28.—(Special.)—The city civil service board cannot give preferential treatment to ex-service men. City Attorney Dennis ruled and accordingly the council today approved the action of the civil service board in abolishing the rule.

Mr. Dennis said that the regulation could not be enforced in court if brought to a test and he declared that the first time an employee who had not been in the service was laid off or supplanted by an ex-service man the test would be made.

MARSHFIELD ELKS TO DEDICATE NEW HOME WITH TWO DAYS OF FUN SEPTEMBER 5-6

Mayor Baker of Portland Will Speak at Ceremonies—Venison Luncheon Will Be Given Following Day. Temple Cost \$70,000 and Is One of Best on Coast.



MARSHFIELD, Or., Aug. 28.—(Special.)—Marshfield Elks have planned a big time when they dedicate their new temple September 5 and 6. They have invited lodges from all sections of the state. The formal portion of the two days' events opens with the ceremonial dedication Sunday afternoon at 3, with an address by Mayor Baker of Portland. He will be followed by Past Exalted Ruler George Goodrum of Los Angeles whose topic will be "History of Marshfield R. F. O. No. 1150." The same evening arrangements have been made for a homecoming smoker. There will be no further items until Monday afternoon at 1, when a venison luncheon will be served followed at 3 with a tea, dancing and a general reception. At 8 Monday night the grand dedication hop takes place. The Marshfield Elks organized in 1909, and in 11 years the lodge has grown steadily until now the membership is 564. The lodge draws from a considerable surrounding territory and has members in all the cities in this county and in Curry and western Douglas counties. The lodge occupied the Masonic temple until their new building was opened in July.

WIFE OF SENATOR BORAH IS INTERESTING WOMAN

Portland Visitor and Native of Oregon Relates Stories of Husband's Career—Acquaintance With Presidential Candidates Discussed.

VERY neatly dressed and prepossessing young woman caused considerable interest at the headquarters of the Harding-Coolidge campaign club yesterday when she inquired if it were the place where voters signed who were to cast their ballot for the presidential election. She was invited to a desk and, seating herself, wrote on a membership application blank "Mrs. William E. Borah, Boise, Idaho." She is the wife of Senator Borah and has been visiting her sister, Mrs. Max Luedemann of 412 East Fortning street. She departed on the evening train for Washington, D. C.

Mrs. Borah is a native daughter of Oregon. She was born in Yamhill county and her father, W. J. McConnell, represented that senatorial district in the legislature of 1882, serving as president of the senate. He moved with his family to Moscow, Idaho, established a large mercantile business there and was elected one of the two United States senators when Idaho was first admitted to statehood. He was afterward governor of Idaho and is still living at Moscow. Mrs. McConnell was with Mrs. Borah in Portland and accompanied her as far east as Spokane. Mrs. Borah, who has been prominent in Washington social circles during her husband's more than 12 years in the senate, talked interestingly to club members of both candidates for president and their families with whom she is well acquainted. While Governor Cox was in congress, he lived in the same apartment house as the Borahs and has often visited there since. Mrs. Cox is an exceedingly interesting and intelligent young woman, Mrs. Borah said, and every one who knows her is an admirer and friend.

Governor Cox, shortly before the San Francisco convention, was in Washington and called Mrs. Borah to the telephone and, among other things, told her he was going to receive the democratic nomination for president. "Well," retorted Mrs. Borah, who is known for her quick wit, "if you do that astounding thing I will certainly vote for you."

"After the San Francisco convention had adjourned," Mrs. Borah continued, "the governor telegraphed me and reminded me of my promise. Now what am I going to do? I simply cannot and should not vote for a democrat. I might have done so at some other time in the past under the same circumstances, but in this great American year, never."

Mrs. Borah is an admirer of Senator Harding and said he inspired confidence and respect in every one he meets and she is confident of his election, as according to her, is Senator Borah. She also said that there is a great need of a republican senate and that the leaders of that body are looking to Oregon to elect Robert Stanford, who may have the de-

"One day he returned home saying: 'One senator told me today that I was the best dressed man in the senate.' I replied: 'I don't have to ask who said that. I know already. It was Senator Gore.'"

But Mrs. Borah told a new story on her husband. She said: "One day he was going from New York to Washington. Two up-to-date women sat in front of him. They were discussing the peace league and Senator Borah's stand on that subject. One remarked to the other, 'You will certainly have to hand it to that clever savage from the west.' They were trying to get a New York Sun at each station, but were unable to obtain one. As Senator Borah left the train he wrote on his sun: 'Compliments of the clever savage from the west.' He received a telegram that evening saying, 'Thanks to the clever savage from the west,' with their initials signed to it."

LAW CATALOGUES ISSUED

WORK OF LOCAL INSTITUTION FOR YEARS IS COVERED. Classes Meet in Evening in Order to Afford an Opportunity to Those Occupied During Day.

Catalogues covering the work for the year 1920-21 have just been issued by the Northwestern College of Law. This school is the successor of the Portland law department of the University of Oregon, and has been in continuous operation since 1884.

The school at present has no connection with the University of Oregon, which conducts a day law school in Eugene. The school in Portland meets for evening classes only, thus affording an opportunity to those occupied during the day.

B.; Robert R. Rankin, A. B. LL. B., formerly United States district attorney; George B. Guthrie, A. B. LL. B., Clarence J. Young, A. B. LL. B., legal department of the Southern Pacific railroad; Robert L. Sabin Jr., A. B. LL. B., and Chester G. Murphy, A. B. LL. B.

J. Hunt Hendrickson, who has been connected with the school since it separated from the University of Oregon, is dean of the faculty and James W. Gantenbein, son of the late Judge C. U. Gantenbein, who was for many years of the school, is secretary of the faculty.

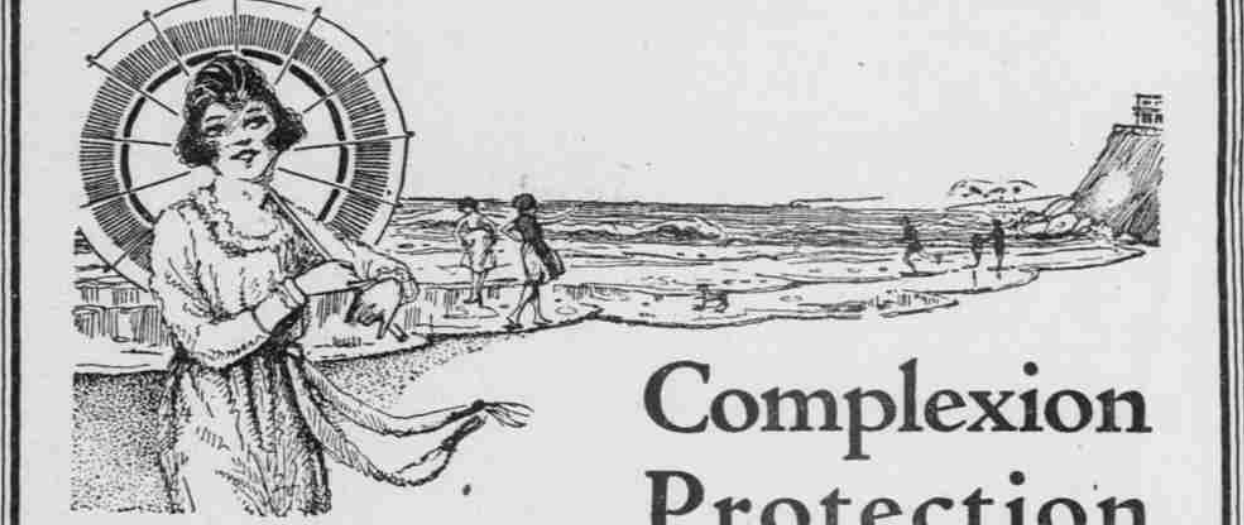
