

IRISH AD HERE AIM OF MISS M'SWINEY

Sister of Late Lord Mayor of
Cork Arrives.

RECEPTION IS SIMPLE

Reports of Engagement of Widow
Are Branded as Propaganda.
Initiated by England.

A little woman, dressed in the black of deepest mourning, came to Portland last night in the person of Miss Mary MacSwiney, sister of the late lord mayor of Cork, Ireland, who died of a hunger strike in Brixton prison. Miss MacSwiney came to urge the citizens of Oregon to support the recognition of the Irish republic by the United States.

There was no pomp or ceremony connected with her arrival. In quiet, rather tired voice, she greeted some of the supporters of Ireland at the station and at her hotel. That was all.

Only Ireland Discussed.
Not once in an interview granted last night, did Miss MacSwiney mention Terence MacSwiney by name. She did not allude to him as a patriot, or a victim of England. Her talk was confined to the Ireland of today, its citizens, the condition of the country, and the actions of England in regard to its ambitions.

"We are not asking the United States to aid Ireland with arms and men," she declared. "We simply want recognition."

Reports that Mrs. Muriel MacSwiney, the widow of the hunger striker, was to marry again were branded as "pure fabrications" by Miss MacSwiney.

Propaganda Use Charged.

"These stories are absolutely false and are but a part of the underhanded propaganda carried on by England," Miss MacSwiney declared. Art O'Brien, mentioned as being the man my sister-in-law was to marry, is old enough to be her father. He is an old friend of the family, and a splendid man, but the lies were published simply to create adverse sentiment against Mrs. MacSwiney."

Ireland is in dire need of material aid from America, Miss MacSwiney said, but she is not appealing for that aid.

"My sole purpose here is to obtain recognition," she said. "Within one month from the time that the United States recognizes the republic of Ireland, the other great nations must follow. But the other nations must not lead. The United States is the only country not under the power, financially and otherwise, of England."

Valley Forge Is Recalled.

"When America wanted help at Valley Forge, the first food ship that arrived in Philadelphia was from Ireland. We are now asking you to help us with our Valley Forge. You might be afraid that England would go to war with the United States if you recognized Ireland. England could not. She has no money. She would have to borrow money to carry on the war from America and, although you are friendly with England, I doubt if you would be friendly enough to lend her money for that purpose."

"England is complaining that she cannot pay you the interest on the debt she owes you. It is an interesting fact that England is paying that exact amount to the United States to commit atrocities on women and children in Ireland. Lloyd George and the British judge acknowledge that a state of war exists in Ireland, yet they do not abide by the lawful rules of warfare."

Brother's Arrest Cited.

"Three weeks ago I received word that ten men, including my brother, John MacSwiney, had been arrested charged with having revolvers in their possession. They had no revolvers, yet six of these men were shot dead. And the soldiers came out while the relatives were praying and mourning outside the gates and jeered and mocked at them."

The economic value to America in recognizing Irish independence was emphasized by Miss MacSwiney. Ireland at present, she said, is not allowed to trade directly with the United States. A lucrative market would be opened to America with the independence of the island firmly established, she declared.

"I want to convey to the people of Portland and of Oregon," she said in conclusion, "the fact that it is time for the citizens of America to be true to the ideals of Washington, who said, 'I am a Patriot in Ireland, in hope, your cause is identical with mine; true to the principles of Abraham Lincoln, who fought for government of the people, by the people, and for the people; true to the policy of Jefferson and the congress of 1793 which laid it down as the settled policy of the United States; true to the nation without military intervention is not an unfriendly act; and true to the policy for which they recently fought, of freedom for all nations, rigorously struggling to be free.'"

order for several hundred cigarettes—they don't sell less than a hundred. They ask us to send them in plain wrappers. That's so neither the postmaster nor anyone else can guess that it is in the package. Women all over the country in small towns and big are smoking more every year.

The manufacturer pointed to a map of the United States hanging on the wall of his office. It was dotted over with pins, indicating the location of women mail-order customers ordering cigarettes from this small, one-story, one-roomed building. From Maine to Florida, from California to the state of Washington, the pins found their way through the most remote districts, through little towns and big. It was a most surprising geographical revelation of the truth of the figures based upon the report of the bureau of internal revenue.

I interviewed storekeepers of several cigar stores in various parts of this city. They declared that New York women were not among the secret smokers, but had come out into the open about the country.

"They came into the store and buy their own," said a storekeeper. "They used to send their husbands or their brothers or someone else's brother, but now I should say that half of my customers are women."

"My women customers buy the same brands of cigarettes as men," said another storekeeper. "They don't like dainty, little feminine cigarettes. They want a man-sized smoke." Recently Joseph French Johnson, dean of the school of commerce at New York university, created a sensation by declaring that if women would smoke, they should take to pipes as less harmful than cigarettes.

pettes. Manufacturers declare, however, that at present the women's trade shows no disposition to follow the dean's advice. A woman smoking a small black pipe in a fashionable New York restaurant the other night attracted a good deal of attention and comment. I have seen a few women smoking small cigars in New York, but at the present the majority seem to prefer the taste of cigarettes. Influence of European habits—women have long smoked in Europe—the greater freedom of women and changing fashions are given as some of the reasons for the increase of feminine smokers.

LEVER ACT CASES FAIL

All Profiteering and Hoarding
Prosecutions Dismissed.

WASHINGTON, D. C., March 12.—All United States district attorneys have been instructed by Attorney-General Daugherty to dismiss profiteering and hoarding prosecutions pending in their districts under section four of the Lever act which recently was held unconstitutional by the supreme court.

The attorney-general's order affects about 500 indictments.

be ready for the committee to accept at its next meeting. Mr. Williams went east for the purpose of attending the meeting of the committee held March 2. The committee has a deficit of \$1,000,000, which must be raised. The method of collecting this is by a quota for every state. Oregon will be expected to raise \$14,000. The quota is based on 10 cents for every republican vote cast. When the effort will be made to secure this sum in Oregon Mr. Williams does not know.

Oregon's national committeeman has been appointed on the special committee to investigate southern representation. The committee includes six other members. Mr. Williams will leave Portland April 15 to join the other members in Texas and they will visit every southern state to study conditions and report. The purpose of the survey is to aid the republican party in the south.

"The situation respecting federal patronage is the same as it has been," continued Mr. Williams, touching on a matter very close to the heart of several hundred Oregon people. "Senator McNary and Stanfield have held one brief conference. I talked twice with Senator Stanfield and the question of patronage was not mentioned. The representatives, however, will be allowed to name the postmasters in their congressional districts and the senators, as per senatorial usage, will name the rest of the federal appointees. I made no suggestions as to patronage and will not do so unless requested. I do not know that I will be asked for advice in the matter."

Stanfield Last to Arrive.

"Senator Stanfield was the last of the new senators to arrive. Others had been there from a month to two weeks before the inauguration, selecting their desks and offices. Senator Stanfield appeared on the scene the afternoon before the inauguration, being sworn in. Senator McNary had reserved an office next to his own for his colleague. Senator McNary has arranged to have Senator Stanfield take his place on a number of important committees."

Discussing conditions, Mr. Williams reports that the hotels and retail stores show a healthy increase, but that there is very little travel on the railroads. Financial conditions in New England and New York are good. Concerning the newly appointed cabinet, Mr. Williams said that the cabinet is accepted as the strongest that could be selected from the list of candidates. "And," said the committeeman, "the candidate whom the people think is the poorest selection will develop into the strongest. I refer to Attorney-General Daugherty. I know him and know that he will make good. Hughes, Hoover, Hays and Daugherty were particularly good selections. There is no question that President Harding was wise in his appointment of Hoover, although Hoover was not popular with a number of President Harding's supporters."

Many Democrats to Stay.

In a general way it can be said that democrats now in office will not be disturbed until their terms expire. The men who have been in office eight years or four years and whose terms will expire within a year or so will not be ousted to make room for republicans unless there is a special reason for so doing. This is the attitude taken by the powers that be at Washington.

"With the inauguration of President Harding," continued Mr. Williams, "the White House was opened for the first time in three years. The place had been locked up and no one could get in. Now the gates are wide open and all nations of immigration thousands of people swarmed over the grounds and even upon the porch. It was like shackles being broken and there was a feeling of relief."

Reverting to the shipping board and Senator Chamberlain, Mr. Williams declared that Oregon could not have put across any other man than Chamberlain. The assurance that the Oregonian will be on the board was given to Mr. Williams in a private interview which he had with Washington Harding the day he left Washington for Portland.

Senators Hold Elevator.

"I had a funny experience in Washington," said Mr. Williams in conclusion. "We were in an elevator, a number of the national committee and two governors, and we wanted to get to the fourth floor. When we arrived at the third floor the well ran and the elevator stopped. A dignified chap entered and the elevator went to the ground floor. We went to the bottom. This went on for about an hour. We were waiting for the elevator. I thanked the negro operator for the ride he was giving us, but said that if he would only stop for a minute we'd get out and walk instead of sliding up and down the shaft. The negro explained that we were in a senate car and that it was a senate rule that when a member of that body wanted to use the elevator the operator had to take him to the floor he desired, no matter who or how many were in the elevator at the time. We never did get to the fourth floor on that elevator, although we were within a few feet of it repeatedly. I spoke to Senator McNary about it and he told there was such a rule but that only the southern and eastern senators ever insisted on inconveniencing other passengers."

IRISH CLUB ELECTS; RESULT UP TO COURT

Delegates to National Convention Subject to Finding.

INJUNCTION IS MODIFIED

Circuit Court Tomorrow to Hear
Arguments of Rival Factions
of Friends of Freedom.

Modification of the injunction against a meeting for the election of delegates to the national convention of the American Association for the Recognition of the Irish Republic resulted in the holding of such a session yesterday at the Hotel Portland, though credentials will not be issued to delegates named until the circuit court decides Monday which of two rival organizations of friends of Irish freedom is officially recognized by the national body.

Despite the desire of the American Association for the Recognition of the Irish Republic, Inc., incorporated under the laws of Oregon, to prevent the use of that name by Dr. Andrew C. Smith and his followers through injunction, about 50 Irish republic sympathizers met yesterday and organized an association to be known as the American Association for the Recognition of the Irish Republic and elected Dr. Smith president.

Delegates Also Elected.
Delegates to the Chicago convention of the national body were elected as well, though the incorporated body avers that the other society has no right to do so.

The restraining order, granted by Circuit Judge Stapleton Friday afternoon to prevent the meeting yesterday and signed at the petition of the incorporated association, was modified yesterday morning when Frank Lonergan, attorney, argued that the arrival of out-of-town delegates in Portland made it extremely inconvenient and expensive should the convention scheduled be prevented. Judge Stapleton agreed that the meeting might be held and officers and delegates elected, provided that the action was subject to later decision by the court.

Hearing Set for Monday.

Monday at 2 o'clock was the time set for a hearing on the injunction, a demurrer alleging that the complaint was based on insufficient facts and misrepresentations having been filed by Attorney Lonergan.

Adherents of the organization headed by Dr. Smith contend that the association led by J. H. Fitzgerald, Dennis Galvin and Mrs. Lucy Moran is an outlaw society and that the basis of disagreement is that such organization has been operating with business methods which are not sound. Following the convention sessions yesterday afternoon, an executive committee meeting was held, which lasted until late last night. Further business of the convention will be transacted at a brief session to be held at the hotel this afternoon.

Outside Delegates Attend.

Delegates were present from Baker, Pendleton, Hermiston, Pilot Rock, The Dalles, Heppner, Klamath Falls and five counsels in Portland. The convention adopted a constitution and by-laws with the objects and aims of the national organization and elected the following officers to serve for the ensuing year: Dr. Andrew C. Smith, president; Rev. F. J. O'Rourke, J. H. Dalles, vice-president; Mrs. Emma May Nelson, Portland, treasurer; Miss Anne Kearns, secretary. The following is the new executive committee: Frank McNally, Pendleton; John J. Kelly, Heppner; Rev. Gabriel Harrington, O. M. Cap. Bend; E. Grant, Baker; Dennis D. O'Connor, Klamath Falls; Miss Katherine Roe, Portland. Delegates to the national convention are Dr. Smith and P. E. Sullivan, and the alternates are Mrs. Cleve Preston and Thomas Kerby.

OIL FIRM INCORPORATES

Columbia Petroleum Company Has
\$1,000,000 Capital Stock.

SALEM, Or., March 12.—(Special.)—The Columbia Petroleum company, with a capital stock of \$1,000,000, has been incorporated by Effie L. Seed, C. A. Hill and E. Jensen. Headquarters will be in Portland.

Kimball, Cummings & Withrow has been incorporated by J. F. Kimball, K. G. Cummings and R. E. Withrow. The capital stock is \$10,000, and headquarters will be in Klamath Falls.

Elise O. Porter, Charles R. Dimm and Conrad and Erick Olsen have incorporated the Porter Universal Advertising System company. The capital stock is \$20,000 and headquarters will be in Portland.

The Milton Creek Logging company has decreased its capital stock from \$250,000 to \$170,000.

H. E. Withrow & Co. has increased its capital stock from \$10,000 to \$25,000.

seemingly it is probable that until this lease expires, Mr. Pantages will be unable to use the theater for the Portland headquarters of the Pantages circuit.

Mr. Johnson said that Mr. Pantages is now operating two houses in some towns, and it is possible that he may later operate the Hippotrome theater jointly with the present Pantages theater here.

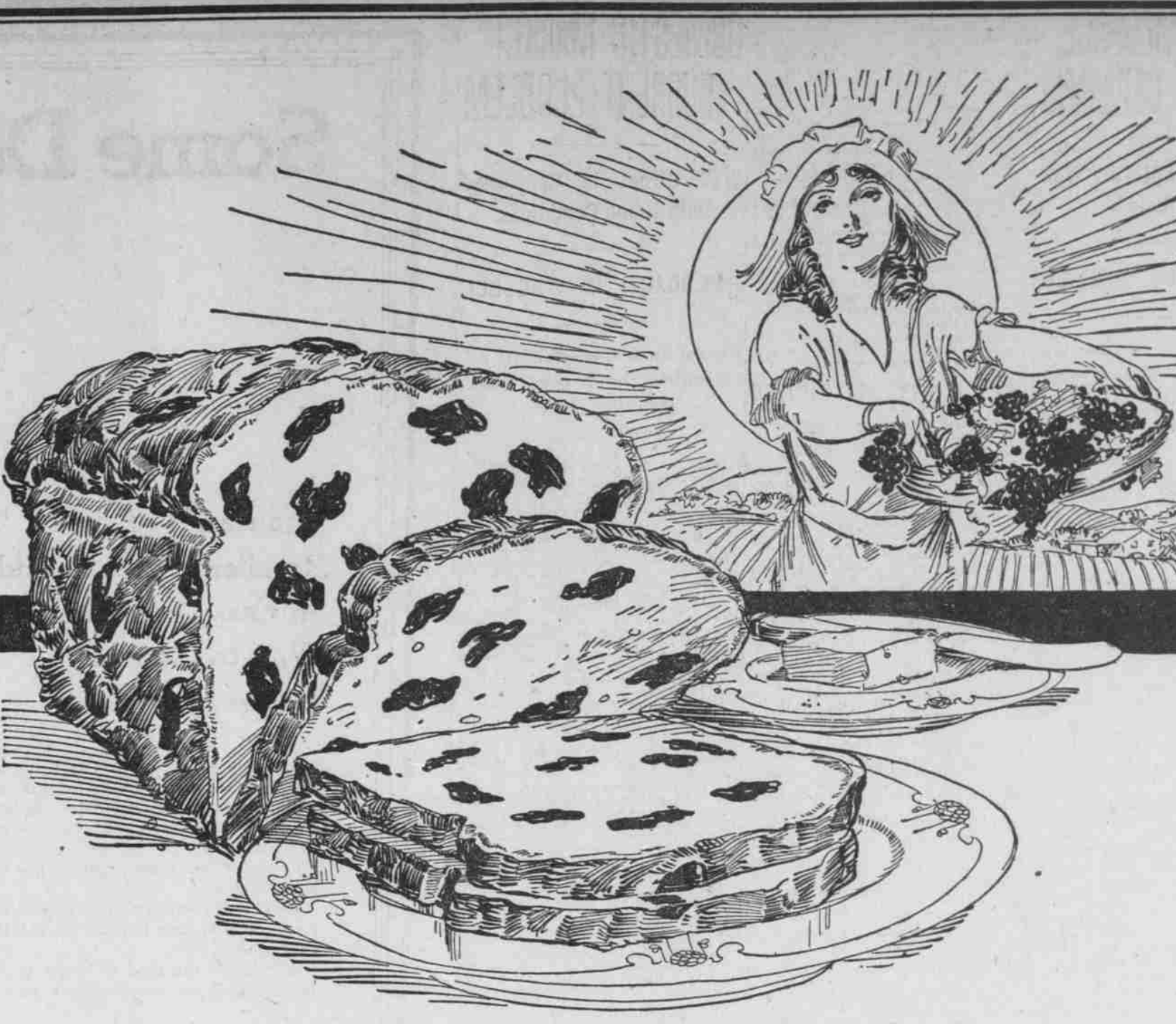
The Hippotrome theater is one of the largest auditoriums in the city and seats 2000 persons. The building occupies a half block at Broadway and Franklin street with the exception of 50 by 50 feet at the corner of Yamhill and Park streets.

The theater originally was built by Montre and Sullivan at a cost of approximately the same as the purchase price in yesterday's deal. It formerly was known as the Empress theater. The name later being changed to Hippotrome theater.

Mr. Johnson said that the growth of the Pantages circuit had been so great that the theater is now possible to book acts for a year, since it took them that time to complete the circuit. The circuit now begins at Montreal and goes by way of Seattle and Portland to San Francisco, afterwards doubles back through Salt Lake City and Denver to New Orleans.

New theaters have recently been built by Mr. Pantages at Memphis and Birmingham in the course of his invasion of the south. Mr. Johnson said.

THROAT BADLY SLASHED

WOUNDED MAN PICKED UP ON
MARQUAM ROAD.

Identity Not Fully Established, but
I. V. Cappelen Believed Name;
Suicide Theory Advanced.

A man, believed to be I. V. Cappelen, his throat cut from ear to ear, was found lying on Marquam road about 9 o'clock last night by Ira Manville and C. Ferguson, medical students of the University of Oregon, living at 574 Sixth street. At St. Vincent's hospital it was said he might live.

According to the story given the police, the two students went outside to investigate the source of a pebble barrage which was being laid against the front windows. They expected to find small boys, but instead the wounded man motioned them to come. They gave first aid and called the emergency hospital.

Cappelen's wound was nearly severed, but he answered questions with nods of the head. He denied that he had attempted suicide, and endeavored to convince the police that he had been attacked, they said. Police lean to the suicide theory because of the fact that only 10 cents and a check for a suitcase were found in his pockets.

His identity was not positively established last night. The name of I. V. Cappelen was found on a coat hanger in the suitcase. Detectives obtained the suitcase at the union depot, where it had previously been checked. Whether he had just arrived in the city and had checked the suitcase while he found a room, or whether he had checked it preparatory to departure, was not ascertained.

He was apparently 34 years old, was dressed in a white collar and was smooth-shaven.

EMIGRANTS WANT U. S. AID

Gathering in Warsaw Decides to
Appeal to American Government.

WARSAW, March 12.—(By the Associated Press.)—Prospective emigrants assembled here have decided to appeal to the American government for assistance in obtaining passport visas.

It was estimated that from 2000 to 3000 emigrants are here seeking to depart for the United States.

BOND ISSUES UNDER FIRE

EX-GOVERNOR WEST ATTACKS
STATE APPROVAL SYSTEM.

Irrigation Securities Commission
Asked to Give Public Hearings
on Future Financing.

SALEM, Or., March 12.—(Special.)—Oswald West has written a letter to the irrigation securities commission in which he directs the attention of the body to alleged defects in the system of approving irrigation bonds. He suggests that the commission, before proceeding with the various district issues now pending and aggregating more than \$10,000,000, fix dates for public hearings with regard to the projects to be financed.

Under the present laws the state certifies to irrigation district bond issues and in some cases guarantees the interest thereon for a period of three to five years.

It was pointed out by ex-Governor West that Teel Irrigation bonds in the amount of \$800,000 have been completed and guaranteed. These bonds, he said, were in the hands of

the public and are selling below par. As a result work on the project has stopped.

"If work is not renewed and the project completed," said Mr. West's letter, "the holders of these bonds have a moral right to go before the legislature and ask relief."

Attention also was made by Mr. West that the Grand Pass Irrigation district has voted \$300,000 of bonds to cover construction work there. For completion of the project, Mr. West said additional funds would be needed.

PORTLAND BANK SUES
Judgment of \$50,000 Is Asked in
Tacoma Failure.

TACOMA, Wash., March 12.—(Special.)—Judgment for \$50,000 against Ole S. Larson, as president, and Gustaf Lindberg as director of the defunct Scandinavian-American bank of Tacoma was asked by the Northwestern National bank of Portland in a suit filed here today.

The amount was asked on a promissory note which was to run 90 days from November 10, 1920. Larson is now under indictment on 10 counts returned by a grand jury investigating the bank failure. He is charged with grand larceny and embezzlement. Lindberg is a wholesale
