THE REPUBLICANS
HOLD PRIMARIES

Have Large Crowds Notwithstanding Storm.

APPEARED TO WORK IN HARMONY

Will Hold Their County Nominating Convention Thursday Next—Free Silver and Gold Standard Vote Side by Side.

The republicans held their primaries throughout the county yesterday and those in this city were marked by an unusually large attendance. Every republican and his republican friend were out and while there appeared to be some factional division as to the delegates considering all things, honors are about even.

The morning opened with quite a storm and all day long the rain incessantly fell. Workers who favored special candidates for nomination on the county ticket were out in gum boots and great coats and buttonholes considerably suffered. As this is considered a republican year the party is about evenly divided as regards prospective candidates before the nominating convention. All the wheel horses were out in force and those who were not pleased with the result of the last primaries, held several weeks ago to nominate delegates to the "county-state" convention, were noticeable for their subtle activity.

North Hillsboro precinct elected the following: B. P. Cornelius, J. D. Moryman, R. H. Greer, T. Tucker, E. F. McNelly and W. D. Wood. South Hillsboro: H. P. Ford, J. H. Stanley, J. Milne, E. J. Lyons, J. Carstens, E. C. Deichman, U. S. Hicks and J. Ashbar. This precinct nominated C. W. Redmond for constable and J. P. Hicks for the Justice of the Peace.

North Hillsboro nominated D. W. Smith for Justice and F. J. Williams for Constable.

Fruit Crops and the Effects of Recent Frost

LAST CIRCULAR FROM BUREAU

The Injury is Not so Very Great—Oregon Will Yet Have a Good Fruit Crop—A Law Long Ago Repealed.

Crop Report.

WESTERN OREGON.

Fruit—The correspondents continue to differ as to the effects of the frost and cool weather on the fruit crop. Snow on trees in full bloom is an unusual sight in any country, and especially so in Oregon. It is generally conceded that peaches and almonds have been injured by the frosts. Few correspondents go to the extreme of saying that the crop is ruined. In some few unfavored localities there may be orchards where the crops are ruined, but if so these are the very great exceptions. In Jackson county some damage necessarily resulted, yet some correspondents there report the trees fairly well filled with uninjured embryo peaches; the same pertains to Josephine and Douglas counties. In the counties of the Willamette valley, where all other fruit is better adapted than are peaches, the greatest damage was done, but even in these valley counties there is no general and wholesale loss. The frosts affected the cherries to a very limited extent, more so for the early varieties than for the late. The prune and plum crops appear to be free from any real injury. Fast experience has shown that more damage results to fruit from cold rain than from frosts, and should there be no more cold rains, such as prevailed the past week, the fruit crops will most likely be found to be practically uninjured. Strawberries are in bloom and in places the young fruit has formed; there appears to have been but little, if any, damage done to them by the frost. Currants and gooseberries are formed and no damage from any cause has been done to them. Grapes have swollen their buds and promise to be prolific. Fruit as a whole can be said to be uninjured; there are exceptions to all rules, and the few unfavored localities are the exceptions in this case.

EASTERN OREGON.

Fruit—South of the Blue mountains, except along the Snake and John Day rivers, the fruit buds have not advanced sufficiently to be injured by the weather. Trees are generally in full bloom along the Snake, Columbia and John Day rivers, and while some few fruit growers consider that damage has been done by the weather, yet the consensus of opinion is that little real damage has resulted. The cloudy nights and moist atmosphere has saved the fruit. The berries are in a most promising condition. The larger fruit and berry growers are most sanguine for a prosperous fruit year.

A jury was impaneled and after a legal skirmish the case went to the jury, it returning a verdict of guilty as charged.
