

DEATH HELD COURT IN CLERK'S OFFICE

W. W. Annans Succumbed to
a Stroke of Apoplexy.

TRAGIC SCENE AT COURT HOUSE.
Fruitless Efforts for Thirty Minutes to
Resuscitate the Stricken Veteran.

Last Saturday forenoon, at about 11:00 o'clock, the county clerk's office was the scene of an event which will long be remembered by the eye witnesses. On Thursday W. W. Annans had come to town from his little ranch beyond Laurel. Staying over night, on Friday he was drawn as a juror on the case of Jacob Novak vs. J. B. Prickett, et al, of the Dilley Labor Exchange. The jury was sent out late in the evening and remained out all night. On Saturday morning they came in and asked for instructions from Judge McBride after which they retired and soon brought in a verdict. The jury was discharged and Annans, who has been in the habit of using stimulants for years, told Dr. Wood, who was in the circuit court room, that he felt very ill and wanted relief. From these rooms he went downstairs to the Clerk's office to claim his time. While waiting, the attack came on and he reeled dizzily and fell to the floor. Joseph Kineman caught him as he fell, but it was too late. The stricken man expired and the combined efforts of Dr. Wood and bystanders could not again start the engine which had ceased to throb. Drs. F. J. Bailey and S. T. Linklater soon came in response to calls but examination evidenced no signs of life.

Annans was a man of iron nerve and constitution. He had always been more or less addicted to drink and for several years has been a user of morphia in order to alleviate pain caused by rheumatism and poor circulation. Years ago he was widely known as one of the noted frontiersmen of Montana. Annans was generous to a fault, a sturdy and reliable friend, kind-hearted to all and well meaning. He had his faults, and they were many—and who is there who has not faults. But he had enough on the credit side of nature to proclaim him more than an average man.

His remains were buried Sunday under the auspices of the General Ransom Post, of this city of which he was a zealous member. Deceased left a wife and two children. His estate is limited. His pension of eight dollars a month will descend to the widow.

MOTION FOR NEW TRIAL OVER-RULED BY McBRIDE

Counsel for Defense set up that new
Evidence is in Existence.

DAY OF HANGING SET FOR FEBRUARY 4TH

Wachline had no word to say Before Sentence
was Formally Pronounced.

There are now but two chances which can save murderer Gus Wachline from paying the penalty imposed by society and law for his brutal murder of John T. Ledrick in April, 1894. One of these chances is that the supreme court may grant a stay of proceedings upon appeal—which might but prolong the life of the prisoner for a short time—and the other, intervention by that Hand which alike created criminal and victim.

On Saturday morning Messrs. Bagley & Brown argued for a new trial upon the grounds of newly acquired evidence, stating that C. C. Hancock and one or two other witnesses, name unknown, would swear that cart tracks had been seen, just after the time of the crime, leading from Ledrick's to Buck's, and that the latter having no cart, it pointed to Buck's criminality and his subsequent taking the cart away; also that a rifle, supposed to be Buck's, had recently been found buried upon the premises. Messrs. Huston and Cleaton, for the state, argued that neither of these allegations, if true, would or could have material bearing in the changing of a verdict and that no affidavits of witnesses had been produced to prove them; and intimated as such was the case, perhaps Wachline had told them where to find the gun, to which Counsel Brown replied that he had seen the gun unearthed but would not say where he had received his information. Judge McBride, after having heard the arguments, denied the motion, and turning to the prisoner, ordered him to stand up. Wachline did not move, apparently bewildered, altho' he showed no signs of agitation. Sheriff Bradford then said: "Stand up." The Court asked if the defendant had anything to say before sentence was pronounced. Waiting a moment and no response having been made by Wachline, who, after having cast one glance at the Judge and then riveted his eyes on the floor, the Court said, "in a distinct voice:

Court—You have been duly convicted of the crime of murder in the first degree by the verdict of a jury of your country; you have had every opportunity to present your defense; you have had the benefit of every witness for whose attendance you have requested and posed and you have had the benefit of able and enthusiastic counsel, who have left nothing undone to represent the facts in this case in as favorable a light to you as possible; that you have been convicted, is due solely to the overwhelming character of the evidence against you. The jury were right. There is no doubt of your guilt, and nothing that now can be said will avail you anything. But perhaps this scene and these surroundings may influence some other young man who may be hesitating in his choice between a life of industry and a life of crime. A few years ago you were before this court and convicted of a petty felony. On account of your youth and promises of reformation, this court, in its wisdom, gave you a chance to live an honest life, and you were given a short sentence. You had only been released from the penitentiary a few days when, forgetting your pledges of good conduct, you stole treacherously upon an innocent old man and murdered him for trivial gain. You had received your lesson; you were young and vigorous and the means of honest livelihood by honest industry were before you, but you deliberately chose crime. There you made a fearful mistake. Any man makes a mistake when he allows himself so far as to dally with temptation as to even dream that there is any other way of success in life outside of achieving it by honest toil. Not only in your case, but in every case it is true that the wages of sin is death. You must die. Do not delude yourself with any false hopes of trial or pardon, but in the brief time that is allotted to you upon this earth, I exhort you most earnestly to make such atonement for your crime as may be in your power, and prepare to meet that tribunal before whose bar judge, jury and prisoner must alike account for the lives they have lived. It only remains for me to pronounce upon you that sentence which your own deed has invoked.

It is the judgment of this court that you hence be conveyed to the county jail of this county and there kept a close prisoner until the time which will be here after fixed by warrant of this court for your execution, which will not be less than thirty nor more than sixty days from this date, at which time you will be taken to the jail yard of said county jail by the sheriff of this county and at said place and in the presence of twelve bona fide electors of this county, you will, by said sheriff be hanged by the neck until you are dead, and may God have mercy on your soul.

Before adjourning court, McBride drew up the death warrant, fixing the date of execution as February 4th, 1898. Counsel for Wachline asked the Judge to sign a "Certificate of Cause," which His Honor refused to do. The supreme court may grant a stay of proceedings, but it is highly improbable.

Albert Wachline, the father of

the condemned man, lives on a mountain ranch near the scene of the crime. Throughout the trial the father never came near, nor did he prior to the trial. On Monday of this week, however, he came into the city, accompanied by his son, younger than Gus. After a consultation with Messrs Bagley & Brown, the defendant's counsel, they went over to see the son and brother condemned to death. Sheriff Bradford went into the prison with them and but few words were exchanged. The father exhibited no signs of emotion, but the brother broke down and cried before leaving the jail.

The prisoner was seen by an Argus reporter Monday afternoon just prior to the family visit. He was asked several unimportant questions to which he readily responded in the affirmative or negative. He stated that he yet had hopes of his attorneys obtaining a stay of proceedings through the Supreme Court. He said that his general health was good and that he was well supplied with reading matter. When asked if he had anything to say to the public he stated that he would prefer not to say anything until he had consulted his attorneys.

The gun found under a log near Ledrick's place, has, from its appearance, been cached for several years. It is a muzzle loading rifle and is rusted considerably. The stock on one side is nearly rotted away. The weapon still has a load and the cap is still on the tube. The hammer is rusted so that it cannot be raised. Messrs. Bagley & Brown would not disclose the source of information leading to the recovery of the rifle. There is no question but what the gun has been exposed to the elements for years. If Ledrick's assailant had had this gun it would at that time have proven a powerful bludgeon with which to strike a man down.

SENTENCED BUT GETS STAY OF PROCEEDINGS

Jas. Lee Jr. Gets no new trial
but is Released on bail.

IS APPEALED TO SUPREME COURT.
Judge McBride Signs Certificate of
Probable Cause and Lee is Released on
\$1500 bail.

"Jimmie" Lee, the young lad from Patton's valley, who was convicted of rape was denied a new trial last Saturday. Attorney Huston made the argument several days ago and it was under advisement. The defendant was brought into court Saturday morning and sentenced to three years in the penitentiary.

Later on Mr. Huston perfected an appeal to the Supreme Court and asked the Court to sign a Certificate of Probable Cause, to which assent was made. Bonds were fixed at \$1500, which were given whereupon the young fellow goes at liberty until the Supreme Court decides upon a question of law. Had McBride not signed the certificate young Lee must have gone to the pen at once. Supreme Court proceedings had already begun and the Court, recognizing that the law point involved was an intricate one, acceded. The real point at bar is:

There are two statutes governing in these cases. In statutory rape the male must be over 16 and the female under 16. In forcible rape, age has no bearing. The indictment in the Lee case was so constructed that it covered both statutes. The court would not allow evidence to show that Lee was under sixteen, and defendant's counsel contends that a double-barrelled indictment is not in conformity to the statute, hence the appeal.

They would doubtless have killed the poor woman had it not been for the action of the intelligent family dog, who, hearing the noise, came rushing at the cattle, biting and barking furiously. The canine soon cleared them away and by that time help had arrived. Dr. F. A. Bailey was called to dress the injured woman's wounds and he says altho' severe, they will by no means prove fatal. It was a perilous position for the woman and that dog is in no danger of going hungry to his kennel.
