

EARLY PIONEER SUDDENLY DIES

Samuel Williams Suddenly Succumbs to Heart Failure.

WAS AN OREGON PIONEER OF 1841.

Was Prostrated in the Office of S. B. Huston.

Samuel Williams, one of the most widely known pioneers in Washington county, succumbed to heart failure yesterday while in the law office of S. B. Huston. Mr. Williams was executing some business with G. A. Wehrung and that gentleman was in the office when Mr. Williams arrived, no one else being present. Mr. Williams, who was attending to the business, being absent for a few minutes. Mr. Williams entered the office, greeted Wehrung in a very jovial manner, talked for a short while, suddenly threw up his arms, and never regained consciousness. Mr. Wehrung called Mr. Williams, who was coming across the street to the office and Dr. Linklater was hastily summoned, but medical skill was of no use.

Mr. Williams was an unusually active man and has been pushing harvesting and threshing with great activity. The excitement of this, coincident with the very warm weather, probably brought on the attack.

Mr. Williams was born in Missouri in 1833 and crossed the plains with his father, reaching Oregon in 1841. In 1856 he was married to Ann Eliza Jolly, who with five children, survives him. The children are: Warren W., Frank J., Eliza J. Sewell and Amanda M. Frazier.

Mr. Williams has for several years owned a large farm one mile east of town. Some years ago he purchased the Barnard property on Main street and for some time since the elderly couple lived in the city. He was a good citizen, kindhearted, industrious and a man whose word was as good as his bond. The entire community feels a great sympathy for the bereaved family so suddenly brought to sorrow.

The funeral will take place Friday, at 4:00 p. m., from the Congregational Church, after which the remains will be interred in the L. O. O. F. cemetery.

FATAL ACCIDENT FRIDAY LAST

Pioneer George Thing Fell From a Building.

DIED ABOUT TWO HOURS LATER.

Struck on his head and Crushed in Base of his Brain.

Pioneer George Thing, for many years a resident of Reedville, but more recently of Hillsboro, met death last Friday by falling from a scaffold on a house upon which he was doing carpenter work. He left this city early Friday morning and went to work upon the building, which is on Rock Creek, about two miles from this city. At 11:00 o'clock he sustained a fall of 12 or 15 feet and struck upon the back of his head, crushing the base of his brain. He was unconscious until death came, about two hours later.

Mr. Thing came to Oregon in the early days and moved from Columbia county to Reedville, in 1852. He leaves a widow and the following children: Eugene, Riordan, Wash, Mrs. Lena Stewart, South Tualatin, Horace, Astoria, Herbert, George, Ada, Paul and Amy.

The Exposition.

Roy Latham Writes.

Roy Latham, at one time an attaché of THE ARGUS office, writes to his parents from Manila, date of July 1st. Among other things of his trip, he says: "The sea was very rough but it was fun for us, excepting two days. When we were coming over we captured the Guam Islands. They did not fire a shot. We took 54 soldiers, 6 officers and the Governor. We set free all the prisoners on the island. The natives said the Spaniards were 'no good' but that the Americans were 'all right.' How is that? Tell the folks of the boys who are with us from Hillsboro that they are all right. We want to 'celebrate' July 4th awful bad but don't know whether we can or not. It is a very pretty place down here."

"When I left Portland I weighed 140; San Francisco, 148; think I weigh about 155 now, so you see soldering agrees with me."

"I have seen Dewey. He is a fine looking fellow. The natives are fighting about 20 miles from here, giving the Spanish thunder. I think the war will be over in a couple of months."

The Wheat Situation.

J. B. Montgomery, one of Portland's substantial capitalists, was in the city Tuesday evening, a guest at the Hotel Hillsboro. He is one of the best informed men on the coast relative to wheat statistics and he is of the opinion that the crop will not move for more than 50 cents per bushel. This, if borne out, will bring to the northwest six million dollars less than last year's crop, although the entire yield will exceed that of last year's by over four millions of bushels. Although always formerly a republican, Mr. Montgomery is now an ardent bimetalist and says that unless that legislation is gained, with normal crop conditions under the present money standard, wheat must go back to the old Cleveland prices of non-profit.

By direction of the city council, Recorder Bowman has brought up for repassage several Hillsboro ordinances passed several years ago, but which were not properly certified, thus making their validity questionable. The revision is now completed and the ordinances will soon be legalized. The city recorder's fees have been fixed as follows: Drawing city warrants and filing papers, 5 cents each; recording minutes of council meetings, per folio, 10 cents; copies of ordinances for posting to give public notice, per folio, 5 cents; administering oaths of city officers and issuing licenses, 25 cents each; preparing election notices, 50 cents. His fees as peace officer are the same as a justice of the peace.

The recent decision of the circuit court to the effect that the objections to about \$10,000 in claims against the insolvent estate of Anton Pfanner, the Forest Grove banker and broker who mysteriously disappeared over a year ago, has lifted a burden of anxiety on the part of claimants. The judge sustained the objectors' allegation that the claims in question had not been regularly verified, but made an order allowing the claimants 30 days in which to amend the verifications. The assignee must pay the claims as soon as corrected in full to the 20 per cent dividend already declared. The claim of W. Smith for \$13 was disallowed.

Surprises in the yield are becoming quite common to the farmers of this vicinity. One field where a yield of 20 bushels was expected, turned out 12 bushels, while oats near the city promising 35 or 40 bushels yielded but 19. As that portion of the county near Greenville, Gales Creek and in the east end seems to be yielding much better, farmers in this vicinity are at a loss to account for the shrinkage, unless they attribute to the aphids. Threshing reveals many half crops.

She was wheeling along a fence near the Connell place when a team in the field, and just opposite her, became frightened. One of the horses, in his maneuvers, pushed a rail through into the pathway, which struck Miss Patterson in the breast, causing a painful wound. R. B. Collins brought Miss Patterson into the city where she received medical attendance.

In years past Washington county has been rather slow about exhibiting its resources and productions, but the people at last seemed to have awakened to the importance of having proper representation.
